Figure 45: World LPG production by region, 1990-2013

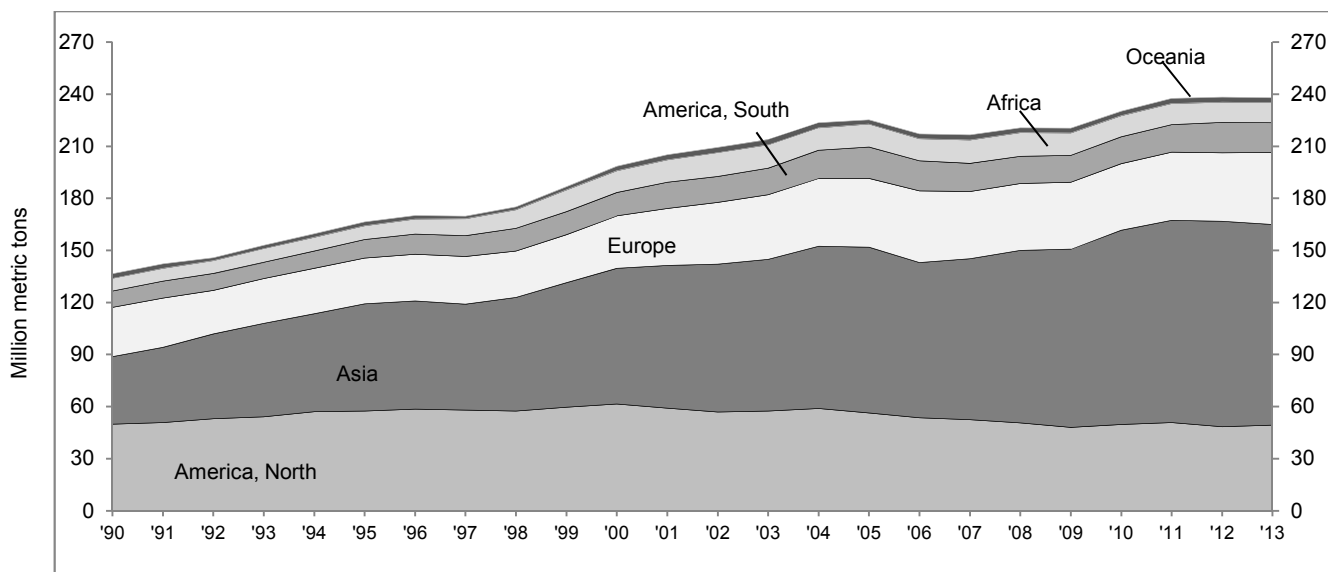


Figure 46: Major LPG producing countries, 2013

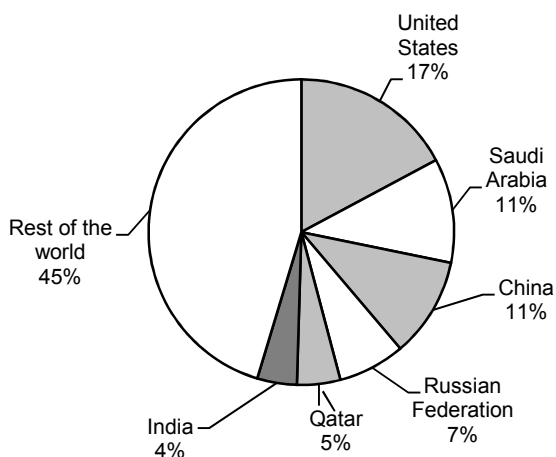


Figure 47: Major LPG consuming countries, 2013

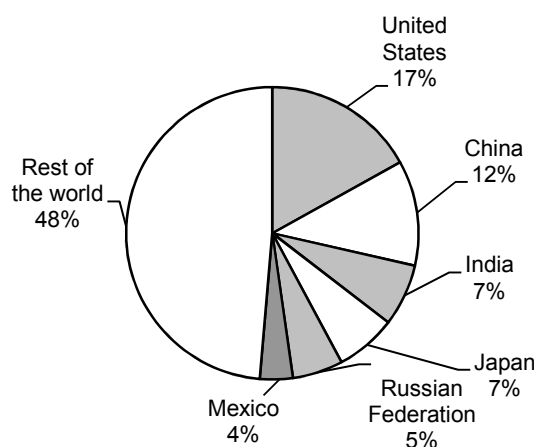
