22nd meeting of the High-level Group for Partnership, Coordination and Capacity-Building for the 2030 Agenda (HLG-PCCB)

Virtual meeting 26 May 2021, Open/ closed meeting

Opening

- 1. Ms. Awad (co-chair) welcomed members and issue partners to the meeting.
- 2. Mr. Schweinfest (secretariat) gave some opening remarks to thank members for their support during <u>52nd session of the UN Statistical Commission (UNSC)</u> held fully virtually for the first time.

Preparatory work for the UN World Data Forum (UNWDF) Bern 2021

- a. Logistics for Bern 2021 and process for the next host
 - 3. Mr. Rothen (Switzerland) presented the current preparations for the UN World Data Forum to be held in Bern, 3 6 October 2021. The Swiss Confederation are now confident to hold the Forum with travel restrictions starting to lift in many parts of the world. The hosts predicted this will be the most inclusive Forum ever since it will be organised in a hybrid format to allow both virtual and in-person participation. The final decision to go ahead on the current dates will be officially announced by the Government in early July.
 - 4. Ms. Perucci (secretariat) announced the HLG-PCCB a proposal to immediately restart the process for selecting the future host(s) of the Forum. Following some strong interest displayed during the 52nd UNSC to host the Forum, the secretariat felt confident in restarting this process to ensure the HLG-PCCB can decide in September. This was important to maintain the momentum in planning future forums and the needs of the current host to know in advance (due to possible travel restrictions) who is selected as the future host(s) to organize the closing ceremony and invite the relevant country representatives. The process would restart with a direct call for detailed bids and proposed choosing the next two hosts (fourth and fifth hosts). The selection of the fourth (January to March 2023) and fifth host (October to December 2024) in one process allows the secretariat to plot a path to returning to the Forum to its intended even-year biennial cycle. The HLG-PCCB agreed to the proposal.

b. Provisional programme review

- 5. Mr. Rutherford (on behalf of the chair of the programme committee) reported on the Programme Committee selection of the legacy session proposals (resubmitted) and their development of the high-level plenary sessions. Out of the 75 session proposals, 57 were selected to fill 63 slots in the provisional programme. A mini-call will be launched shortly to fill the remaining slots and provide other inputs showing innovative and interesting examples of how the data community has adapted itself during Covid-19. Seven high-level plenaries are now planned to cover the six thematic areas plus a special topic on data accountability. All the details of the selected sessions and the high-level plenaries are contained in an excel file shared before the meeting.
- 6. Members thanked the programme committee for their hard and dedicated work. Attending members of the programme committee were focused on bringing further innovative content into the Forum and harmonising the messages across different segments of the programme (i.e. gender). Members only note of concern was on the regional representation and expressed a wish to see more contributions from the Asia and Pacific, and Latin America and Caribbean regions.

Action: Members are requested to provide any further comments on the provisional UNWDF programme including specific comments on the sessions selected by Thursday, 3 June.

c. Outcome document

7. Ms. Dhuli (on behalf of the subgroup) reported on developments with the outcome document following the last meeting of the subgroup on the 22nd April. New inputs for the document were reviewed such as the recent World Bank World Development Report and a data initiative under the G20. A new timetable was proposed to map out key dates until the document's launch, including a public consultation over the late summer. Current members of this subgroup are Albania, Angola, Mexico, Palestine, the Philippines, Switzerland, the UK and PARIS21.

Review of the implementation of the Cape Town Global Action Plan for Sustainable Development Data (CTGAP)

8. The secretariat together with PARIS21 and the World Bank are looking to collaborate with members on a new approach to the implementation and financing of the CTGAP linked to the Bern network's clearing house and the World Bank Global Data Facility, both to be launched in anticipation of the UN World Data Forum. This proposed developing a new collection tool to understand disruptions and new approaches resulting from the

- Covid-19 pandemic; identify new and existing priorities to revise/shape the CTGAP by 2023/4; and to assess the needs for technical and financial support.
- 9. The secretariat proposes to convene a subgroup meeting in June to advise on this proposal. Current members of this subgroup are Hungary, Mexico, South Africa, the United Kingdom and PARIS21. World Bank will be added, and other members are welcome to express an interest to join.

Action: Members are requested to indicate their interest to join the subgroup on the implementation and financing of the Cape Town Global Action Plan for Sustainable Development Data (CTGAP) by Thursday, 3 June.

Update on the data stewardship working group

10. Mr. Poledo gave an update on the working group which held a kick-off meeting on 29th April. At the meeting, Poland and Colombia volunteered to co-chair the group and the following five work streams were identified: governance and legal frameworks; equity and inclusion; sharing and collaboration; data stewardship and the city data agenda; and overall conceptual framework on data stewardship. The next steps are to define the coverage of work under each stream and ensure the different starting points and contexts among countries are recognised.

Administrative and logistical arrangements for further meetings and events

- 11. The High-level Political Forum will run from 6 to 16 July. Some data and statistics side events are planned such as the regular VNR datalab for the use of data for Voluntary National Reviews. Please check the <u>calendar</u> for latest updates on the different events.
