Purpose of the meeting

1. Experiences and lessons learned from the World Population and Housing Census Programme (1995-2004)

This session will focus on experiences and lessons learned during the 2000 round of censuses. Participants will review the extent to which countries were able to follow the recommendations of the resolution on the 2000 World Population and Housing Census Programme as well as the implementation by the United Nations of the above mentioned programme. The recommendations coming out of this session will provide inputs for the draft resolution on the 2010 World Population and Housing Census Programme as well as give consideration to updating the *Principles and Recommendations for Population and Housing Censuses*.

- To what extent were countries able to conduct censuses, report results and follow the *Principles and Recommendations* during the 2000 census round?
- Why have some countries failed to carry out a census during the 2000 round?
- How well did censuses meet demands for data at the national level as well as for international reporting?
- How successful were the United Nations and funding agencies in substantively and technically supporting national efforts to carry out population and housing censuses in the 2000 round?

- What elements from the 2000 resolution should be included in the draft resolution on the 2010 World Population and Housing Census Programme? What other elements are needed?

2. Critical issues to be addressed

The recommendations for this session will provide inputs for the draft resolution on the 2010 World Population and Housing Census Programme and contribute to the revision and updating of the *Principles and Recommendations for Population and Housing Censuses*.

- What, if any, additional critical issues have emerged during the past census decade and how should these be reflected in both the draft resolution and future revisions of the *Principles and Recommendations*?
- How might the draft resolution take into account alternative approaches to traditional census taking?
- To what extent should the *Principles* and *Recommendations* consider intercensal survey programmes?
- How might both the draft resolution and the *Principles and Recommendations* reflect the delicate balance between maximizing data utilization and maintaining confidentiality?
- What steps should be taken by the expert group to strengthen public support for censuses?
