ENGENDERING CENSUSES AND HOUSEHOLD SURVEYS

1.0 Introduction

In order to realize the aspirations of Vision 2030 goals, the Kenya Government is determined to mainstream gender into government policies, plans, budgets and programmes. These efforts are geared to achieve gender equity in all areas that affect the society and ensure that the needs and interests of women, men, girls and boys are addressed. A number of initiatives on gender mainstreaming have been introduced by the government. Among them are the ratification of relevant International Instruments and the appointment of gender officers in all ministries and state corporations. This is in line to bring a considerable degree of gender awareness in all ministries and government agencies. The operationalization and strengthening of gender divisions in all ministries and state corporations is being implemented to achieve gender mainstreaming at all levels. Emphasis is put on engendering data collection and analysis in all areas of the economy. This is a deliberate effort to recognize and acknowledge various ways in which women and men contribute to the economy and society as a whole.

1.1 Institutional Framework

The Ministry of Gender, Children and Social Development developed the National Gender Policy on Gender and Development which spells out a policy approach of gender equality and empowerment of women. The Sectional Paper No. 2 of 2006 provides a framework for the operationalization of gender mainstreaming in policy, planning and programming. The Sectional Paper recognizes that socio-cultural attitudes held by both women and men and their socialization are of particular significance in determining their unequal status. As a result, the development initiatives also impact differently on women and men which in the end affect the development process.

The Department of Gender and Social Development (DGSD) is mandated to promote gender mainstreaming in national development processes, coordinate and harmonize the implementation of the National Policy on Gender and Development 2000 as stipulated in the National Plan of Action (2008 - 2012). With appointment of gender officers in all ministries and state corporations, the Department of Gender and Social Development came up with a framework of activities that would assist the officers strengthen gender mainstreaming in their respective organizations. The gender officers have been trained in the following areas:

- Gender Mainstreaming and Integration
- Gender Analysis
- Gender Audit
- Gender Responsive Budgeting
- Gender Awareness and Advocacy
- Monitoring and Evaluation

Plans are in place to train the gender officers on **Production of Gender Statistics** which will be carried out by the Kenya National Bureau of Statistics.

The Department of Gender and Social Development works closely with Kenya National Bureau of Statistics as the department relies greatly on the bureau for data in all sectors.

Some of documents the department has produced with the assistance of the KNBS are the development of the Kenya Gender Data Sheets 2005 and 2007 and Men & Women of Kenya (Facts and figures 2000).

2.0 Engendering National Census and Household Surveys

The Kenya National Bureau of Statistics is mandated to undertake National Population and Housing Census which is carried out after every ten years at the same time carry out household based surveys (e.g. Demographic and Health Survey after every five years, Integrated Budget Household Survey and many others) which provide data for planning purposes. The KNBS operates on behalf of the government in accordance with the Statistics Act 2006 of the Laws of Kenya.

The planning and execution of census activities are spearheaded by the Kenya National Bureau of Statistics (KNBS) on behalf of the Government of Kenya in accordance with the Statistics Act 2006 of the Laws of Kenya. In order to strengthen the efforts in mainstreaming gender into all aspects of data collection and analysis, the KNBS has critically examined, added questions and modified the data collection tools to reflect a gender perspective.

2.1 2009 National Population and Housing Census

The 2009 Population and Housing Census, whose theme would is "*counting our people for development*" will be the seventh census to be undertaken in Kenyan history on the night of 24th/25th August 2009 as appoint of reference. The overall goal of the census is to provide demographic and soc-economic information on the population and housing and household amenities. Planning for the census started in 2006 with the formation of the secretariat and cartographic mapping. This has taken into account key targets that will be supportive in the achievement of the overall goal. The key targets include: complete coverage; confidentiality of the information collected from respondents; census publicity; use of standard procedures country wide; and enumeration of special population. The Gender Dimension Monograph which was introduced in the analysis stage, during the 1999 Population and Housing Census will be the main focus. Data on employment especially on unpaid work and household production will give an indication of women's contribution to both economy and development process.

2.1.1 Census Process

The census process is undertaken in three major phases namely pre-numeration, enumeration and post-enumeration. All the three phases are very crucial to the exercise and must be taken seriously.

Pre-enumeration,



2.1.1 Organization and Management Structure

A Census Secretariat was constituted in 2006 to spearhead the process of planning and tracking implementation of the various census activities. Committees were proposed and established through a Legal Notice gazette by the Minister of State for Planning, National Development and Vision 2030 in July, 2008. The committees will provide avenues to appraise various stakeholders on progress towards implementation of various activities at different levels. The management of the 2009 Population and Housing Census will be achieved through the establishment of various offices and committees with various functions and responsibilities.





2.1.2 Census Data Collection Instruments

One of the key milestones in the preparatory activities for the census is the development of census data collection instrument which were developed beginning of 2008, tested and then shared with various stakeholders in July, 2008 in a stakeholders' workshop. The instrument were finalized with components on Labour and Agriculture being subjected to further discussions based on the issues raised from the pilot census experiences. Age and sex are key variables on which other variables are based on. In administering the

questionnaire, at no point should these variables be left out otherwise one has to go back to the household to ascertain them. The module on labour force was modified to include economic activity and main occupation etc. The questions are: What was mainly doing during the last 7 days preceding the census night? What was...... main occupation? On average, how many hours does usually work in a week? (See attached Pilot Census Questionnaire)

2.2 Kenya Demographic and Health Survey 2008

KDHS is normally carried out after every 5 years. The survey commenced in November 2008 and is still going on. The questionnaire was modified to incorporate questions that reflect the contribution of women to economic development. During the preparatory stages, a technical committee was formed to spearhead the process. The committee was fairly represented by both female and males (7,18). The DHS has three separate questionnaires namely; Household, Woman's and Man's. In the household questionnaire, questions that relate to the contribution of women were as follows: Where is the water source located? How long does it take to go there, get the water and come back? who usually goes to this source to fetch the water for the household? (*see see attached portion of the household questionnaire*)

In the woman's questionnaire, there is a section on husband background and woman's work. One of the questions asked was "aside from your house work, have you done any other work in the last seven days?" (*see see attached portion of the woman's questionnaire*)

Section six of the Man's questionnaire dwells on employment and gender roles. Some of the questions asked are: "Have you done any work in the last 12 months?, Have you done any work in the last 12 months? What is your occupation, that is, what kind of work do you mainly?, Do you do this work for a member of your family, for someone else, or are you self-employed?" (*see attached portion of the man's questionnaire*).


2.2.1 KDHS Implementation

At the implementation stage, research assistant, super visors are recruited. A TOT was carried out and trainers were drawn from KNBS and other participating organizations like National Coordinating Agency for Population and Development, Ministry of Health, National Public Health Laboratory, NASCOP, KEMRI and NACC among others. After the training, the trainers doubled up as regional coordinators. Table 1 gives details of the personnel involved in the KDHS exercise.

2.2.2 Data Processing

The system for data processing was developed with assistance from Macro International. The process is divided into different components namely, system development, questionnaire receipts, editing, data entry, data cleaning and validation and analysis. All the basic tables produced are in a disaggregated format. Details of the personnel in each category are shown in table 2.







Fig. 2 % Distribution of KDHS data processing staff by category and gender

3.0 Dissemination

For National Population and Housing Census, Gender Dimensions Monograph is among the publications produces after the analysis. All the data presented in this monograph is in disaggregated format and covers all the demographic and socio-economic indicators. From the pilot census, the response to the modified questions was high. The packaging of the information is designed to suit different users and other stakeholders. Other than the main detailed reports, posters, fliers, data sheets are also developed. The dissemination is done in three main stages.

The main reports are launched at national level where line ministries, state corporations, research institutions, donor partners and the media groups are invited for the occasion. The next step is done at regional levels (Provincial headquarters) and the third one at district level. It is at the district level that all the administration are invited and having taken part in the whole process, they are advised to use their local gatherings to continue disseminating the information those at the grassroots of the results of the census or survey. This has been effective. At this level the packaging is made simple where information regarding overloading women with too many responsibilities is expressed in the form of posters, or fliers and to some extent in the form of local plays. This way people are bound to grasp the message fast.

At a later stage, extracts of disaggregated data are done according to sector or combined in the form of data sheet; for example the Kenya Data Sheet 2007 contains most demographic and socio-economic indicators up to the district level. This is one way of measuring the country's status in achieving the MDGs

The Kenya National Bureau of Statistics has also developed a website where most of the information is posted for those who cannot access the hard copies of the reports.

4.0 Future Plans

KNBS is planning to carry out a Time Use Survey in order to capture more information on household production and unpaid work. The National Accounts Section will then operate a satellite account together with the NAS. A team of three officers will be visiting the Republic of South Africa for a study tour to gain skill and more knowledge and finalize plans to implement the Time Use Survey.
