Normative Statements

International and Regional Conventions

- * highest level of normative resources, dealing with inalienable human rights
- * wide scope

Standards, Guidelines and Tools

- * numerous
- * some general in scope, some specific
- * P&R, ICD, assessment tools, strategic plans, handbooks, manuals

Normative Statements

- * normative documents and decisions
- * less binding but more specific in nature

Research

- * cross-cutting issues
- * concentrated on birth

Other resources

- * advocacy and resourcemobilizing documents
- * recommendations from expert group meetings



Conclusions. Main gaps identified

- Guidelines and practical tools for
 - the improvement of death registration
 - linking registration of vital events with the production of vital statistics
- Learning / training programmes for producers and users
- Research work on death, marriage and divorce registration
- Revision of handbooks that accompany the P&R
