Notes on indicator 12: Seats held by women in national parliaments

The Inter-Parliamentary Union is the world organization of parliaments, consisting of more than 140 national parliaments worldwide. Its mandate concerns parliaments and parliamentary democracy. For the past 15 years, the IPU has collected data on women in national parliaments. It is therefore the main source of information for indicator 12.

Indicator 12 shows the percentage of women in national parliaments, the ratio being of total number of seats occupied by women over the total number of seats currently filled in parliament. Compared with other MDG indicators, it is straightforward and easily measured.

Data collection

- The data covers on average 181-189 countries. The number of countries covered in the database varies with suspensions of dissolutions of parliaments. As of November 2006, the database consists of 189 countries.
- The data used is official data received from national parliaments in the majority of cases. After each election a questionnaire is sent to parliaments to solicit the data. If no response is provided, IPU meetings provide a good opportunity for a direct request. As a last resort, other methods are used to obtain the information, such as from the electoral management body or Internet searches.
- The data is collated in excel sheets on a monthly bases and posted on the IPU website at (<u>http://www.ipu.org/wmn-e/world.htm</u>). The main changes in the data obviously occur with elections. However, other changes in data are due to rotation in parliament, such as resignations or deaths that lead to either by-elections or new appointments.
- It should be noted that presenting the composition of parliaments by sex is not a given, despite the fact that it is easily measured. There can be difficulties in obtaining information on by-election results and replacements due to death or resignation. These changes are *ad hoc* events which are more difficult to keep track of. By-elections, for instance, are often not announced internationally as general elections are.
- In order to ensure the validity of the data, our statistics are often circulated to our Members every six months, for corrections or amendments.

Part C: Ongoing Regional or Country Projects

While the IPU is involved in country-level activities providing assistance to parliaments, there are no specific projects that support the development of gender statistics at the national level.
