

Census Round 2010

Progression of Population Censuses and the size of the enumerated population.

The following tables summarize the census activities for the census round 2010. Countries are listed according to the date the census was conducted or is scheduled. Countries which base their detailed population statistics on continuous population registers are listed with the reference date for the population statistics provided by the respective national statistics office.

Only population censuses are considered (no housing-only censuses) and ONLY THE FIRST census of a country in this round (some countries conduct more than one census per decade).

Explanation Columns:

- (A) Countries and areas are sorted in the order of the date of the census
- (B) Census dates are given as listed on the PHC2010 homepage as exact date or as range. If the listed census date is stated as year or month (e.g. 2005 or Oct 2005) the date is given as range corresponding to this data (e.g. 1 Jan to 31 Dec 2005 or 1 Oct 2005 to 31 Oct 2005)
- (C) Census status: T - taken; S - scheduled, not yet taken or not known if taken; N - Not scheduled
- (D) UN membership status as of 1 January 2012 (<http://www.un.org/en/members/index.shtml>)
