I. WHAT IS THE STATISTICAL AGENDA FOR THE DEVELOPMENT?

The Statistical Agenda for the Development is the instrument of management of the development of the National Statistical System for the period 2006-2010, and too for the coordination of partnerships for the official statistics able to guarantee appropriate expectation of the resources for the statistical activity.

II. WHAT ARE THE OBJECTIVES OF THE STATISTICAL AGENDA FOR THE DEVELOPMENT?

The Statistical Agenda for the Development seeks to assure the qualitative and quantitative improvement of the production and diffusion of official statistical information, mainly:

- 1. To adapt the statistical production to the agenda of the country development and to the monitoring of MDG;
- 2. To reinforce the institutional capacities and to improve the articulation and the coordination of the SEN;
- 3. To promote the statistical culture and the use of the statistical information for the administration of the development at many levels;
- 4. To guarantee a positive institutional framework to the development of the statistical science and the improvement of the statistical activities covering.

III. WHAT ARE THE COMPONENTS OF THE STATISTICAL AGENDA FOR THE DEVELOPMENT?

The Agenda includes Statistics Activities Plan for the period 2006-2010, the Training Plan of the human resources of the SEN, the Technological Plan for the same period, the Plan of Institutional Reinforcement..

V. EXECUTIVE SUMMARY

1. AN AGENDA BUILT BY A PARTICIPATORY PROCESS

The Statistical Agenda for the Development was elaborated under a participatory process. Three national ateliers (February 2002, November 2003 and May of 2006) were accomplished, with the intervention of representatives National Council of Statistics, representatives of all Organs Producing Official Statistics, of important segments of the users as ONG's, and representatives of partners as the Agents of the United Nations, of Portugal, of Afristat, and of Paris 21, but also with appropriate diffusion by the press. In the validation process the Agenda was presented to the International Monetary Fund staff, to the united mission of the budgetary supporting partners that includes the World Bank, African Development Bank, Dutch Cooperation, Portugueese Cooperation, Luxembourg Cooperation and the media.

The Statistical Agendafor the Development will be presented to Statistics National Council (CNEST) for approval and then to the Cape Verde Government.

2. A STATISTICAL AGENDA TO BENEFIT THE STATISTICAL COORDINATION AND OF THE PARTNERS OF DEVELOPMENT OF THE NATIONAL STATISTICAL SYSTEM

The Statistical Agenda is an instrument of coordination of the partnerships for the development of official statistics and thus, the essential of the resources for the statistical activities, for the training, for the improvement of the installation of conditions and technological for the whole Statistical System should be mobilized in a coordinated way.

The Statistical Agenda is as such, an instrument of clarification of the public effort and the partners for the official statistics having the national effort assure the sustainability of the statistical activities.

The Government of Cape Verde will accomplish a thematic consultation (round table) of partners of development in order to mobilize financial resources and technicians for the execution of the Agenda

.

3. AN AGENDA PREPARED ACCORDING TO THE BEST INTERNATIONAL PRACTICES

The Statistical Agenda for the Development consummates the national strategy of development of the statistics. It welcomes, at first, the recommendations of the Strategic Scheme for the Reinforcement of Statistical Capacities in Africa and of PARIS 21, but also the commitments of the Country in the frame of GDDS, of the statistical program of ECOWAS, of the Program of International Comparison.

4. AN AGENDA THAT ENABLES THE STATISTICAL SYSTEM TO ANSWER THE NATIONAL PRIORITIES

The Statistical Agenda consummates the integration of the national strategy of development of statistics, in the strategy of development of the Country. It was designed taking as references the main Agendas of development, the perspective of information for the market and the citizenship, the programs of development and the international commitments of Cape Verde.

It will comprise in an integrated way, all of the statistical priorities of the Country, namely within the scheme of the follow up and evaluation of Millennium Development Goals and of the Growth and Poverty Reduction Strategy Paper (PRSP).

5. AN AGENDA TO PROMOTE THE ECONOMIC GROWTH

The Statistical Agenda for the Development ties the appropriate priority to the information on the market. It also adjusts the necessary indicators to the management of macro-economic politics as relative to prices, of the national accounting, of the public finances and of the balance of payments, on companies, on international trade, on consumption, on tourism and globally.

The Statistical Agenda should put at disposal of the national and foreign companies, information that permits identification of business opportunities, management of risks and supervision of the respective development.

6. AN AGENDA THAT VALUES ACTION RESEARCH AS WAY TO FACILITATE THE FOCALIZATION OF SOCIAL PROGRAMS AND TO IMPROVE THE IMPACT OF THE SAME AND RESPECTIVE DEPARTMENTS

The Statistical Agenda for the Development supports on the statistical operations as instruments of action research. In this respect, it facilitate regular information of the job market evolution, namely concerning the structures and so, this regular knowledge of the evolution of the

unemployment, facilitating the adoption of policies for-employment with stability and income, and the annual monitoring of the respective impacts.

The Agenda will make available for the decision-makers and managers of social programs, information with annual periodicity for knowledge of the recent impact of the policies and programs of improvement of life conditions and in general of poverty reduction and unemployment, but also to improve the relocation of resources and the geographical focalization of the programs.

7. AN AGENDA FOR THE SUSTAINABILITY OF OFFICIAL STATISTICS

The Statistical Agenda for the Development is based on valorisation of the profits and good practices of the official statistics in Cape Verde. It is also based on the perspective of results oriented administration and in the integration and rationalization of the official statistical activities, in the valorisation of the administrative sources, in the progresses and perspectives of the Country regarding the New Technologies of Information and Communication and in the appropriate use of the existent capacities relatively to the whole National Statistical System.

The Agenda focuses on the development of the human resources, and has as one of the main modules, the Training Plan aiming at gaining competence for the working positions. In this perspective, the Plan will though, focus on the perspective of acquisition of three types of competences: basic level (acquisition of minimum competences), advanced level (or specialized, seeking the creation of technical and scientific autonomy) and recycling (up-dating of knowledge).

The valorisation of the administrative sources is one of the important focuses of the Statistical Agenda, seeking to improve the statistical spreading and to rationalize the costs of the statistical activities. The Technological Plan to implement in the frame of the Statistical Agenda should facilitate the use of those sources, but also those of the census cartography and the diffusion of official statistics.

The Statistical Agenda will clarify the magnitude of the national effort for the official statistics and it will recommend more advanced modalities of allocation of resources to assure the predictability and the sustainability of the System.

It will naturally demand financial reinforcement for the statistics. The resources for the execution of the Statistical Agenda for the Development is estimated to be about 15 million dollars, including the expenses derived from the management of INE, of OPES and of CNEST.

To implement the Statistical Activities Plan it will be necessary about 12, 4 million dollars.

To implement the execution of the Plan of Human Resource Training it will be necessary about 600.000 dollars.

To implement the Technological Plan it will be necessary about one million dollars.

The investments in the construction of the headquarters of INE and other in infrastructures and equipments should also ascend about 1 million dollars.

8. AN AGENDA TO PROMOTE KNOWLEDGE, PARTICIPATION AND CITIZENSHIP

The Statistical Agenda focuses on information for the ONG's namely the associations of consumers but also for the common citizen for the knowledge of the economical and social situation, for the application of assisting rights and claim power to participate in the decision making and the collective effort and, in short, for the citizenship. Being so, it is advisable to invest in statistical literacy and, in general, in the promotion of the statistical culture.

9. A STATISTICAL AGENDA FOR THE DEVELOPMENT

This is an Agenda to facilitate the visibility and the reliability of Cape Verde, the economical growth, the improvement of the impact of social policies, the reduction of poverty and the inequalities, the exercise of the citizenship, the management under environmental sustainability. Here is a Statistical Agenda for the Development:



Principle 1: Official statistics provide an indispensable element in the information system of a democratic society, serving the Government, the economy and the public with data about the economic, demographic, social and environmental situation. To this end, official statistics that meet the test of practical utility are to be compiled and made available on an impartial basis by official statistical agencies to honor citizens' entitlement to public information	The process of preparation of the Statistical Agenda, was through the analysis and consideration of the statistical incidence of the development calendars and national commitments, but also for the due consideration of the recent search of the statistical information, select the statistical operations of usefulness effective for the knowledge and the action for the decision maker (national or foreign, including the development partners) as for the common citizen.
Principle 2. To retain trust in official statistics, the statistical agencies need to decide according to strictly professional considerations, including scientific principles and professional ethics, on the methods and procedures for the collection, processing, storage and presentation of statistical data.	The Statistical Agenda will be implemented by the National Statistical System that appreciates the independence trends and the Organs Producers of Official Statistics, autonomy, in the context of the execution of the statistical activities. The technical and methodological options that the statistical operations of the Agenda contain elapse of the good emanated international practices of the Commission of Statistics of the United Nations.
Principle 3. To facilitate a correct interpretation of the data, the statistical agencies are to present information according to scientific standards on the sources, methods and procedures of the statistics	The popularization of information on the sources, the methods and procedures used is already practical in most of the statistical publications. However, the Official Database Statistics and to conclude in the sphere of the Statistical Agenda holds a database of goal-information, besides assuring the access through an only counter, the statistics officials of Cape Verde portal - of all the statistics officials, it makes available for each statistics the key-information relative namely to the source, the methods and the procedures.
<u>Principle 4.</u> The statistical agencies are entitled to comment on erroneous interpretation and misuse of statistics	It is already familiar to the Organs of the National Statistical System and mainly the INE to provide public information for explanation, in cases of wrong interpretations and of the abusive use of official statistics. This good practice will be maintained following the essential of the legal system.
<u>Principle 5.</u> Data for statistical purposes may be drawn from all types of sources, be they statistical surveys or administrative records. Statistical agencies are to choose	The Statistical Agenda struggles to respond the statistical demand, the resource to

the source with regard to quality, timeliness, costs and the burden on respondents.	inquiries and censuses, but also tries to offer appropriate valorisation to the administrative sources. The technological plan is one of the modules of the Statistical Agenda and it seeks, among other to endow SEN of platforms and technological solutions that allows the best use of the administrative sources. The Agenda still has the concern of the statistical integration, in order to avoid the duplication of efforts and the eventual overload.
Principle 6. Individual data collected by statistical agencies for statistical compilation, whether they refer to natural or legal persons, are to be strictly confidential and used exclusively for statistical purposes.	The Statistical Agenda will recommend some legislative alterations for better adaption to the legislative and institutional sphere and to the statistics challenges on this decade. However, the alterations won't include the principles of the statistical secret properly treaty in the Law of SEN.
<u>Principle 7.</u> The laws, regulations and measures under which the statistical systems operate are to be made public.	All the laws and regulations that govern the Statistical System are in the Bulletin, as well as of the Web-site of INE.
Principle 8. Coordination among statistical agencies within countries is essential to achieve consistency and efficiency in the statistical system	All the laws and regulations that govern the Statistical System decree in a clear way on the principles and the coordination mechanisms, as well as objectives and technique. The Statistical Agenda is par excellence an instrument of statistical integration and as such, this coordination of the statistical activities procures the rationalization of the statistical activities.
Principle 9. The use by statistical agencies in each country of international concepts, classifications and methods promotes the consistency and efficiency of statistical systems at all official levels.	The statistical operations of the Agenda basis on the use of the concepts, classifications and universal methods. Being so, the development of statistical nomenclatures, not existent starting from references and the revision of the existent ones, considering the revision of the international standards are activities predicted in the Agenda.

<u>Principle 10.</u> Bilateral and multilateral cooperation in statistics contributes to the improvement of systems of official statistics in all countries

A Statistical Agenda for the Development welcomed first of all, the orientations of the Strategic Sphere for the Reinforcement of Statistical Capacities in Africa and of PARIS 21. Likewise, the execution of the Agenda will be accomplished with support of the cooperation bilateral, as well as multilateral, like Afristat, World Bank, BAD, United Nations, as well as of the sub-regional organisms of cooperation as ECOWAS.

7.1 THE SYSTEM OF INFORMATION FOR THE ADMINISTRATION OF THE STATISTICAL CALENDAR FOR THE DEVELOPMENT

The Statistical Agenda for the Development 2006-2010 tries to integrate the strategy of the development of the statistics in the national strategy of development, and for so, to take care of the statistical incidence of the international commitments, calendars and Country development programs.

Consequently, a system of information was developed for the management of the Statistical Agenda that establishes an inventory of about 40 international commitments, calendars and development programs of the Country, namely: OMD, DECRP, GDDS, the multilateral monitoring in the scope of the ECOWAS, the aid programs budget of the European Union, Holland and the respective statistical incidence translated in more than 700 statistical indicators. The System establishes the chronology of diffusion of the statistical indicators considering the monitoring of the mechanisms and evaluation of the commitments, programs and calendars, it would list the statistical sources, the great statistical operations (Censuses and Inquiries), the operations on administrative sources and the regular statistics, with the respective chronology, as well as the plan of statistical spreading for the period 2006-2010. The System still establishes the matrix of the technical, financial and institutional partnerships in order to sustain the Statistical Agenda. This system facilitates the whole process of hierarchy of the statistical activities considering the entire commitments, calendars and development programs that it assists.

Constructed in the ambit of the elaboration of the Agenda, it will be effectively the system of future Agenda management, being able to be a component of their outputs, to be a public consultation through BDEO, in the scope of the transparency of the statistical activities, in order to contribute for the reinforcement of the statistical culture and too for the public control of the SEN activity.

VIII. STATISTICS ACTIVITIES PLAN FOR 2006-2010

The Activities Statistics Plan consist of synthesis operations as the national bills/accounts, the demographic projections, the balance of payments and the energy balance, Censuses and Inquiries as the Census 2010, the Second Demographic Inquiry and Reproductive Health, the Inquiry to the Expenses and Family Revenues of 2007/2008 (IDRF 2007/08), the Unified Questionnaire of Basic Indicators of Well-Being (QUIBB), 2nd Business Census of Cape Verde to be accomplished in 2009, the Annual Inquiry to the Enterprises, the Inquiry about the tourists' satisfaction, the Annual Inventory of Establishments of Tourist Lodging, the Inquiry about the situation of the Deficient ones, to accomplish by the INE.

It still consists of the biannual Inquiry to the employment, the Inquiry to Informal Sector to be accomplished by IEFP, the Socio-economic Inquiry, the census of the units of craft fishing and the inquiry to the production of the craft and industrial fishing, to be done by the INDP, the device follow-up of the vulnerability to the food insecurity, the Inquiry to the Zoo technical parameters of the cattle, the Annual Inquiry to the rain cultures and livestock, the Inquiry to the production of the irrigated cultures among other operations of the system of permanent statistics of MA.

It still contains the production of statistics with the administrative sources help, especially by OPES as the Education and the Health, as well as the development of the usual statistics.

IX. HUMAN RESOURCES TRAINING PLAN OF THE SEN FOR 2006-2010

From the SEN, it is expected that takes the responsibility for the essential of the follow up programs and evaluation included in those projects or programs. The demands to SEN implicate that this is qualified properly in the sense of answering in a positive and opportune way those demands. In this sense, the present Plan of Training was elaborated for the period 2006-2010, seeking the execution of the Plan of Statistical Activities of Middle term for the same time.

The integration of the Training Plan into the Plan of Activities is an innovative exercise in Cape Verde, elaborated by INE, in collaboration with OPES, consulted during the process.

The Training Plan of SEN allows, in a perspective of middle and long term, the gradual technical autonomy of the OPEO and, it becomes more and more qualified OPEO to render service in an optics of rentabilisation of their human resources and material, above all, of automatic treatment of the information.

The Training Plan is in quest of the acquisition of competences, having been included all of the training actions that, for a certain workstation, they make possible the exact exercise of the functions attributed to this position. In this view, the Plan was elaborated taking into account three types of competences: basic level (acquisition of minimum competences), advanced level (or specialized, seeking the creation of technical and scientific autonomy) and recycling (updating of knowledge).

In this viewpoint, it was considered as minimum prototype for the most qualified technicians (superior and middle) a group of aptitudes to the entrance or to be developed as work tools (SPSS, advanced Excel, Elaboration and Administration of Projects and Languages). It why those actions have an important power in the group of the inventoried actions.

The identified training actions profit all the groups and professional categories, not being exclusive technicians with higher academic degree or implicated directly into the statistical production.

The identified actions seek the development of competences for the acting of tasks. In this perspective they were eliminated the actions for acquisition of academic degree, in other words, the degrees were not included, masters degrees, master's degrees or doctorate, owing these actions be fulfilled in an ambit completely differentiated.

The Training Plan still intends to be assigned in the time. However, the impossibility of defining to the departure the available financings does not allow a superior detail, in the measure in that it's drawing in the implementation, the choice of the modalities and the type of training depends excessively on the financial resources at disposal. However, this document should create the Operational Plan of Training in an annual optics, so the number effective of beneficiaries must be identified, the modalities (on Job, in training in room, in Cape Verde, abroad, for e-learning,...), the duration and the program content, among other subjects.

It's certain that many of the actions training can and should be multiplied by the technicians of the SEN or in complement way for national consultants properly qualified. In that case, the use of partnerships with the University of Cape Verde and other institutions of the higher education is inavoided

The Training Plan implicates a substantial modification in the politics of administration of the technical staff of the SEN in the sense of they be multiplied by the beneficiaries the formation actions, in modalities to study case per case. The objective is, firstly, to guarantee an effective institutional profit and not just individual associate benefits to the training and, secondly, technicians of different areas win sensibility in different domains with evident benefits for the professional mobility.

However, it is necessary that it is had in mind that to educate people is not just to give him information in order to get new knowledge, abilities and become more efficient in that he does. It is, above all, a basic process for the workers to discover new attitudes, ideas, solutions and concepts that modify their lifestyle and behaviours.

The following are the training objectives:

General Objective

To implement the Training Plan of Middle term for SEN in the period going from 2006 to 2010 that allows, first, the execution of the Statistical Agendaand, second, that orientates the SEN for it gradual technical and scientific autonomy, through the rationalization of the scare resources affected to the this activity, disseminating the knowledge through the internal multiplication and the promotion of a true mobility politics within the SEN.

Specific Objectives

To carry out the attributions in the ambit of the follow-up of the programs and evaluation of DECRP, MCA and OMD, among other documents and programs of reference of the country;

- "To endow OPEO of SEN with the technical and scientific competences in order to the gradual reduction of the technical dependence of external entities to the System:
- To facilitate the execution of the Statistical Agenda 2006-2010;
- To allow the INE the increment of revenues through the rendered specialized services in statistics areas and similar;
- To allow the INE to support the higher education institutions in the teaching of disciplines with high technical and scientific component;
- To stimulate the innovation in the work methods and promote the elaboration of technical communications.

No final da execução do Plano deverá não só ter sido reforçada a capacidade teórica interna e a respectiva capacidade de colocar em prática os conhecimentos adquiridos, mas, sobretudo, permitir a promoção de uma verdadeira política de mobilidade interna (no INE e nos OPES) dos quadros técnicos.

Para a sua elaboração foi utilizada a seguinte metodologia:

For the materialization of those objectives, the Training Plan has a temporary logic that allows, first, the rationalization of the scarce resources, affected to this activity and, secondly, allows the dissemination of the knowledge through the internal multiplication. The goal will always be to produce statistics with quality and to diffuse them with opportunity.

At the end of the execution of the Plan, not only the internal theoretical capacity will be reinforced and the respective capacity to put in practice the acquired knowledge, but, above all, to allow the promotion of a true politics of internal mobility (inside INE and OPES) of the technical staff.

For its elaboration the following methodology was used:

- ✓ To carry out an evaluation of the needs in effectives and training of the producing organs of official statistics of the National Statistical System. By default, an inquiry was done to all the technicians of SEN, following by qualitative interviews to the leaders of the producing organs;
- ✓ "To develop a program of average formation progressively, open to all of the producing organs of the National Statistical System, in statistics (in technical and instrumental areas correlated), and in administration;
- ✓ "To privilege the training modalities on job, whenever necessary with the collaboration of appropriate structures of the higher education, national and foreigner, that offers a teaching of recognized quality. It was advantaged the formation on equally Job or in labour schedule as way to promote the participation and to obtain concrete results. However, that objective should be rendered in approach more effective in the Operational Plans.

✓ To privilege the training in national territory, to be accomplished by national consultants or for international consultants but to be realized in Cape Verde, as manner to rationalize resources and increase in a significant way the number of beneficiaries.

In fact, one is aware that there is not enough internal human capacity to carry on all the training that is needed. However the realization of the training session abroad is very expensive and limits the number of participants. In any case it is recommended that the definition of a strategy of financing the training actions correlated to statistical cooperation policies.

The results of the Training Plan were:

- ✓ Characterization of the staff of the OPEO
- ✓ Listing of the OPEO needs on staffs and training
- ✓ Budget of Training Actions
- ✓ Differentiation between technical and scientific training capacitation and recycling one
- ✓ Identification of the training actions for each OPEO

The Training Plan at present elaborated will allow, in function of the mobilized resources, to identify the necessary training actions and the respective modalities. The product to obtain will be like this: the Operational Training Plan.

The training plan will cost around 600 thousand USD, about 70% affected to the INE and 30% to the OPES.

X. ACTORS

The coordination of the Statistical Agendawill be insured in the ambit of the system and the mechanisms of operation of the National Statistical System. So, the coordination of the statistical activities will be highly accomplished by CNEST, having as instrument the plans and the reports of official statistical activities.

In the terms of the law, the partners of the development will be invited to the meetings of CNEST in that it is approved the report and the annual plans of statistical activities.

The INE assures the <u>technical coordination</u>, in the terms of the law, through protocols with OPES, of the accomplishment of conjoined operations and the integration of the operations like the QUIBB-CV.

The INE will lead the <u>assembling of the technological plan</u> of the National Statistical System and it assures the coordination of the implementation in articulation with NOSI.

<u>The implementation of the training plan</u> will be coordinated by INE in articulation with organisms of the public administration of the training area. It will be created at level of the INE, a Division of Administration of the Training Plan.

The Direction of Plan and Operations of the INE supervise the <u>planning and the monitoring</u> of the Statistical Calendar.

<u>The coordination of the partnerships</u> for the Statistical Agendawill be insured by the General Direction of the Plan of the Ministry of the Finances and Administration and by the General Direction of the International cooperation of the Ministry of Foreign Affairs, Cooperation and Communities. It will be accomplished annually a meeting balance of the programming of the statistical cooperation, with INE and OPES under the leadership of General Direction of Plano and the General Direction of the International Cooperation.

XI. RESOURCES FOR THE IMPLEMENTATION OF THE CALENDAR

The Statistical Agendafor the Development constitutes the opportunity of the decade to adapt the Statistical System to the demands of a Country of Medium Development, demanding the reinforcement of the financial effort for the statistics.

The resources for the execution of the Statistical Agendafor the Development should reach about 15 million dollars, including the appealing expenses of operation of INE, OPES and CNEST.

This amount includes:

- ✓ 12, 4 million dollars for the execution of Statistics' Plan Activities
- ✓ 600 thousand dollars for the execution of the Training Plan of the Human resources will be necessary.
- ✓ 1 million dollars for the implementation of the technological Plan
- ✓ 1 million dollars for the investments in the construction of the headquarters of INE and other infrastructures and equipments

The Government of Cape Verde should approve the Statistical Calendar, making it an official instrument of administration of the development of the Statistical System, as it will negotiate a STATCAP with World Bank, as well as the financing of BAD in the ambit of the cooperation program with Cape Verde.

The Government of Cape Verde should accomplish a thematic consultation (Round Table) of the development partners for the mobilization of the necessary resources to the execution of the Statistical Agenda

XII. STRATEGY OF MOBILIZATION OF RESOURCES

PRINCIPLES

- 1. the Statistical Agendais an instrument of coordination of the partnerships for the statistics officials' development, which should help the rationalization of the resources (No duplication of efforts and statistical integration)
- 2. The national effort should guarantee the sustainability of the statistical activities
- 3. The financial support of the Statistical Agendais segmented in agreement with the areas of specialization of the partners
- 4. The cooperation in the statistics domain should help the previsibility of resources for the official statistical activities

MECHANISMS

- 1. The Government will accomplish a thematic consultation (Round Table) of the development partners)
- 2. Affectation of national resources through the National budget
- 3. Consultations themes to the partners
- 4. Balance and annual programming of the statistical cooperation for INE, OPES, DGP and DGCI, under the leadership of DGP and DGCI.

PARTERSHIPS ALREADY IDENTIFIED

We propose to appeal to the financing of World Bank through STACAP and of Trust-Fund of Monitoring and Evaluation of PRSP, of BAD in the setting of the new cooperation program with Cape Verde for the period 2006-2010 and the Program of International Comparison (PCI), of the Swedish Cooperation in the setting of the Project of Assistance to the Statistical System of Cape Verde, the Portuguese Cooperation, in the extent of the Agreement of Statistical Cooperation and in the scope of the program of cooperation of middle term, of the Office Common of Fund and Programs of the United Nations in ambit of the Program of Cooperation for the period 2006-2010 and the support to the follow-up of the Objectives of Millennium for the Development, the European Union, in the ambit of the project "Support to the Development of the Statistical Systems of PALOP", of Handicap International and the Luxemburg cooperation, in the scope of the cooperation with Cape Verde and the Millennium Challenge Account, ECOWAS, in the ambit of ECOSTAT and Afristat, in the scope of the Strategic Program 2006-2010.
