BACKGROUND

Implementation of the statistical programmes and activities is a very demanding and complex process based on continuous co-operation and co-ordination of all institutions and stakeholders, systematic monitoring and use of international standards and recommendations, thus ensuring reliable and internationally recognized statistical indicators to be produced for the whole country.

Those participating in the implementation of the statistical programmes are those leading the statistical activities, data providers for statistical surveys and users of official statistics.

The following institutions are officially leading the BiH statistical activities: Agency for Statistics of Bosnia and Herzegovina, Institute of Statistics of the Federation of Bosnia and Herzegovina, Institute of Statistics of the Republika Srpska and Bureau of Statistics of the Brčko District, defined by the Law, as Branch Office of the BiH Agency for Statistics.

Other institutions at the levels of Bosnia and Herzegovina, which within their competence perform also the statistical activities, were not officially included in the common statistical system of Bosnia and Herzegovina during the preparation of this Multi-annual Programme.

The tasks and development of the BiH statistics in the next four-year period are clearly defined by the objectives and responsibilities taken by Bosnia and Herzegovina given the local, European and international priorities, on the one hand, and existing situation, real possibilities and available resources, on the other hand. To this end, the priorities and overall planned activities in the Multi-annual programme were accordingly referenced.

The main purpose of the implementation of statistical programme is foreseen in the following:

- To mirror as faithfully as possible the real situations and honor the citizens' right to public information;
- To focus on phenomena which are essential for decision makers, public institutions, businessmen and other organizations to be able to monitor changes and trends in the economy; to analyze them, make reliable forecasts and undertake all the necessary measures;
- To enable medias, teaching institutions, scientists, researchers and analysts to use objective and reliable information on economic and social trends;
- To help European and international organizations and donors to plan their activities on the basis of internationally recognized statistical data.

Due to a number of impeding factors, the drafted Multi-annual Programme could only and partly meet the requirements during the period from 2005 through 2008. Nevertheless, we do believe that the selection of priorities specified by this Programme could create a basis

for faster development and improvement of the statistical system and better quality of statistical services.

The 2005-2008 BiH Multi-annual Programme is composed of the following parts:

- A. Strategic guide for the development of BiH statistics until 2008,
- B. Principles of Official statistics of Bosnia and Herzegovina;
- C. Systematic Overview of Planned Statistical Activities;
- D. Reference between Eurostat Statistical Requirements Compendium and Systematic Overview of Statistical Activities in the Multi-annual Programme;
- E. Resources needed for the implementation of the Multi-annual Programme.

Statistical activities not included in the BiH Statistical Multi-annual Programme but subject to specific needs and requirements of the entity governments shall be included in the programmes of the entity institutions.

In same exceptional cases, the District Brcko Bureau of Statistics and institutions in charge of surveys in District Brcko, in addition to provision of data to be processed at the State level, shall collect and process data for the specific needs of the District Brcko pursuant to the BiH Law on Statistics. The responsibilities of the reporting entities to provide and submit such data are those defined in the BiH Statistical Programme. Annual statistical programme of District Brcko shall make an integral part of the BiH statistics annual programmes.

A. STRATEGIC GUIDE FOR DEVELOPMENT OF BIH STATISTICS UNTIL 2008

MISSION:

Mission of the official leaders of statistical activities in BIH considers an efficient production and dissemination of good quality and timely statistical data meeting user needs and reflecting the situation and changes in the economy, demography, social domain, environment and natural resources. Such data should enable international and time series comparisons.

VISION:

- Harmonization with international and in particular - EU standards and recommendations;
- User orientation;
- Up-to-date approach for data collection, processing and dissemination;
- Quality improvement of statistical information;
- Implementation of modern IT systems and innovations;
- Skilled and motivated staff;
- Working conditions improvement

- Respecting the ***official principles*** and statistical ethic;
- Building cooperation and confidence between users, leaders of statistical activities and statistical data providers;
- Producing user oriented statistical data;
- Providing high quality of statistical services and products;
- Respecting knowledge and experience ;

- Respecting privacy of individual data;
- Increasing efficiency and team work;

FUNDAMENTAL TASKS:

- Production, processing and storing of statistical data and information;

- Building and maintenance of statistical infrastructure and/or classifications, registers, data bases and meta-bases, system of statistical indicators and similar;
- Quality improvement of statistical activities;
- Development and improvement of statistical methodologies;
- Improvements in organization of surveys;
- Improvements in preparation and dissemination of statistical information;
- Improvement and development of internal and co-ordination between the institutions;
- Improvements in organization of work;
- Strengthening professional skills and raising capacity.

*RELATIONSHIPS BETWEEN THE THREE SIDES PARTICIPATING IN THE IMPLEMENTATION OF STATISTICAL ACTIVITIES
(users, leaders of statistical activities and data providers)*

User needs orientation:

- Production of statistical information in line with current and future needs;
- Dissemination of statistical information - data and meta data – according to user needs;
- Implementation of surveys, according to specific user needs.

User groups:

- Public administration and government institutions;
- Research sector and universities;
- Business sector;
- Non-government organizations;
- Media and public;
- European institutions and international organizations.

Improvement in dissemination of statistical information:

- Integrated use of electronic technologies through countrywide statistical system;
- Increased presentation of statistical information and meta-data according to user needs;
- Combined use of electronic and conventional dissemination systems;

- Analysis of information published and broadcasted by different medias and provision of aggregated statistical data at various and detailed levels of aggregation.

Reducing the burden on data providers:

- Detailed analysis and balance between user needs and burden on data providers;
- Better organization and coordination of statistical surveys;
- Gradual transition to sample survey from full coverage survey;
- Increase in electronic data collection;
- Optimal sample size and coverage of micro-enterprises.

B. OFFICAL PRINCIPLES OF THE BiH STATISTICS

Availability of reliable statistical information is crucial for democratic societies. To meet such requirements the official statistics must acquire the confidence of wider public, data providers and data users. The BiH statistical institutions are fully aware of responsibilities and obligations in this matter.

In line with the ***UN Fundamental Principles of Official statistics*** and given the:

- Article 19 Law on Statistics Bosnia and Herzegovina
- Article 2 Law on Statistics of the Federation of Bosnia and Herzegovina and
- Article 17 Law on Statistics of the Republika Srpska

The Agency for Statistics of Bosnia and Herzegovina, the Institute of Statistics of the Federation of Bosnia and Herzegovina, and the Institute of Statistics of the Republika Srpska, shall ensure the following principles to be applied to all important areas of their activities relevant for the official statistics:

RELIABILITY

Aimed at meeting the starting point for public and private decision-makers the official statistical data must guarantee proper accuracy. This means that statistics institutions shall acquire information based on «relevant figures». However and given the fact that all statistical data have to be considered only as estimates of unknown real values, this means that such figures shall represent the best possible approximate value. Only with such degree of reliability they can justify the confidence of users.

OBJECTIVITY

The official statistical data shall be produced by applying objective and transparent methods. The statistical institutions shall decide on methods and procedures to be applied for data collection, processing, storage and presentation strictly in accordance with professional criteria based on scientific principles and statistical culture.

RELEVANCE

The official statistical data describe progress and trends in the economy and society, as much as possible. Aiming at correct data interpretation, the statistical institutions shall present information on sources, methods and applied statistical procedures on the basis of professional standards.

QUALITY

The professional skills shall represent the basis for all the activities of statistical institutions. The strengthening of professional skills shall be guaranteed through trainings, surveys and standard international practice. A good co-operation between the statistical institutions in Bosnia and Herzegovina is crucial for the consistent and efficient statistical system.

IMPORTANCE

The statistical institutions produce information and data to be used by public in monitoring economic and social matters and trends and thus enabling proper functioning of the society. The Statistical Council shall discuss the Programme, suggest the final comments, recommendations and give the final opinion for adoption as it sees fit for political, scientific purposes and for general public.

STATISTICAL CONFIDENTIALITY

The official statistics is based on information and data collected from a number of individuals and enterprises. Such information and data are strictly confidential and shall be used only for the production of Statistics.

TRANSPARENCY

The BiH statistical institutions shall have clear communication aiming at correct data interpretation fully in accordance with professional standards, sources, and methods defined for presentation of statistical data.

C. SYSTEMATIC OVERVIEW OF STATISTICAL ACTIVITIES IN 2005-2008

1. GENERAL OVERVIEW

The priorities of the BiH statistics in this period are aimed at considering the European statistical system requirements. During the process of preparation of reforms to approach the European integrations Bosnia and Herzegovina aims at implementation of all the EU standards/*acquis* in the field of statistics. To this end, the reference between the requirements of the European integrations and the BiH Statistics Multi-annual Programme, is aimed at monitoring the process of implementation of the EU legislation in the field of statistics through performance of statistical activities.

Simultaneously, the Multi-annual programme ensures harmonization of fundamental tasks, strategic policies, particular programmes and individual statistical activities. The key instruments for the implementation of the Multi-annual Programme are seen in the annual programmes of statistical activities, adoption and use of *acquis* in all statistical fields, operational plans for implementation of particular tasks and activities and progress reports.

In particular, the responsibilities of statistical institutions meaning the implementation of specified tasks within the statistical activities are thoroughly provided in the annual programmes and plans of the statistical activities.

The 2005-2008 Multi-annual Programme offers a modest structure if compared to similar programmes offered by other countries. Nevertheless, its structure shall ensure a production of basic information to meet the:

- Requirements of government bodies for monitoring of defined priorities (continuing macro-economic development, improved living standard, improved conditions for business development, social programmes and labor market, European integrations);
- European institutions and international organizations requirements;
- Other user demands

The structure of the BIH programme meets the requirements of the following documents:

- Community Statistical Programme 2003-2007, making a part of *acquis*;
- Eurostat Statistical Requirements Compendium;
- Global assessment of BIH Statistical System;
- Opinion of the European Commission that «statistics play an important role in monitoring the situation and progress in all fields to be negotiated»;
- BIH specific needs.

2. OVERVIEW OF PLANNED INFRASTRUCTURAL ACTIVITIES

Development of statistical infrastructure is an inseparable part of the programme making a basis for its implementation. However, it is not possible to include all planned activities with regard to infrastructure in the overview of individual statistical activities since they, mainly, make an integral part of each separate module and statistical activity.

Therefore, the planned activities on infrastructure are listed below:

a) Continuous monitoring of statistical data quality (Theme 10)

During the first year of the programme implementation, a document “Systematic approach of BiH statistics in monitoring quality of statistical activities” shall be drafted. This document aims at providing the guidelines for monitoring the statistical data quality during all phases of statistical data production and linking of each single statistical activity, as planned in the Multi-annual Programme, with EU recommendations «Leadership Expert Group on Quality» and other relevant literature. Initially, the analysis of the current situation should be carried out, including well-defined overview of variable contents, methods used for data compilation, summary of data sources and summary of possible shortcomings and error sources. The Statistical Council shall play an important role in quality management development and inclusion of data providers and data users in the operation and development of the BiH statistical system.

b) Classification (Theme 11)

Classifications represent a very important segment within statistical infrastructure. Accordingly, this Program includes a number of activities for introduction and use of EU classifications in the BiH statistical system. First of all, introduction and use of EU Classifications of Economic Activities: initially in the 2005 NACE rev.1.1, and then 2007 NACE. Setting up and development of the Business Register for statistical purposes in line with EU Recommendations are closely related to the Classification of Economic Activities. Pursuant to such recommendations all statistical units (enterprises, local, units homogenous production units) have to be linked to variables defining their **activity** (primary, secondary and auxiliary), **size** (number of employees, turnover and net assets) and affiliation to one of five institutional sectors. In parallel, EU Classification of Products by Activities – CPA supported by corresponding NACE. The following classifications shall also be introduced and used: Classification of Individual Consumption by Purpose (COICOP), Classification of Functions of General Government (COFOG), other functional classifications (COPNI, COPP), Classification of Occupations (ISCO), Classification of Constructions (CC) and International classifications of economic purpose of products (BEC). For the foreign trade needs a combined nomenclature CN shall be used. What concerns the social statistics the standard classifications of education based on ISCED shall be used. What concerns the territorial classifications a unique register of administrative-territorial and territorial units shall be introduced and also, EU regional NUTS classifications.

c) Training and strengthening professional skills in statistics (Theme 12)

During the implementation of the Multi-annual Programme, a special attention shall be paid to training courses. All priority tasks defined by the Programme shall be supported by

well designed training courses. This includes: foreign languages classes, IT courses, the best possible practical solutions in different field of statistics, use of sample methods, data dissemination etc. Training program will be implemented through annual plans. Practical use of acquired know-how will be precondition for any further training.

d) Electronic data processing (Theme 13)

Definition of IT strategy for electronic data processing; Standard data entry software; Experience of Eurostat; Electronic data collection and transmission between entity statistical offices, the BiH Agency for Statistics and other institutions and Eurostat; Definition of procedures for data storage; Development of applications to be used for survey analysis and preparation and publication of results.

e) Information technologies (Theme 14)

Procurement of new servers with more processors, memories and higher speeds. Experiences of other countries to be studied and applied; Transfer of new technology; Entity statistical institutes, the BiH Agency for Statistics and other institutions to be connected by a network (the Central Bank BiH, Tax Authority and others); Provision of network and data protection and design of a firewall.

f) Reference databases and meta-bases (Theme 15)

Design the IT strategy for databases; Develop data models to connect related statistical surveys; Define all classifications, nomenclatures, codebooks for the base and meta-base, and offer them to others as standard to facilitate exchange of data; Use different administrative sources; Design a BiH database; Use SPSS, SAS, STATA software tools for analyses and reports; Define and design meta-base with statistical methodologies, classification, statistical terms etc.

g) Access to information (Theme 16)

Improve accessibility to information and statistical data by using web pages. Provide professional assistance through library and telephone services; Improve quality of statistical bulletins; Organize statistical conferences and presentations.

h) Dissemination (Theme 17)

Ensure the BiH Statistical system to be user friendly and user orientated; Increase a number of data to be published; Apply a principle of free statistical data dissemination in BiH; Publish bulletins for a particular statistical fields.

i) Statistical coordination (Theme 18)

The activities to be covered in the next period:

- To improve cooperation between the statistical institutions to ensure implementation of tasks specified by the BiH Statistical Programme and provision of relevant and updated data for Bosnia and Herzegovina;

- To coordinate preparation of strategic documents necessary to develop the BiH statistical system (four-year statistical programme, annual work programmes).
- To coordinate the activities on development of methodologies for statistical surveys and researches; definition of standards to be used by statistical institutions.
- To coordinate development of project documents needed for the implementation of the programme and other statistical activities.

j) Statistical co-operation (Theme 19)

The following activities are covered by this theme:

- Strengthening of relations and cooperation with other State institutions collecting statistical data within their competence and for the needs of the BiH statistics (Indirect Taxation Authority, Ministry of Foreign Trade and Economic Affairs, Ministry for Human Rights and Refugees, Central Bank BiH, State Border Service etc.). A separate Memoranda of Understanding will be signed with each above-mentioned institution;
- Providing professional support in drafting methodologies and applying international standards.
- Providing active participation of statistical institutions in drafting all the necessary documents and legal regulations meeting BiH and/or international needs and specifying needs for statistical data.
- Improving cooperation with academic community to exchange and strengthen statistical professional skills and capacities and increase confidence of public;
- Developing cooperation with business community to underline the importance of statistical data in managing business and other policies;
- Increasing cooperation with the Directorate for European Integrations to coordinate all activities and meet SAP and European partnership requirements;
- Improving cooperation with EUROSTAT, OECD, SIDA, EFTA, statistics of UNECE, UNDP, WTO, WB, IMF and other European and international institutions in implementing CARDS and other programmes of assistance aiming at harmonization of the BiH statistics with European and international standards and meeting the conditions to sign the SAA;
- Developing cooperation with statistical institutions in the West Balkan countries and signing an agreement on cooperation to create the conditions for regional statistical development;
- Developing cooperation with statistical institutions of European countries aiming at exchange of experience and strengthening relations with ESS (European Statistical System).

k) Activities on research and methodology (Theme 22)

When implementation this programme, the work on research and methodology will be organized, if necessary.

1) Data protection and statistical confidentiality (Theme 25).

During the first year of implementation all the necessary documents regulating statistical data protection and statistical confidentiality will be drafted and harmonized with the relevant EU standards.

The particular statistical activities and surveys from the Multi-annual Programme were incorporated into the corresponding modules (themes and chapters).

What concerns the tabulation, chapters, themes and modules fully meet the 2003-2007 Community Statistical Programme and Eurostat Requirements Compendium. The modules represent a list of all the requirements for various statistical areas and policies.

The modules are to be implemented on the basis of various surveys (statistical surveys designed for collection of micro data from respondents, other surveys designed for grouping the final and intermediate statistical characteristics, processing by aggregation and balancing), by activities on the statistical infrastructure and other statistical activities.

The contents of particular modules inside the programme require implementation of more than one statistical survey or activity. The infra-structural activities are, mainly, incorporated in every statistical survey or activity, for example, every statistical survey is linked with corresponding and relevant classifications and requires IT support and processing.
