## Clarifications related to question 8:

 in 2003 was conducted Pilot Business Census covered all large and medium-sized entrepreneurs and the sample of small ones, all banks, saving banks and insurance companies, the sample of non-profit institutions and public administration as well as the sample of natural persons (crafts and free lances)

## But:

in 2003 was also conducted Agriculture Census
Agricultural Census in 2003 is conducted by Law on Agriculture Census (NN, No 87/2003)
Characteristics covered by Census are completely harmonized with Council Regulation No 571/88/EEC and related amendments

The Census covered 448 532 households and business entities and their parts engaged in agricultural production.

Thresholds for private family farms were as follows:

10 acres utilized agricultural land or

1 head (cattle, pigs, sheep, goats, horses) or

10 adult (poultry, rabbits, bee-hives) /cumulatively

than 1000 m2 in intensive production of aromatic and medicinal plants or engaged in intensive production of vegetables and ornamental plants

in 2004 was conducted Census on Sale Capacity in Retailing
