Background

The aim of UNGEGN Toponymic Guidelines is to gather and disseminate toponymic information on a specific country, especially from the perspective of standardization of geographical names. They include information about official, national and minority languages, names authorities, source material for toponyms, glossaries, abbreviations used on official maps and administrative division. For the time being over 40 countries have issued Toponymic Guidelines or at least drafts of such Guidelines, a number of countries having also developed several updates and editions.
