Proposal

Submitted by the Dutch-German Speaking Division (DGSD)

In order to facilitate communication and exchange of information on the standardisation of Geographical names the Dutch-German speaking Division proposes to compile a name and address list of names of authorities and Toponymic Commissions in U.N. member countries.

This list is to be compiled by UNGEGN and should be mailed to the various UNGEGN-Linguistic Divisions for further distribution among U.N. member countries.

As a model of the proposed address list the following addresses of relevant agencies in Austria, F.R.G. and The Netherlands may serve.

Names Authorities and Toponymic Commissions

Austria

Contribution of Austria to the activities of the Chairman of the Dutch- and German Speaking Division of the UNGEGN in accordance with the Report of the Divisional Meeting of October 1980.

In consequence to the federal structure of Austria the legal situation is rather complicated. For the purposes of international cartography the following statements will suffice:

The names of inhabited places of all categories are standardized. They are published by the federal authority

The geographical names other than inhabited place names, i.e. the names of mountains, hills, valleys, rivers, lakes, glaciers, woods, etc. are officially collected and published in maps by the federal authority

The standardization of these names is in progress but not yet concluded. Nevertheless, the names of the official Austrian Map 1:50 000 are to be regarded as official names in so far as they form part of an official publication.
