Summary

The International Seminar on the Naming of Seas, organized by the Society for East Sea to discuss the practices and principles at issue in the naming of seas, has been held annually during the 2002-2007 period. This seminar has generated widespread interest in the issue of naming seas as well as in a comparison of diverse cases of geographical names from all around the world. Over the last thirteen years, from 1995 to 2007, experts from twenty-five countries have participated in this seminar, presenting a total of 158 papers. The subjects of the papers presented span a wide field, ranging from history, geography, old maps and toponymy, to international politics and organizations.

International Seminar on the Naming of Seas, 2002~2007

The International Seminar on the Naming of Seas has been held annually during the period 2002-2007. This seminar has been organized by the Society for East Sea in order to discuss the practices and principles at issue in the naming of seas. Launched in 1995, the seminar has been held in major world political centers, including Vladivostok (2002), Shanghai (2003), Paris (2004), Washington D.C. (2005), Seoul (2006) and Vienna (2007).

This annual international seminar has provided a comprehensive forum to engage in extensive discussions on the history and principles of the naming of seas as well as to introduce diverse cases of geographical naming all over the world. Over the last thirteen years, experts from twenty-five countries have participated in this seminar and presented 158 papers. Forty-seven participants, 27.0% of the total, were from the Republic of Korea, followed by China (27 participants, 15.5%), Russia (25, 14.4%), Japan (12, 6.9%), France (9, 5.2%), and the USA (9, 5.2%). In recent years, there has been an ever greater diversity of countries participating, including Algeria, Hungary, Slovenia, Jordan, Bulgaria, Austria and Israel, which is an indication that this seminar has indeed succeeded in generating interest in sea names in various countries around the world.

The subjects of the papers presented have also encompassed a wide variety of areas, ranging from history, geography, old maps and toponymy, to international politics and organizations. As many as sixty-seven papers, 42.4% of the total, can be categorized under the title of historical geography and old maps, especially regarding the name "East Sea" or "Sea of Japan." Based on historical literature and old maps from each country, these studies have mainly focused on searching for the trajectory of the name of the sea between Korea and Japan.

Worthy of special note is the fact that there has been a growing interest in toponymic principles and comparative case studies on the naming of geographical features in recent years. Since the eighth seminar in 2002, this field has been the focus of the greatest attention. This trend illustrates that the seminar has been coming to the fore as an academic forum for the discussion of naming issues.

The 14th International Seminar is scheduled to be held on the occasion of the 31st International Geographical Congress in Tunis, Tunisia in August 2007.

In addition to this international seminar, there have been workshops with experts on geographical names, organized by the Society for East Sea. Major examples include the workshop at which Dr. Milan Orozen Adamic lectured on the use of exonyms in the Slovene language in Seoul in December 2004. Another noteworthy instance is the workshop at which Dr. Peter Jordan and Dr. Isolde Hausner addressed the topic of exonym use in Austria and place names in Austrian multilingual areas, and the Austrian Committee on Geographical Names and the application of GIS to onomastics, respectively, in Seoul in December 2006
