Nevertheless, we could imagine that in a few areas, more in-depth study could be useful, i.e. - In addition to the National Accounts and the Balance of Payments, more detail could be given for the information systems of "Prices" and "Employment". - discussion of the trade-offs between the various requirements in terms of "accuracy timeliness, consistency, coherence, credibility and relevance". - the subject of horizontal and vertical coherency could be covered in more detail, bearing in mind that user's need for consistent information should be given a high priority. 4.
