MINUTES ISWGNA TELECONFERENCE 28 MAY, 2008

1. SNA/BPM issues

1.1. Classification of licences to use non-customized software and audiovisual products provided on disk for perpetual use

Following the actions agreed to at the ISWGNA meeting of 21 April and a willingness by the Chair of the BOPCOM to consider the change if the major stakeholders of the BPM update were in agreement, the ISWGNA agreed to seek agreement from the major stakeholders, notably the UN merchandise trade, OECD and Eurostat trade in services experts and BOPCOM members to change the draft version of *BPM6*. This will be carried out as follows:

- OECD will circulate draft letter addressed to the Chair, Interagency Task Force on Statistics of International Trade in Services containing the suggested changes, to the ISWGNA by cob today for comments
- The Project Manager, on behalf of the ISWGNA, will send the letter to the UN, OECD identified stakeholders and Eurostat, and the IMF will send the letter to BOPCOM members, seeking their comments before 20 June 2008 deadline for comments on the BPM6 draft.

The ISWGNA emphasized that this issue should not affect the current draft of Volume 1 of the 2008 SNA.

1.2. Software leasing

The IMF BPM staff reported that the following extract from SNA par 10.101 presented problems for the BPM6 and they queried whether it was fully consistent with SNA par 11.78: "If the acquisition of a copy of a licence to use purchased with regular payments over a multi-year contract is judged to meet the conditions of capital formation, then it should be regarded as the acquisition of an asset under a financial lease. If regular payments are made for a licence to use without a long-term contract, then the payments are treated as payments for a service under an operating lease."

The ISWGNA agreed that: (i) the notion of change of economic ownership, as recommended by the AEG, should be added to the first sentence and that the IMF will provide a suggestion by cob 28 May; (ii) the reference "under an operating lease" will be deleted from the second sentence.

1.3. Deliveries between affiliated enterprises

The BPM Editor and the SNA Editor will examine the draft text of both manuals to ensure there is absolute consistency between them regarding deliveries between affiliated enterprises and if necessary, circulate a re-wording of the text in paragraph 14.59 to the ISWGNA.

1.4. Construction projects

The extension of the treatment of long period production of buildings and structures to other items such as ships and aircraft cause an inconsistency with the BPM6. The Editor consulted previous decisions by the ISWGNA and concluded that the ISWGNA agreed to keep the current (1993 SNA) recommendation to treat stage payments for construction and large capital projects as fixed capital formation. The words in par 6.136 referring to ships and heavy machinery should therefore be removed.

2. Chapter 22

The Editor reported that she received comments from most ISWGNA organizations on the chapter. All outstanding comments will be sent by cob Friday, 30 May. The Editor proposed to discuss all comments on the chapter next week with the GFS experts from the IMF to provide an amended version of the chapter to be posted for world-wide comments by cob 6 June. The ISWGNA agreed to the proposal.

3. Chapter 25

The Editor reported that comments from most of the ISWGNA organizations were still outstanding. It was agreed that each ISWGNA organization should provide comments on the draft chapter and outline the issues that should be incorporated into the chapter. UNSD will compile the list of these outlined issues. The ISWGNA will discuss this chapter in a later teleconference.

4. Follow-up on the global review on Volume 1

The Project Manager reported that the Management Group (MG) congratulated the ISWGNA-NA on its achievement in considering the comments received through the global review and accepted their recommendations in this regard.

4.1. Reader's Guide

The MG accepted the Project Manager's proposal to exclude the Reader's Guide from Volume 1.

4.2. Leases and licenses

The MG considered has come to the view that the treatment of emission trading permits in the national accounts needs to be addressed urgently. It has therefore recommended that this aspect of the review of leases and licenses be given a high priority on the research agenda.

The ISWGNA agreed that the Project Manager will provide some suggestions to the MG on a way forward.

4.3. Non-life insurance

The ISWGNA took note of the responses received from some AEG members regarding the Project Manager's note on Non-life insurance.

4.4. Codes

Following the ISWGNA agreement at its meeting of 8 and 9 May 2008 not to change the classification and coding structure of accounting entries in Volume 1, Eurostat sent to the ISWGNA a note with proposed codification changes concerning mainly consumption of fixed capital and current transfers, based on a review of specific country comments, The ISWGNA members, with the exception of Eurostat, confirmed their position not to change the codes of Volume 1. UNSD indicated that it would prepare a draft note to clarify the ISWGNA decision on the codes.

5. High Level Group on National Accounts

The Editor and UNSD will circulate possible issues for discussion at the first meeting of the high level group by cob Friday 30 May for comments by the ISWGNA.

6. Next teleconference

The next teleconference is tentatively scheduled for 10 June.
