MINUTES ISWGNA TELECONFERENCE 19 AUGUST, 2008

1. Progress on Volume 2

The Editor reported that 6 (chapters 18, 19, 20, 22, 26 and 27) of the 12 chapters for Volume 2 are posted on the update website for world-wide review. Comments have been received already on chapters 20 and 27 by the deadlines of 31 May 2008 and 12 February 2007 respectively. Two more chapters (chapters 23 and 25) will be ready for posting by 22 August with a commenting deadline of 30 September.

1.1. Chapter 23 - NPIs

The Editor reported that the draft chapter was submitted to the ISWGNA for comments and that the feedback received indicated the draft needs to provide clearer guidance on the delineation of NPIs in the SNA and the NPI satellite account and the link between the two. The Editor informed the ISWGNA that she will meet with Lester Salamon and Helen Tice from Johns Hopkins University Centre of Civil Society Studies (JHUCCSS) on Wednesday, 20 August to discuss issues regarding the NPI satellite account.

The ISWGNA agreed that the revised version of the chapter, taking into consideration the comments of the ISWGNA and the JHUCCSS will be posted for world-wide review with a deadline for comments on 30 September without further review by the ISWGNA.

1.2. Chapter 25 - Informal sector

The Editor reported that there are a few issues that need to be resolved to finalise the draft for posting. The ISWGNA discussed the issues and agreed on the following:

The chapter should have a broader scope to include not only the informal sector, but also the NOE and provide guidance on the delineation of the concepts.

The term "informal activity" will be replaced by "activities of units in the informal economy" to align with the ILO concept of "informality" which is based on production units rather than enterprises in the SNA sense. The heading of section G will also be adjusted accordingly.

The Editor's version of paragraph 25.49 should be used in the chapter.

The chapter should include information on data collection practices, but they should be presented as guidelines and not recommendations.

After informal consultation with the ILO it was decided that reference in the chapter will be made to ILO instead of ICLS with a clarification that ILO adopts the resolutions after member countries of the ICLS have endorsed them.

The revised version of the chapter, incorporating aforementioned ISWGNA decisions, will be posted for world-wide review with a deadline for comments on 30 September without further review by the ISWGNA

2. Consolidation of country comments

The ISWGNA agreed that the procedure established for the consolidation and assessment of country comments for draft chapters of Volume 1 should be followed. The procedure is as follows:

- Draft chapters are assigned to ISWGNA members who will consolidate the comments and assess them according to the following categories:
 - (i) Out of scope
 - (ii) For consideration by the Editor
 - (iii) For consideration by the ISWGNA by teleconference
 - (iv) For consideration by the ISWGNA at a face-to-face meeting
- The Editor and the responsible organization together will review and finalize the assessments of the country comments for each draft chapter before presenting them to the ISWGNA for discussion.

The ISWGNA agreed to the following distribution of responsibilities for the consolidation and assessment of country comments for the first set of draft chapters of Volume 2:

The consolidated country comments for these chapters need to be submitted to the Editor by 7 October (and copied to the other organizations) and will be discussed at the meeting of the

ISWGNA on 13 October in Paris. During this meeting the ISWGNA will also identify the issues arising from the country comments for consideration by the AEG. These issues will be added to the agenda of the AEG meeting of 12 - 14 November in Washington, DC.

The country comments for the remaining four draft chapters (chapters 21, 24, 28 and 29) and the two annexes (annex 3 and 4) will be discussed at the face-to-face meeting of the ISWGNA on 10 - 11 November in Washington, DC.

3. Future ISWGNA face-to-face meetings

The Project Manager confirmed the dates for the two scheduled ISWGNA face-to-face meetings on 13 October in Paris and on 10 - 11 November in Washington, DC to discuss the country comments for the draft chapters of Volume 2 and proposed that a third face-to-face meeting of the ISWGNA should be considered to discuss the final draft of Volume 2. The ISWGNA agreed to schedule the meeting for 15 - 16 December either in New York or Washington, DC. If no substantive issues remained unresolved during the final drafting of the chapters of Volume 2 this meeting will be cancelled.

4. AEG meeting/Luxembourg Recommendations (LRs)

The Project Manager informed the ISWGNA:NA that the ISWGNA:MG has confirmed 12 - 14 November as the date for the AEG meeting and 17 - 18 November as the date for the meeting of the High Level Group on National Accounts.

An announcement of the AEG meeting scheduled to be held on 12 - 14 November 2008 in Washington, DC will be sent by UNSD to the members of the AEG by cob 21 August.

The Project Manager further reported that the ISWGNA:MG will discuss issues related to the Luxembourg Recommendations during their next meeting 9 -12 September in Tunisia.

5. Next teleconference

The next teleconference is tentatively scheduled for 24 September 3 PM Luxembourg time.
