III. Overview of the various components and features of an integrated business and international statistics programme within a standardized statistical production process

This session will provide an introduction to the Guidelines on Integrated Economic Statistics. These Guidelines set out the institutional and regulatory environment perspective and the main components of the statistical production process for the efficient production of economic statistics such as standards and methods, statistical business registers, surveys and administrative sources, dissemination and communication methods. In order to operationalise these Guidelines, an overview is provided of the elements (i.e. governance and project management, business registers and frames, questionnaire design, collection, data processing, warehousing of the envisaged integrated business and international statistics programme using a standardized information management framework, i.e. the Generic Statistical Business Production Model (GSBPM).
