Draft programme of work of the United Nations Statistics Division for the biennium 2004-2005

Note by the Secretariat**

- 1. The draft programme of work in the field of statistics for the biennium 2004-2005, which is contained in the annex to the present note, is submitted for the consideration of the Statistical Commission in compliance with the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation. In section I, paragraph 7 of its resolution 52/220, the General Assembly stressed the role of the relevant intergovernmental bodies in the consideration of the narrative of the proposed programme budget, as well as the necessity for a timely presentation of their recommendations on the budget.
- 2. The draft programme of work has been formulated within the framework of subprogramme 5 (Statistics) of programme 7 (Economic and social affairs) of the revised medium-term plan for the period 2002-2005. It will be implemented by the Statistics Division of the Department of Economic and Social Affairs.
- 3. Efforts are currently under way to prepare baseline and target data for inclusion within the proposed programme budget for the biennium 2004-2005.
- 4. The Commission is invited to make comments and recommendations, as appropriate, on the draft programme of work. Those comments and recommendations will be taken into account by the Secretary-General, as appropriate, in finalizing his proposed programme budget for the biennium 2004-2005, which will be reviewed by the Committee for Programme and Coordination at its forty-third session, the Advisory Committee on Administrative and Budgetary Questions at its spring 2003 session and the General Assembly at its fifty-eighth session.

Draft programme of work for the biennium 2004-02005 for the Statistics Division, Department of Economic and Social Affairs

- 1. The programme of work has been formulated within the framework of subprogramme 5 (Statistics) of programme 7 (Economic and social affairs) of the revised medium-term plan for the period 2002-2005.
- The Statistics Division carries out its activities in collaboration and cooperation with other offices of the Secretariat, such as the Executive Office of the Secretary-General, in the preparation of the data for the annual millennium development goals progress report. In particular, the Division cooperates very closely with statistical divisions and units in the regional commissions, in the specialized agencies, in the United Nations funds and programmes, in a number of non-United Nations intergovernmental organizations and in countries. It acts as the secretariat of the Committee for the Coordination of Statistical Activities, which provides technical inputs into the work of the United Nations System Chief Executives Board for Coordination. In the context of its programme element of "statistical capacity-building", the Division also frequently cooperates with other international, interregional, regional and national organizations. In the context of methodological development work, the Division has close contacts with international professional associations, notably the International Statistical Institute, and with academic communities, and is working to strengthen that collaboration in specific programmes. In general, those types of collaboration and cooperation include joint projects, training and workshops with other agencies and developing countries, the preparation of reports, participation in meetings, briefings, technical and substantive support of inter-agency meetings, and the sharing of information and experience.

Objectives

To promote international comparability of statistics through the standardization of statistical methods, classifications and definitions used by national statistical offices and to reach international agreement on the use and usefulness of relevant concepts and methods.

Expected accomplishment(s)

Field projects: provision of technical services to member States and regional and interregional projects and training to assist developing countries and countries with economies in transition in strengthening national capabilities in the collection, processing and dissemination of statistics, and of advice and technical assistance on the scale of assessment methodology to other organization.

- ^b These outputs will need to support specific programmes and priorities for developing statistical capacity-building, such as censuses, surveys of various kinds, environment statistics, analytical reporting such as for millennium development goals indicators of various kinds, and collaboration with international funds, agencies and programmes in achieving coordinated national statistical programmes.
