Annotations

1. Election of officers

In accordance with rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council and past practices, the Statistical Commission, at the commencement of its first meeting of a regular session, shall elect, from among the representatives of its members, a Chairman, three Vice-Chairmen and a Rapporteur (the Bureau).

The Bureau serves for two years, as far as possible. This is achieved by electing the Bureau for a period of one year and re-electing those members of the Bureau who continue to be representatives to the Commission at the following session. The Bureau is elected based on the principle of equitable geographical distribution: a member of the Bureau is elected from each of the regions represented in the Commission.

2. Adoption of the agenda and other organizational matters

The items in the provisional agenda and the corresponding documentation were proposed by the Commission at its thirty-fifth session (New York, 2-5 March 2004). Some changes have been made, in consultation with the officers of the Commission. The proposed draft organization of work is before the Commission. The Commission is invited to adopt the agenda and organization of work for the session.

3. Follow-up to policy decisions of the Economic and Social Council: working methods of the Statistical Commission

The Commission will have before it the report of the Bureau of the Commission reporting on its review of the working methods of the Statistical Commission. The report covers the areas of agenda content and structure, time management, documentation, preparation of session report, participation in the session, politicization, and relation with the Economic and Social Council and other functional commissions. The report presents the decisions taken by the Bureau in order to improve the working methods. The Commission is invited to comment on the report.

4. Economic statistics

(a) Programme review: energy statistics

The Statistical Commission will have before it the report of Statistics Norway, which overviews the new needs for energy statistics and how they are satisfied by the conceptual and practical work undertaken by international, regional and specialized organizations. The Commission is invited to express its views on the findings, conclusions and recommendations for future work in this area.

(b) National accounts

The Commission will have before it the report of the Intersecretariat Working Group on National Accounts. The report includes a progress report on work completed in the updating of the System of National Accounts, 1993 (1993 SNA).² It covers the results of meetings of the Advisory Expert Group on National Accounts and other expert groups, summarizes the recommendations reached on a number of issues among the 44 issues selected for updating, and provides information on the global consultation mechanism, the governance structure, the funding situation and other aspects of the SNA updating project to be completed by 2008. The report summarizes the findings of a survey conducted by the United Nations Statistics Division, at the request of the Commission at its thirty-fifth session, to reveal and analyse the factors impeding the implementation of the 1993 SNA in developing countries. The Commission is invited to express its views on the status of the SNA updating, comment on the progress in understanding the factors impeding the implementation of the 1993 SNA and discuss possible solutions to improve the level, scope and pace of the 1993 SNA implementation in developing countries.

(c) Service statistics

5. Demographic and social statistics

(a) Population and housing censuses

The Commission will have before it the report of the Secretary-General summarizing activities completed in response to the actions taken by the Commission at its thirty-fifth session, including a draft resolution requesting the Secretary-General to proceed with the development of a 2010 World Population and Housing Census Programme recommending that States Members of the United Nations undertake to carry out population and housing censuses during the period 2005-2014; the formation of an international expert group to focus on critical issues related to planning the next round of population and housing censuses (2005-2014), and the establishment of draft terms of reference, outlining the role of the expert group, its process and the setting of priorities of work and outputs in relation to the 2010 World Population and Housing Census programme.

The report also presents conclusions and recommendations of the United Nations Symposium on Population and Housing Censuses (New York, 13 and 14 September 2004) and the Expert Group Meeting to Review Critical Issues Relevant to the Planning of the 2010 Round of Population and Housing Censuses (New York, 15-17 September 2004). The Commission is invited to express its views on the draft resolution, and on the terms of reference of the Expert Group, and to comment on the direction of the Expert Group's future work.

(b) Health statistics

The Commission will have before it a report of the World Health Organization (WHO) that addresses the recommendations made by the Commission at its thirty-fifth session and describes progress made by the Organization along those lines,

including regarding the formation of an intersecretariat working group on health statistics. The Commission is invited to comment on the progress made thus far by WHO with regard to the Commission's recommendations.

(c) Poverty statistics

7. Activities not classified by field

(a) Statistical capacity-building

The Commission will have before it the report of the Secretary-General containing a brief description of the current technical cooperation programmes of the United Nations Statistics Division and their funding mechanisms. Furthermore, the report describes new strategic priorities. The Commission is invited to comment on the technical cooperation programme of the Statistics Division.

The Commission will also have before it a report of the Partnership in Statistics for Development in the Twenty-first Century (PARIS 21) outlining how the National Strategy for the Development of Statistics (NSDS) provides a country with a strategy for strengthening statistical capacity across the entire national statistical system. The Strategy is a comprehensive and unified framework for continuous assessment of evolving user needs and priorities for statistics and for building the capacity needed to meet these needs in a more coordinated, synergistic and efficient manner. The Commission is invited to comment on the NSDS approach.

(b) International economic and social classifications

(c) Indicators for follow-up to United Nations conferences

It also describes the 2004-2005 international work plan for Millennium Development Goals indicators, the planned outputs in relation to the series of international events planned in 2005 leading up to the expected follow-up Millennium Summit in September 2005 and the interrelation between international and national work on Millennium Development Goals indicators. This item is for information and the Commission is invited to take note of the report.

(d) Presentation of statistical data and metadata

Following the presentation of an outline for a proposed "Data and metadata reporting and presentation handbook" to the Commission in 2004, the Organization for Economic Cooperation and Development (OECD) prepared a draft version of the handbook, which the Commission will have before it as a background document. The draft incorporates comments and suggestions received from international organizations and national agencies in both OECD and non-OECD countries over the last 12 months. It should be emphasized that the format of the handbook, among other features, allows for the incorporation of emerging issues on data presentation as they arise in future. OECD is inviting countries to provide final comments to them. This item is for information and the Commission is invited to take note of the report.

(e) Common open standards for the exchange and sharing of data and metadata
