
ADMINISTRATIVE ARRANGEMENTS FOR THE MEETINGS

The 44th session of the United Nations Statistical Commission will be held from 26 February – 1 March 2013 at the United Nations Headquarters. The opening session will start at 10:30 a.m. and on subsequent days the meeting will start at 10:00 a.m. Please enter the UN premises through the Visitor's Entrance located on First Avenue (between E. 45 & E. 46 Streets).

We would like to remind you that you will need to comply with the formality of requesting your Permanent Mission to the United Nations in New York to advise the Secretary-General in writing of your intention to participate in the meetings and provide the name(s) of all the members of your delegation. Once your mission has informed the Secretary-General, they will then request a grounds pass to the United Nations premises for you.

Working Language(s) of the meetings

The 44th session of the Statistical Commission will be conducted in Arabic, Chinese, English, French, Russian and Spanish and all official documentation will be in 6 UN official languages.

All the other meetings will be conducted in English only.

GENERAL INFORMATION

Immigration Requirements

Participants should contact relevant United States of America embassies or consulates on visa requirements, and obtain the appropriate entry permit where necessary as early as possible.

The official notification letter is generally sufficient to be used as supporting documentation for visa (entry permit) request. Please contact us, should there be any issues with obtaining visa for the purpose of attending this event.

Money

The majority of ATMs (Automated Teller Machines) networks in New York City are linked to a network that most likely includes your bank at home. Hence, you would be able to make a cash withdrawal if you have a cash card (ATM Card) that offers **Cirrus** (<u>http://www.mastercard.com/atmlocator/index.jsp</u>) or **Plus** (<u>www.visa.com/atm</u>), the 2 most popular networks. There are fees and daily limits associated with withdrawing money using the above networks. Please check with your bank at home for this information.

Traveller's cheques are another good and safe alternative. Be sure to keep a record of their serial numbers, so you are ensured a refund in case they are lost or stolen. The 3 most popular traveller's cheque providers are **American Express** (American Express branches, <u>www.americanexpress.com</u>), **Visa** (Citibank branches), **MasterCard** (Thomas Cook Currency Services).

Credit Cards are a convenient way to pay for transactions. **American Express**, **Visa** and **Master Card** (among others) are accepted virtually everywhere in New York.

<u>Hotels</u>

Arrangements for hotels need to be made by individual participants (or their Mission) at hotels of their own choice. A list of hotel in the vicinity of the UN is provided below.

Please note that a credit card is normally required to make a reservation, participants should plan accordingly.

Participants can contact hotels directly and make reservations. Participants can also contact your country's Mission to the United Nations which may be able to assist you (contact details for missions can be found at <u>http://www.un.org/en/members/</u>). Participants should make the necessary reservations at least one week prior to the event.

Subway and buses (<u>http://www.mta.info/</u>) are a convenient way to get around Manhattan. **Metro Card** valid for subway and bus can be purchased at subway stations.

- <u>Single:</u> trip fare is \$2.50.
- <u>7-Day Metro Card</u> costs \$29.00 (unlimited ride for one week for one person)

Yellow Cab Taxis are readily available around Manhattan. Taxis are a safe alternative for late night travel when train and buses can be few and far between. It is advisable not to take taxis without meters (illegal taxi), as they could charge exorbitant fares. Taxi fees can be paid in cash or credit card, however, if paying in cash, it is a good idea to have small bills because taxi drivers usually cannot change anything higher than \$20. While taxis are relatively expensive for a single person, they are more affordable with 3 or more riders. The rates for taxis are as follows:

Initial fare......\$2.50 Each 1/5 mile (4 blocks)....\$0.50 Each 1 minute idle......\$0.40 Night surcharge......\$0.50 (after 8:00 p.m. until 6:00 a.m.) Additional riders......FREE

Pay only what's on the meter, plus a 15-20 per cent gratuity. On all trips within New York City, any bridge and tunnel tolls to the destination shall be paid by the passenger, who shall be so informed before the start of the trip. On all trips within the City of New York, return tolls shall not be charged except for trips over the Cross Bay Veterans, Marine Parkway-Gil Hodges Memorial, and Verrazano Narrows Bridges. On trips beyond the City of New York, all necessary tolls to and from the destination shall be paid by the passenger. There are additional charges for crossings outside the metropolitan area and New Jersey. Passengers are required to pay one way.





Annotations

1. Election of officers

In accordance with rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council and past practices, the Statistical Commission, at the commencement of its first meeting at a regular session, shall elect, from among the representatives of its members, a Chair, three Vice-Chairs and a Rapporteur (the Bureau).

The Bureau serves for two years, to the extent possible. This is achieved by electing the Bureau for a period of one year and re-electing those members of the Bureau who continue to be representatives to the Commission at the following session. The Bureau is elected on the basis of the principle of equitable geographical distribution; a member of the Bureau is elected from each of the regions represented on the Commission.

2. Adoption of the agenda and other organizational matters

The items on the provisional agenda and the corresponding documentation were proposed by the Commission at its forty-third session (New York, 28 February-

2 March 2012)¹ and were adopted by the Economic and Social Council in its decision 2012/230. The Bureau of the Commission has subsequently approved some changes. The proposed draft organization of work for the session is before the Commission. The Commission may wish to adopt the agenda and organization of work for its forty-fourth session.

3. Items for discussion and decision

(a) **Programme review: developing a statistical-spatial framework in national** statistical systems

The Commission will have before it the programme review of the development of a statistical-spatial framework in national statistical systems, prepared by the Australian Bureau of Statistics. The report is based on the responses to a global survey of national statistical offices, assessing the current linkages of geospatial information and statistics as well as the policy context and the potential future developments. The report describes the varying degrees of integration of geospatial information and statistics in a variety of countries. In addition, it presents a review and analysis of users' needs and explores areas where the value and usability of official statistics could be enhanced by applying geospatial attributes. The report makes recommendations on ways to achieve the linking of statistical information to a location at national and international levels. The Commission is invited to express its views on the importance of linking statistics and geospatial information; in particular the Commission is asked to decide on a possible programme of future work in the area, on the basis of the recommendations contained in the programme review.

(b) Implementation of the Fundamental Principles of Official Statistics

The Commission has before it the report of the Friends of the Chair group on the Fundamental Principles of Official Statistics. The group was established at the fortysecond session of the Commission. The report contains a new draft preamble, the main findings of an implementation survey conducted in 2012, a road map for taking the Fundamental Principles to the Economic and Social Council and some preliminary suggestions on ways in which the Principles can be reenforced. The Commission also has before it a background document with more detailed findings of the implementation survey.

The Commission is requested to amend and adopt a new preamble, discuss the findings of the implementation survey as presented in the main document and background document, comment on the road map and provide guidance on further work on the reenforcement of the Principles.

(c) National accounts

The Commission will have before it the report of the Intersecretariat Working Group on National Accounts. The report provides information on the progress of the global and regional implementation programmes for the 2008 System of National Accounts (2008 SNA) and supporting economic statistics. The report describes the activities and the outcome of the meeting of the Advisory Expert Group on National Accounts. The report also provides an update on the finalization and publication of translations of the 2008 SNA in the other official languages of the United Nations. The Commission is requested to express its views and provide guidance on the elements of the programme of work of the Working Group.

(d) Environmental-economic accounting

The Commission will have before it the report of the Committee of Experts on Environmental-Economic Accounting. The report describes the progress made in the programme of work of the Committee, with a particular focus on activities related to the revision of the System of Environmental-Economic Accounting (SEEA). The report includes for the consideration of the Commission the implementation strategy of the SEEA central framework and covers the ongoing efforts to promote it in international forums as a statistical framework for the environment and its relationship with the economy. The report also presents for consideration the SEEA experimental ecosystem accounts and the SEEA extensions and applications, submitted as background documents. It describes the outcome of the international seminar on linking ecosystems and ecosystem services to economic and human activity. The report also provides information on the finalization of the System of Environmental-Economic Accounting for Energy (SEEA-Energy), submitted as a background document for adoption. The Commission is invited to adopt SEEA-Energy and express its views on the progress of the work of the Committee.

(e) Environment statistics

The Commission will have before it the report of the Secretary-General on the revision of the Framework for the Development of Environment Statistics and three background documents containing the final chapters of the Framework, a plan for its implementation (Blueprint for Action) and a detailed analysis of the feedback received in the consultation process. The report elaborates on the revision process that started in 2010 and presents the outcome of the global consultation on the Framework as well as of the pilot tests of the core set of environment statistics that were carried out by 25 countries. It describes the changes that were implemented in the final document on the basis of the feedback received from the two exercises. It gives a detailed description of the revised Framework that is a multi-purpose organizing framework for environment statistics, and introduces a blueprint for putting the revised Framework to work. The Commission is invited to endorse the revised Framework and the Blueprint for Action.

(f) International trade statistics

The report of the Secretary-General describes the current policy needs for statistics on international trade, the value added of trade, global value chains and economic interdependencies. It outlines new developments in international merchandise trade statistics, statistics of international trade in services and the corresponding trade classifications, and presents a feasibility study on proposed future goals for international trade statistics. Finally, the report indicates some new initiatives in linking trade and business statistics and estimating trade in value added, and highlights some of the work of the many task teams in this area. The report concludes that a measurement framework covering international trade and economic globalization is needed and proposes that such a framework be developed. The Commission may wish to express its views on this proposal.

(g) Agricultural statistics

In accordance with the mandate given at its forty-third session, the Commission will have before it the report of the Global Steering Committee presenting the key activities undertaken to implement the Global Strategy to Improve Agricultural and Rural Statistics. The report includes a description of progress made in the following:

- Establishing the global office as well as the global governing bodies
- Defining the administrative arrangements of the Trust Fund for Statistical Capacity-Building
- Developing monitoring and evaluation mechanisms
- Undertaking resource mobilization initiatives

- Establishing partnership arrangements with regional organizations and regional development banks
- Developing regional action plans

In addition, the report presents the initial methodological outputs which will underpin the technical assistance and training activities aimed at strengthening the capacity of national agricultural statistical systems.

The Commission is invited to take note of the progress report, and to provide further guidance to the Global Steering Committee on the implementation process of the Global Strategy.

(h) International Comparison Programme

The Commission will have before it the report of the World Bank on the International Comparison Programme (ICP). The report, prepared by the World Bank on behalf of the Executive Board of the International Comparison Programme, outlines the status of implementation of the 2011 round. The report describes the following: (i) governance, capacity-building and outreach activities undertaken in 2012; (ii) the status of country participation, funding, risk assessment and the timetable; (iii) progress in the implementation of ICP price and National Accounts activities; (iv) the 2011 ICP data access policy; and (v) some thoughts on the future of ICP. The Commission may wish to review the progress made with respect to the implementation of the 2011 round and express its views on the workplan leading to the publication of the final results.

(i) Gender statistics

The Commission will have before it the report of the Secretary-General on gender statistics, which describes the recent work undertaken by the Statistics Division and the Inter-agency and Expert Group on Gender Statistics under the global gender statistics programme. The report: (i) summarizes the results of the global review of gender statistics programmes in countries; (ii) presents the new guidelines for the production of statistics on violence against women and other forthcoming methodological work on gender statistics; and (iii) highlights the major outcomes of the fourth Global Forum on Gender Statistics. It also provides an update on the minimum set of gender indicators established by the Inter-agency and Expert Group on Gender Statistics Division and the Inter-agency and Expert Group on Gender Statistics to strengthen the global gender statistics programme, including a new project on evidence and data for gender equality (EDGE), executed jointly with the United Nations Entity for Gender Equality and the Empowerment of Women

(UN-Women). The Commission is invited to comment on the ongoing work on gender statistics, with a view to identifying future priority areas.

(j) Crime statistics

The Commission will have before it the joint report of the National Institute of Statistics and Geography of Mexico and the United Nations Office on Drugs and Crime (UNODC) on a road map to improve crime statistics. Building on the report presented by the Institute at the forty-third session of the United Nations Statistical Commission, this report recalls the main challenges to the collection, production and dissemination of crime statistics at the national and international levels, and it proposes a number of activities that need to be conducted as a matter of priority. Such activities aim to address existing methodological challenges, including quantifying "difficult-to-measure" crimes (such as organized crime and corruption), improving the capacity to produce crime data and coordination at the national level, and fostering the quality and availability of data and statistical analysis relating to crime at the international level. Specific attention is devoted to the development for statistical purposes of an international classification on crime and on ways to promote the implementation of victimization surveys. The Commission is requested to discuss the proposed road map and provide guidance on its implementation.

BACKGROUND INFORMATION ON THE STATISTICAL COMMISSION AND PRACTICAL INFORMATION ON ITS FUNCTIONING¹

<u>Origin</u>

1. The Statistical Commission's nuclear (establishment) session was held in 1946, and its first session, in 1947.

Terms of reference ²

2. On the basis of the recommendations of its nuclear session, the Statistical Commission was established and given terms of reference by the Economic and Social Council. The terms of reference as set forth in Economic and Social Council resolution 1566 (L) of 3 May 1971, reaffirming its resolution 8 (I) of 16 February 1946, as amended by resolution 8 (II) of 21 June 1946, state that the Commission shall assist the Council:

"(a) In promoting the development of national statistics and the improvement of their comparability;

"(b) In the coordination of the statistical work of specialized agencies;

"(c) In the development of the central statistical services of the Secretariat;

"(d) In advising the organs of the United Nations on general questions relating to the collection, analysis and dissemination of statistical information;

"(e) In promoting the improvement of statistics and statistical methods generally."

3. In resolution 1566 (L), the Council stressed the importance of the Commission's coordination function and the need to achieve an integrated system in the collection, processing and dissemination of international statistics; recognized the interest of the Statistical Commission and the Statistical Division in matters related to the use of computers in the United Nations system; and requested the Secretary-General to undertake, in cooperation with

the specialized agencies, concerted action to assist the developing countries in strengthening their statistical systems.

Items considered

4. The Statistical Commission considers special issues of concern in international statistical development, methodological issues, coordination and integration of international statistical programmes, support of technical cooperation activities in statistics and organizational matters. Within the terms of the above resolutions, there is flexibility for the Commission to adjust, where necessary, its priorities and methods to meet new requirements and maintain a balance between matters of current concern and the longer-term development aspects of the statistical system.

<u>Reporting</u>

5. The Commission submits a report on each session to the Economic and Social Council. The report contains an account of the Commission's proceedings and the action taken on each agenda item. The Commission may submit to the Council, in the form of draft resolutions, recommendations to States Members of the United Nations, the Secretary-General or the specialized agencies. Any financial implications of the draft resolutions must be brought to the attention of the Commission and the Council before being adopted and must subsequently be approved by the organs of the United Nations having the necessary authority.

Membership

6. The Commission consists of one member from each of 24 member countries of the United Nations elected by the United Nations Economic and Social Council on the basis of an equitable geographical distribution according to the following pattern:

- (a) Five members from African States;
- (b) Four members from Asian States;
- (c) Four members from Eastern European States;
- (d) Four members from Latin American and Caribbean States;
- (e) Seven members from Western European and other States.
- 7. See Annex II for current membership of the Commission.

Term of office

8. The term of office of members is four years.

Frequency of meetings

9. In July 1999 the Economic and Social Council decided that the Commission should meet annually for four days each session, starting in the year 2000.

Officers of the Commission

The officers are the Chairman, 3 Vice-chairmen and the 10. Rapporteur; they are also referred to as the Bureau. In between sessions of the Commission, members of the Commission, the Bureau and the Secretariat consult on the election of the Bureau for the upcoming session. A Bureau is elected for a one year period with the expectation that they will be re-elected to a second one year term if available. Nominations are made by member(s) of the Elections are held at the beginning of a session. Commission. In practice elections have been by acclamation. At its thirtieth session the Commission decided to give the officers of the Commission (if necessary complemented by any others whose participation is deemed useful by the Chairman) more of a steering role.

Secretariat support and other participants

11. The sessions of the Statistical Commission are substantively serviced by the United Nations Statistics Division (UNSD) and attended by the regional commissions, other United Nations organizations, specialized agencies and related organizations, and non-United Nations international organizations active in international statistical work.

Dates of the meeting and notification to countries

12. Dates for the sessions of the Commission are proposed by the Commission. The dates are fixed by the Economic and Social Council. The session must be held eight weeks before the Economic and Social Council session which will consider the report of the Commission; the Secretariat normally proposes dates to the Commission taking account of this requirement and of the availability of conference servicing facilities. The Secretariat notifies the permanent mission of each of the member countries of the Commission of the dates, and invites them to notify the Secretariat who their representative (and any other delegation members) will be.

The agenda and documentation of the Commission

13. Prior to each session of the Commission, the Secretariat prepares a list of items that have previously been established for consideration by the Commission at that session; the list may be based on requests of the Commission at previous sessions, or of other intergovernmental bodies such as the General Assembly and Economic and Social Council and reflect the multi-year programme of work that the Commission develops. During each session the Commission may decide to add additional items to the agenda, based on documentation and discussion at the session, and priorities or problems. At the end of each session the Secretariat provides an updated list reflecting all the decisions and requests, and on the basis of that list, the Commission proposes to the Economic and Social Council, the provisional agenda and documentation for the next session (subject to further review by the Commission's Bureau). The Economic and Social Council considers the proposal at its substantive session (June/July immediately following the Commission session) and approves it. It is finalized, and after review by the Bureau, distributed by the Secretariat in advance of the Commission session. Documentation may be requested by the Commission, from the Secretariat, other United Nations bodies or specialized agencies, intergovernmental organizations or nongovernmental organizations active in statistical work, a country or an ad hoc group of countries/organizations.

14. Documents are limited to 16 pages in length and where possible are well below this limit. They are to be concise and action oriented. They are made available in the six official languages of the Commission (Arabic, Chinese, English, French, Russian and Spanish). They are to be issued well in advance of the session. Documents are made available on the UNSD Home Page at <u>http://unstats.un.org/unsd/statcom/commission.htm;</u> they are also distributed by airmail/diplomatic pouch.

15. Background documents are also frequently available to the Commission. These contain information from participants and the Secretariat which are of potential interest to the Commission. These documents require clearance by the Secretary of the Commission prior to distribution and adequate copies must be made available by the authors. They can be in any official language(s) and will be circulated only in the language(s) provided by the author. Limited photocopy support can be offered by the Secretariat. The provision of information in the form of documents or background papers is preferred by the Commission in place of lengthy oral statements.

Kinds of interventions that are made

16. Members and observers are encouraged to participate fully in the deliberations of the Commission. The Commission has increasingly called for more focused, issue-oriented and succinct interventions by those participating in the discussions. It has also emphasized that detailed expositions of methodology or the reporting of routine activities should not be presented orally but rather be made available as written material as background documents which can be made available to participants. <u>Travel arrangements; air ticket; schedule of sessions; Conference</u> <u>room; admission to the United Nations building</u>

17. Travel, but not subsistence/hotel expenses, for one representative of each member state of the Commission is paid for by the United Nations according to normal United Nations travel standards. Representatives may make their own travel arrangements and claim re-imbursement from the United Nations. ³ Alternatively, the United Nations is prepared, upon request, to make the necessary arrangements for issuance and payment of the travel tickets. In those cases, Permanent Missions are requested to provide to the Secretariat an address and the telephone number where the representative can be contacted.

18. The first meeting of the Commission sessions normally starts on a Tuesday, at 10:30 a.m. On subsequent days the meetings start at 10:00 a.m. Normally two sessions are held each day; 10:00 a.m. to 1:00 p.m. and 3:00 p.m. to 6:00 p.m. The conference room number where the meetings will be held is available near the entrance to the United Nations Headquarters. Grounds passes for admission to the United Nations building are organized by the Mission of each country to the United Nations.

Annex I

Some notes on the terms of reference of the Statistical Commission

In formulating the terms of reference, the nuclear Commission had certain concepts in mind, as indicated in the following excerpt from its report:

"(a) Promoting the development of national statistics and the improvement of their comparability.

"This task will be performed in close collaboration with the statistical unit of the United Nations Secretariat. It is a continuing function which requires constant attention ... The Commission should be in a position to advise national governments and the Secretariat on problems which will arise ... The Commission may also establish committees or subcommissions in various statistical fields.

"(b) Coordination of the Statistical work of specialized agencies.

"The Commission should advise the Council concerning agreements to be reached with the specialized agencies defining their respective areas of statistical activity ... The coordination process is an operating function to be performed by the Secretariat within the framework established by recommendations of the Commission.

"Initially, the Commission contemplates the adoption of a general plan which will recognize the primary statistical interests of each specialized agency. The collection by the latter of data in its primary field must be without prejudice, however, to the right of the United Nations to concern itself with statistics in the same subject area so far as they may be essential for its own purposes or for the instances, when the data are basic to the work of several specialized agencies, provision should be made for their collection centrally by the statistical unit of the Secretariat ... To facilitate cooperative arrangements among the specialized agencies and the Secretariat, the Commission recommends the establishment of a Statistical Coordinating Committee ...

"(c) Development of the central statistical services of the Secretariat.

"It is important that there be one focal point for statistical activities in the Secretariat. The Commission is in accord with the recommendations of the Preparatory Commission that the statistical work of the constituent organs of the United Nations be centralized in a statistical unit in the Department of Economic Affairs, which would also undertake work for the other Departments of the Secretariat ...

"(d) Advising the organs of the United Nations on general questions relating to the collection, interpretation and dissemination of statistical information.

"This function implies that the Statistical Commission will serve as a technical advisory body, not only to the Economic and Social Council and the statistical unit of the Secretariat, but also all organs of the United Nations ...

"(e) Promoting the improvement of statistics and statistical methods generally.

"This function is very broad and should cover adequately any work which the Commission may undertake through the promotion of uniform standards as to kinds of data to be collected, the methods of their collection, and their form of presentation. This will be accomplished in part through the work of committees or sub-commissions to be designated for particular fields as the needs arise. Improvement will also be accomplished through the current work of the Secretariat in its dealings with national governments on statistical matters. It is essential that the Commission and the Secretariat play an active role in promoting continuously the adoption and use of the most valid and reliable statistics and statistical methods ... To further this end, the Commission recognizes the need to provide opportunities for ... education and training in statistics."

RULES OF PROCEDURE OF THE FUNCTIONAL COMMISSIONS¹ OF THE ECONOMIC AND SOCIAL COUNCIL

I. SESSIONS

Number of sessions

Rule 1

Unless the Economic and Social Council (the Council) decides otherwise, the functional commission (the commission) shall hold sessions biennially.

Date of opening

Rule 2

1. The date of opening of each session of the commission shall be fixed by the Council, taking into account any recommendation of the commission and in consultation with the Secretary-General.

2. In exceptional cases, the date of opening of a session may be altered by the Secretary-General in consultation with the Committee on Conferences of the General Assembly and, whenever practicable, with the Chairman of the commission.

Place of sessions

Rule 3

Sessions shall be held at the Headquarters of the United Nations unless another place is designated by the Council, taking into account any recommendation of the commission and in consultation with the Secretary-General.

Notification of opening date of sessions

Rule 4

The Secretary-General shall notify the members of the commission and also, in the case of the Commission on Narcotic Drugs, the President of the International Narcotics Control Board, of the date and place of the first meeting of each session at least six weeks in advance.

Drawing up of the provisional agenda

Rule 5

1. The Secretary-General, in consultation with the Chairman whenever possible, shall draw up the provisional agenda for each session.

2. The provisional agenda shall include all items required by these rules as well as items proposed by:

(a) The commission at a previous session;

(b) The General Assembly, the Economic and Social Council, the Security Council or the Trusteeship Council;

(c) A Member of the United Nations;

(d) A sub-commission of the commission;

- (e) The Chairman;
- (f) The Secretary-General;
- (g) A specialized agency,² subject to rule 72;

(h) A non-governmental organization, subject to paragraph 4 of this rule.

3. Items proposed for inclusion in the provisional agenda pursuant to subparagraphs (c), (e), (f), (g) and (h) of paragraph 2 shall be submitted with basic documents in sufficient time to reach the Secretary-General not less than seven weeks before the first meeting of each session.

4. (i) Non-governmental organizations in category I may propose items for the provisional agenda of the commission provided that:

(a) An organization that intends to propose such an item shall inform the Secretary-General at least nine weeks before the commencement of the session, and before formally proposing an item shall give due consideration to any comments the secretariat may make.

(b) The proposal shall be formally submitted with basic documents not less than seven weeks before the commencement of the session.

(ii) An item proposed in accordance with the provisions of this paragraph shall be included in the agenda of the commission if it is adopted by a two-thirds majority of the members present and voting.

² When the term "specialized agencies" is used in these rules, it refers to specialized agencies brought into relationship with the United Nations; it also includes the International Atomic Energy Agency.



Communication of the provisional agenda

Rule 6

1. The Secretary-General shall, not less than six weeks before the opening of the session, communicate the provisional agenda for a session of the commission and transmit the basic documents related to each item appearing thereon to the Members of the United Nations, the President of the Security Council, the President of the Trusteeship Council, the specialized agencies, the intergovernmental organizations referred to in rule 74, the non-governmental organizations³ in category I or II or on the Roster and also, in the case of the Commission on Narcotic Drugs, to the President of the International Narcotics Control Board.

2. In exceptional circumstances, the Secretary-General may, for reasons to be specified in writing, transmit the basic documentation relating to items on the provisional agenda not less than four weeks before the opening of the session.

Adoption of the agenda

Rule 7

The commission shall at the beginning of each session, after the election of its officers, in accordance with rule 15, adopt the agenda for that session on the basis of the provisional agenda referred to in rule 5.

Revision of the agenda

Rule 8

During a session, the commission may revise the agenda by adding, deleting, deferring or amending items. Only important and urgent items shall be added to the agenda during the session.

Draft provisional agenda for subsequent session

Rule 9

At each session of the commission, the Secretary-General shall submit a draft provisional agenda for the commission's subsequent session, indicating in respect of each agenda item the documents to be submitted under that item and the legislative authority for their preparation, in order to enable the commission to consider the documents from the point of view of their contribution to the work of the commission and of their urgency and relevance in the light of the current situation.

III. REPRESENTATION

Terms of office of members

Rule 10

Unless the Council decides otherwise, the term of office of members of the commission shall begin on 1 January following the election of the States concerned to membership of the commission and shall end on 31 December following the election of the States that are to succeed them as members of the commission.

Representatives

Rule 11

Each member of the commission shall, after consultation with the Secretary-General and subject to confirmation by the Council,⁴ designate a person to serve as its representative on the commission.

Rights of representatives pending confirmation⁴

Rule 12

A person designated as the representative of a member of the commission in accordance with rule 11 may, pending confirmation by the Council, participate in the work on the commission with the same rights as the other representatives on the commission.

Alternates⁴

Rule 13

1. Each member of the commission may, in consultation with the Secretary-General, designate an alternate representative to act in place of its representative at any meeting of the commission or, except as provided in paragraph 2 of this rule, of its subsidiary organs. When acting as representative, the alternate so designated shall have the same status as a representative, including the right to vote.

2. In the case of a subsidiary organ whose members are experts nominated by Governments serving in their individual capacity, if a member is unable to attend all or part of a session he may, with the consent of his Government and in consultation with the Secretary-General, designate an alternate to act in his place during his absence. Such an alternate shall have the same status as the expert serving as member on the subsidiary organ concerned, including the right to vote.

Advisers

Rule 14

The representative of a member of the commission may be accompanied by such advisers as may be required.

IV. OFFICERS

Election of officers

Rule 15

At the commencement of its first meeting of a regular session the commission shall elect, from among the representatives of its members, a Chairman, one or more Vice-Chairmen and such other officers as may be required.

Term of office

Rule 16

The officers of the commission shall, subject to rule 19, hold office until their successors are elected and shall be eligible for re-election.

Acting Chairman

Rule 17

1. If the Chairman finds it necessary to be absent during a meeting or any part thereof, he shall designate one of the Vice-Chairmen to take his place.

2. If the Chairman ceases to hold office pursuant to rule 19, the remaining officers shall designate one of the Vice-Chairmen to take his place until the election of a new Chairman.

Powers of the Acting Chairman

Rule 18

A Vice-Chairman acting as Chairman shall have the powers and duties of the Chairman.

Replacement of the Chairman or other officers

Rule 19

If the Chairman or any other officer is unable to carry out his functions or ceases to be a representative of a member of the commission or if the State of which he is a representative ceases to be a member of the commission he shall cease to hold such office and a new officer shall be elected for the unexpired term.

Voting rights of the Chairman⁵

Rule 20

The Chairman, or a Vice-Chairman acting as Chairman, may empower his alternate designated in accordance with rule 13 to participate in the proceedings and vote in the commission. In this case, the Chairman or Acting Chairman shall not participate in the proceedings except in his capacity as presiding officer of the commission.

V. SUBSIDIARY ORGANS

Establishment of committees and working groups

Rule 21

1. During a session, the commission, in consultation with the Secretary-General, may set up such committees or working groups composed of members of the commission as are deemed necessary and refer to them any questions on the agenda for study and report.

2. With the prior approval of the Council and in agreement with the Secretary-General such committees or working groups may be authorized to sit while the commission is not in session.

3. The members of committees or working groups of the commission shall be nominated by the Chairman, subject to approval of the commission.

Establishment of sub-commissions

Rule 22

1. The commission shall set up only such sub-commissions as may be authorized by the Council.

2. Unless otherwise determined by the Council, the commission shall determine the functions and composition of each sub-commission.

Officers

Rule 23

Unless the commission decides otherwise, its subsidiary organs shall elect their own officers.

⁵ Not applicable in the case of a subsidiary organ which is composed of experts serving in their individual capacity.



Rules of procedure

Rule 24

The rules of procedure of the commission shall apply to the proceedings of its subsidiary organs in so far as they are applicable.

VI. SECRETARIAT

Duties of the Secretary-General

Rule 25

1. The Secretary-General shall act in that capacity in all meetings of the commission. He may designate a member of the Secretariat to act as his representative.

2. He shall provide and direct the staff required by the commission and be responsible for all the arrangements that may be necessary for its meetings.

3. He shall keep the members of the commission informed of any questions that may be brought before it for consideration.

Duties of the Secretariat

Rule 26

The Secretariat shall:

(a) Interpret speeches made at meetings;

(b) Receive, translate and circulate documents;

(c) Print, publish and circulate as appropriate the records of the sessions, the resolutions of the commission and the required documentation;

(d) Have custody of the documents in the archives; and

(e) Generally perform all other work that may be required.

Statements by the Secretariat

Rule 27

The Secretary-General or his representative may, subject to rule 43, make oral as well as written statements to the commission concerning any question under consideration.

Estimates of expenditure

Rule 28

1. Before a proposal involving the expenditure of United Nations funds is approved by the commission, the Secretary-General shall prepare and provide to the commission an estimate of the programme budget implications of implementing the proposal. The Chairman shall draw attention to that estimate and invite discussion on it when the proposal is considered by the commission.

2. Any programme budget proposal recommended by the commission to the Council for its approval must be stated in terms of the objectives to be achieved.

VII. LANGUAGES

Official and working languages

Rule 29

Arabic, Chinese, English, French, Russian and Spanish shall be the official languages, and English, French and Spanish the working languages of the commission.

Interpretation

Rule 30

1. Speeches made in an official language shall be interpreted into the other official languages.

2. A speaker may speak in a language other than an official language if he provides for interpretation into one of the official languages. Interpretation into the other official languages by the interpreters of the Secretariat may be based on the interpretation given in the first such language.

Languages of records

Rule 31

Records shall be drawn up in the working languages. A translation of the whole or part of any record into any of the other official languages shall be furnished if requested by a representative.

Languages of resolutions and other formal decisions

Rule 32

All resolutions, recommendations and other formal decisions of the commission shall be made available in the official languages.

VIII. RECORDS AND REPORTS

Sound recordings of meetings

Rule 33

Sound recordings of meetings of the commission shall be made and kept by the secretariat. Such recordings may also be made and kept of the meetings of committees, working groups and sub-commissions if so decided by the commission.

Summary records of meetings

Rule 34

No summary records of meetings of the commission or any subsidiary organs shall be provided unless these have been specifically authorized by the Council.

Records of public meetings

Rule 35

1. Summary records of the public meetings of the commission and its subsidiary organs, where authorized and required, shall be prepared by the Secretariat. They shall be distributed as soon as possible to all members of the commission or of the organ concerned, and to any other participants in the meeting, who may, within one week of their receipt, submit corrections to the Secretariat; in special circumstances, the presiding officer may, in consultation with the Secretary-General, extend the time for submitting corrections. Any disagreement concerning such corrections shall be decided by the presiding officer of the body to which the record relates, after consulting, where necessary, the sound recordings of the proceedings. Corrections will be consolidated in a single corrigendum to be issued after the end of the session.

2. The summary records and the consolidated corrigendum thereto shall be distributed promptly to the Members of the United Nations and to the specialized agencies. On publication, these records may be consulted by the public.

Records of private meetings

Rule 36

The records of private meetings of the commission shall be distributed promptly to the members of the commission and to any other participants in these meetings. They shall be made available to other Members of the United Nations upon decision of the commission. They may be made public at such time and under such conditions as the commission may decide.

Reports to the Council

Rule 37

The commission shall submit to the Council a report, which shall normally not exceed thirty-two pages, on the work of each session containing a concise summary of recommendations and a statement of issues requiring action by the Council. It shall as far as practicable frame its recommendations and resolutions in the form of drafts for approval by the Council.

Communication of formal decisions and reports

Rule 38

As soon as possible, the text of the formal decisions and reports adopted by the commission shall be distributed to all members of the commission and to any other participants in the session. The printed text of such decisions and reports shall be distributed as soon as possible after the close of the session to the Members of the United Nations, to the specialized agencies, to the intergovernmental organizations referred to in rule 74 and to the concerned non-governmental organizations in category I or II or on the Roster.

IX. PUBLIC OR PRIVATE MEETINGS

General principle

Rule 39

Unless the commission decides otherwise its meetings shall be held in public.

X. CONDUCT OF BUSINESS

Quorum

Rule 40

A majority of the representatives of members of the commission shall constitute a quorum.

General powers of the Chairman

Rule 41

1. In addition to exercising the powers conferred upon him elsewhere by these rules, the Chairman shall declare the opening and closing of each

meeting of the commission, direct the discussions, ensure observance of these rules, accord the right to speak, put questions to the vote and announce decisions. The Chairman, subject to these rules, shall have complete control of the proceedings of the commission and over the maintenance of order at its meetings. He shall rule on points of order. He may propose to the commission the closure of the list of speakers, a limitation on the time to be allowed to speakers and on the number of times the representative of each member may speak on an item, the adjournment or closure of the debate, and the suspension or adjournment of a meeting.

2. The Chairman, in the exercise of his functions, remains under the authority of the commission.

Points of order

Rule 42

1. During the discussion of any matter, a representative may at any time raise a point of order, which shall be decided immediately by the Chairman in accordance with these rules. A representative may appeal against the ruling of the Chairman. The appeal shall be immediately put to the vote, and the ruling of the Chairman shall stand unless overruled by a majority of the members present and voting.

2. A representative may not, in raising a point of order, speak on the substance of the matter under discussion.

Speeches

Rule 43

1. No one may address the commission without having previously obtained the permission of the Chairman. Subject to rules 42, 45 and 48 to 50, the Chairman shall call upon speakers in the order in which they signify their desire to speak.

2. Debate shall be confined to the question before the commission and the Chairman may call a speaker to order if his remarks are not relevant to the subject under discussion.

3. The commission may limit the time allowed to speakers and the number of times the representative of each member may speak on any question; permission to speak on a motion to set such limits shall be accorded only to two representatives favouring and to two opposing such limits, after which the motion shall be put to the vote immediately. Interventions on procedural questions shall not exceed five minutes unless the commission decides otherwise. When debate is limited and a speaker exceeds the allotted time, the Chairman shall call him to order without delay.

Closing of list of speakers

Rule 44

During the course of a debate the Chairman may announce the list of speakers and, with the consent of the commission, declare the list closed. When there are no more speakers, the Chairman shall, with the consent of the commission, declare the debate closed. Such closure shall have the same effect as closure by decision of the commission.

Right of reply

Rule 45

The right of reply shall be accorded by the Chairman to the representative of any member who requests it. Representatives should attempt, in exercising, this right, to be as brief as possible and preferably to deliver their statements at the end of the meeting at which this right is requested.

Congratulations

Rule 46

Congratulations to the newly elected officers shall be expressed only by the outgoing Chairman or a member of his delegation, or by a representative designated by the outgoing Chairman.

Condolences

Rule 47

Condolences shall be expressed solely by the Chairman on behalf of all members. The Chairman, with the agreement of the commission, may dispatch a message on behalf of all members of the commission.

Suspension or adjournment of the meeting

Rule 48

During the discussion of any matter, a representative may at any time move the suspension or the adjournment of the meeting. No discussion on such motions shall be permitted, and they shall be put to the vote immediately.

Adjournment of debate

Rule 49

A representative may at any time move the adjournment of the debate on the item under discussion. Permission to speak on the motion shall be accorded only to two representatives favouring and to two opposing the adjournment, after which the motion shall be put to the vote immediately.

Closure of debate

Rule 50

A representative may at any time move the closure of the debate on the item under discussion, whether or not any other representative has signified his wish to speak. Permission to speak on the motion shall be accorded only to two representatives opposing the closure, after which the motion shall be put to the vote immediately.

Order of motions

Rule 51

Subject to rule 42, the motions indicated below shall have precedence in the following order over all proposals or other motions before the meeting:

- (a) To suspend the meeting;
- (b) To adjourn the meeting;
- (c) To adjourn the debate on the item under discussion;
- (d) To close the debate on the item under discussion.

Submission of proposals and substantive amendments

Rule 52

Proposals and substantive amendments shall normally be submitted in writing to the Secretary-General. Unless the commission decides otherwise, proposals and substantive amendments shall be discussed or put to the vote no earlier than twenty-four hours after copies have been circulated to all members.

Withdrawal of proposals and motions

Rule 53

A proposal or a motion may be withdrawn by its sponsor at any time before voting on it has commenced, provided that it has not been amended. A proposal or a motion thus withdrawn may be reintroduced by any representative.

Decisions on competence

Rule 54

A motion calling for a decision on the competence of the commission to adopt a proposal submitted to it shall be put to the vote before a vote is taken on the proposal in question.

Reconsideration of proposals

Rule 55

When a proposal has been adopted or rejected, it may not be reconsidered at the same session unless the commission so decides. Permission to speak on a motion to reconsider shall be accorded only to two representatives opposing the motion, after which it shall be put to the vote immediately.

XI. VOTING AND ELECTIONS

Voting rights

Rule 56

Each member of the commission shall have one vote.

Request for a vote

Rule 57

A proposal or motion before the commission for decision shall be voted upon if any member so requests. When no member requests a vote, the commission may adopt proposals or motions without a vote.

Majority required

Rule 58

1. Except as provided in rule 5(4) (ii), decisions of the commission shall be made by a majority of the members present and voting.

2. For the purpose of these rules, the phrase "members present and voting" means members casting an affirmative or negative vote. Members which abstain from voting are considered as not voting.

Method of voting

Rule 59

1. Except as provided in rule 66, the commission shall normally vote by show of hands, except that a representative may request a roll-call which shall be taken in the English alphabetical order of the names of the States represented on the commission, beginning with the State whose name is drawn by lot by the Chairman. The name of each member shall be called in all roll-calls, and its representative shall reply "yes", "no" or "abstention".

2. The vote of each member participating in any roll-call shall be inserted in the record.

Explanation of vote

Rule 60

Representatives may make brief statements consisting solely of explanation of their votes, before the voting has commenced or after the voting has been completed. The representative of a member sponsoring a proposal or motion shall not speak in explanation of vote thereon, except if it has been amended.

Conduct during voting

Rule 61

After the Chairman has announced the commencement of voting, no representative may interrupt the voting except on a point of order in connection with the actual process of voting.

Division of proposals and amendments

Rule 62

Parts of a proposal or an amendment shall be voted on separately if a representative requests that the proposal be divided. Those parts of the proposal or the amendment which have been approved shall then be put to the vote as a whole; if all the operative parts of a proposal or an amendment have been rejected, the proposal or amendment shall be considered to have been rejected as a whole.

Amendments

Rule 63

An amendment is a proposal that does no more than add to, delete from or revise part of another proposal.

Order of voting on amendments

Rule 64

When an amendment is moved to a proposal, the amendment shall be voted on first. When two or more amendments are moved to a proposal, the amendment furthest removed in substance from the original proposal shall be voted on first and then the amendment next furthest removed therefrom and so on until all the amendments have been put to the vote. Where, however, the adoption of one amendment necessarily implies the rejection of another amendment, the latter shall not be put to the vote. If one or more amendments are adopted, the amended proposal shall then be voted on.

Order of voting on proposals

Rule 65

1. If two or more proposals, other than amendments, relate to the same question, they shall, unless the commission decides otherwise, be voted on in the order in which they were submitted. The commission may, after each vote on a proposal, decide whether to vote on the next proposal.

2. A motion requiring that no decision be taken on a proposal shall have priority over that proposal.

Elections

Rule 66

All elections shall be held by secret ballot, unless, in the absence of $an\gamma$ objection, the commission decides to proceed without taking a ballot on an agreed candidate or slate.

Rule 67

1. When one or more elective places are to be filled at one time under the same conditions, those candidates, in a number not exceeding the number of such places, obtaining in the first ballot a majority of the votes cast and the largest number of votes, shall be elected.

2. If the number of candidates obtaining such majority is less than the number of places to be filled, additional ballots shall be held to fill the remaining places.

Equally divided votes

Rule 68

If a vote is equally divided on a matter other than an election, the proposal or motion shall be regarded as rejected.

XII. PARTICIPATION OF NON-MEMBERS OF THE COMMISSION

Participation of non-Member States

Rule 69

1. The commission shall invite any Member of the United Nations that is not a member of the commission, and any other State,⁶ to participate in its deliberations on any matter of particular concern to that State.

⁶ It is the understanding of the Economic and Social Council that a commission, in discharging its functions under this rule, will follow the practice of the General Assembly in implementing an all States clause, and that in all cases where it is advisable it will request the opinion of the Council before taking appropriate decisions.



2. A subsidiary organ of the commission shall invite any State⁶ that is not one of its own members⁷ to participate in its deliberations on any matter of particular concern to that State.

3. A State thus invited shall not have the right to vote, but may submit proposals which may be put to the vote on request of any member of the commission or of the subsidiary organ concerned.

Participation of national liberation movements

Rule 70

The commission may invite any national liberation movement recognized by or in accordance with resolutions of the General Assembly to participate, without the right to vote, in its deliberations on any matter of particular concern to that movement.

Participation of and consultation with specialized agencies⁸

Rule 71

In accordance with the agreements concluded between the United Nations and the specialized agencies, the specialized agencies shall be entitled:

(a) To be represented at meetings of the commission and its subsidiary organs;

(b) To participate, without the right to vote, through their representatives, in deliberations with respect to items of concern to them and to submit proposals regarding such items, which may be put to the vote at the request of any member of the commission or of the subsidiary organ concerned.

Rule 72

Before the Secretary-General places an item proposed by a specialized agency on the provisional agenda, he shall carry out with the agency concerned such preliminary consultation as may be necessary.

Rule 73

1. Where an item proposed for inclusion in the provisional agenda for a session or added to the agenda under rule 5 contains a proposal for new activities to be undertaken by the United Nations relating to matters that are of direct concern to one or more specialized agencies, the Secretary-General shall enter into consultation with the agencies concerned and report to the commission on the means of achieving a co-ordinated use of the resources of the respective agencies.

⁷The expression "that is not one of its own members" does not apply to subsidiary organs composed of experts serving in their individual capacity. * See footnote 2.

2. When in the course of a meeting of the commission a proposal fonew activities to be undertaken by the United Nations relates to matters that are of direct concern to one or more specialized agencies, the Secretary-General shall, after such consultation as may be possible with the representatives of the agencies concerned, draw the attention of the commission to the implications of the proposal.

3. Before deciding on proposals referred to above, the commission shal satisfy itself that adequate consultations have taken place with the agencies concerned.

Participation of other intergovernmental organizations

Rule 74

Representatives of intergovernmental organizations accorded permanent observer status by the General Assembly and of other intergovernmental organizations designated on a continuing basis by the Council or invited by the commission may participate, without the right to vote, in the deliberations of the commission on questions within the scope of the activities of the organizations.

XIII. CONSULTATION WITH AND REPRESENTATION OF NON-GOVERNMENTAL ORGANIZATIONS

Representation

Rule 75

Non-governmental organizations in category I or II may designate authorized representatives to sit as observers at public meetings of the commission and its subsidiary organs. Those on the Roster may have representatives present at such meetings when matters within their field of competence are being discussed.

Consultation

Rule 76

1. The commission may consult with organizations in category I or II either directly or through a committee or committees established for the purpose. In all cases, such consultations may be arranged on the invitation of the commission or at the request of the organization.

2. On the recommendation of the Secretary-General and at the request of the commission, organizations on the Roster may also be heard by the commission.

XIV. AMENDMENT AND SUSPENSION OF RULES OF PROCEDURE

Method of amendment

Rule 77

Only the Council may amend these rules.

Method of suspension

Rule 78

A rule of procedure may be temporarily suspended by the commission provided that such suspension shall not be inconsistent with any applicable decisions of the Council and provided that twenty-four hours' notice of the proposal for suspension has been given, which may be waived if no representative objects. Any such suspension shall be limited to a specific purpose and to a period required to achieve that purpose.


Temporary North Lawn Building Key Elements, 1st Floor



FLOOR PLAN KEY



North Lawn Site Interim Access Plan


