Note by the Secretariat

1. The proposed organization of work for the Statistical Commission at its thirtieth session (see annex) has been prepared pursuant to relevant decisions of the General Assembly and the Economic and Social Council in order to facilitate the consideration of agenda items within the time and services allocated to the Commission.
2. The first meeting of the Commission will be convened on Monday, 1 March 1999, at 10:30 a.m. Facilities will be available for two formal meetings each day.
