¹ As of 13 June 2014, Ms. Gabriella Vukovich (Hungary), one of the three elected Vice Chairs of the UN Statistical Commission assumed the function of Acting Chair. This followed the retirement of Ms. Jil Matheson (UK), elected chair of the UN Statistical Commission, from the UK government as of 6 June 2014. Following this retirement and in accordance with Rule 17 of the Rules of Procedure of the Functional Commissions of the Economic and Social Council, the remaining Bureau members, namely the three Vice Chairs, Mr. Ma (China), Ms. Vukovich (Hungary) and Mr. Tactuk (Dominican Republic), and the rapporteur, Mr. Tedou (Cameroon), immediately consulted among themselves and designated Ms. Vukovich to assume the function of Acting Chair until the election of a new Chair at the beginning of the 46th session of the Commission in 2015.
