SPECIAL FEATURE:

TASK FORCE ON INTERNATIONAL MERCHANDISE TRADE STATISTICS

The annual meeting of the Interagency Task Force on International Merchandise Trade Statistics (IMTS) was this year hosted by the Economic and Social Commission for Asia and the Pacific (UNESCAP) in Bangkok from 15-17 March 2005. The Task Force is made up of representatives of international agencies that deal with trade statistics, namely the World Trade Organization (WTO), the Organization for Economic Cooperation and

and reporting of meta-data. IMF presented its Data Quality Assessment Framework (DQAF) which includes concepts used in the Statistical Data and Metadata Exchange (SDMX) project (see http://www.sdmx.org/), whereas OECD reported progress on its MetaStore project which proposes a common structure and vocabulary for storing and presenting meta-data. MetaStore also builds on SDMX concepts. UNSD, which participates in the SDMX project and cooperates closely with OECD regarding metadata for IMTS, announced that it will conduct its review of the National Compiling and Reporting practices within the framework of DQAF.

On other issues, progress was reported by IMF on the development of the manual for imports and exports price indices, by OECD on its handbook on globalization indica-

tors and by Eurostat on globalization studies regarding the structure of exporting industries and the differences among

EU member states in making BOP adjustments to merchandise trade data. In its annual status report on UN Comtrade, UNSD devoted this year a larger section on new developments regarding the data transfer possibilities from the Comtrade server to international agencies using XML file structures and MS Web Services tools.

COOPERATION WITH COUNTRIES AND AGENCIES

35TH SESSION OF THE HARMONIZED SYSTEM COMMITTEE

The Harmonized System (HS) Committee, 35th Session met 14-24 March 2005 in Brussels. Over 30 contracting parties and observer countries and several international organizations attended the session. There were several outcomes of particular interest: The HS Committee examined the draft of the Correlation Tables between the 2002 and 2007 versions of the HS and approved it with few

exceptions. The Correlation Tables will be published on the internet after their approval by the HS Committee. The Secretariat released the publication schedule for the unilingual (in September 2005) and bilingual version (in August 2006) of the 2007 HS Nomenclature. Also a new brochure concerning the "Amendments to the HS Nomen-

COOPERATION WITH COUNTRIES AND AGENCIES

WCO REGIONAL SEMINAR ON THE HARMONIZED SYTEM IN VIETNAM

WCO Regional Seminar on the Harmonized Description and Coding System (HS) for the Far East, South and South-East Asia, Australasia and the Pacific Islands Region, 25-29 October 2004 in Hanoi, Vietnam. Customs representatives from 22 countries and areas and two observers from international organization (ASEAN and UNSD) participated at the seminar. The Seminar was sponsored by the World Customs Organization (WCO), hosted by Vietnam

Customs and mainly funded by the Customs Administration of Japan. The objectives of this seminar were to share HS related issues encountered by participant administrations, classification questions, the implementation of HS02 and HS07 and to increase the knowledge on HS classification of participants. UNSD gave a presentation on selected topics from the Compiler's Manual and the UN Comtrade database.

Did YOU KNOW...?

ELEGANT MARRIAGE OF ANALYSIS AND LATEST AVAILABLE DATA

The <u>Series de Comercio Internacional</u> (http://www.eclac.cl/Comercio/serieCP/eclactrade/comercio.htm) of the UN Economic Commission for Latin America and the Caribbean (UNECLAC) show graphs of international merchandise trade statistics on its website in Santiago de Chile. In itself these graphs are well-designed and contain useful information. What makes them different from most other graphs, however, is the fact that the data used in the application come directly from the UN Comtrade database in New York. It is an interactive and eye-catching interface feeding real time data from UN Comtrade via MS Web Services to the


Brazil : Importaciones de bienes por categoría de productos, 1990, 1995, 2000, 2001, 2002 y 2003 (Millones de dólares)

application in Santiago. The result is the best from two worlds: Data presentation for local analytical purposes from UNECLAC and the latest available data from UN Comtrade. The great advantage for UNECLAC is that it does not need to store the basic trade data in its own database. UNECLAC and UNSD have been co-operating in the development of these analytical applications, but they can be built in-

dependently by the user organization. Changes in the application do not affect UN Comtrade and vice-versa. As a result, UN Comtrade becomes a virtual internet database permitting organizations to make their own applications for data analysis without worrying how to duplicate and synchronize data. Any newly added or revised data will immediately be available and visible in the local application.

YOU HAVE ASKED US

DO YOU HAVE TOTAL WORLD EXPORTS/IMPORTS OF SPECIFIC ITEMS?

Q: I would like to find out the total world exports/imports of a specific item?

A: UN Comtrade does not store - at this moment - the World as a Reporter (whereas there is World as a Partner), because not all countries or areas in the world report to us. Creating such an entity called World Reporter in-

volves adding estimated trade data at detailed commodity level to the data-base, which we were not ready to do so far. Yet, UN Comtrade allows users to create a Country Group (under My Favorites) that contains all available reporting countries and areas. Such group could serve as a proxy to get World exports or imports of a specific item.

UPCOMING EVENTS

WORKSHOPS ON INTERNATIONAL MERCHANDISE TRADE AND ON TRADE IN SERVICES

Joint UNSD/UNECLAC workshop on Statistics of International Trade in Services, September 2005, Participants from Central Banks and National Statistical Offices will be invited to this workshop in the ECLAC/CARICOM region to share their experiences in the compilation of international trade in services and in the implementation of the Manual on Statistics of international trade in services (MSITS). Countries will be asked to present case studies to specific compilation issues

and resource persons will be available to support the learning experience.

Joint UNSD/UNCTAD workshop on International Merchandise Trade Statistics (IMTS), August/September 2005, The workshop on the compilation of IMTS for francophone countries in Africa will be held at the ECOWAS conference centre in Abuja. Customs officers and statisticians of the National Statistical Offices will be brought together to solve local problems in producing trade data.
