# Worldwide consultation on the annotated outline of the Compilers Guide for the Manual on Statistics of International Trade in Services 2010

This worldwide consultation is addressed in the first place to those who collect, compile and disseminate statistics of international trade in services in all relevant national institutes. #### Introduction

The international recommendations in the statistical area of trade in services are contained in MSITS 2010, which covers the international supply of services under the four modes of GATS including the resident – non-resident trade in services transactions based on Balance of Payments (BOP) principles and the services supplied through foreign affiliates.

At the time of the adoption of MSITS 2010 by the Statistical Commission, Commission members also requested that compilation guidance be provided. For this particular purpose a UN Expert Group on the compilation of SITS was created at the beginning of 2012. Its main purpose is the development of a Compilers Guide for MSITS 2010 (CG MSITS 2010). This guide should provide sound practical advice, good country examples and pitfalls to be avoided.

The first (virtual) meeting of the UN Expert Group took place between 12 and 25 March 2012 and was devoted to the scope, structure and broad content of the compilers guide. The experts commented on a proposed draft outline of the guide. On the basis of these comments, the outline was further refined by the Task Force on SITS in its special session on 28, 29 and 30 March 2012. The resulting detailed annotated outline of the compilers guide for MSITS 2010 is herewith presented for your information and comments.

#### The annotated outline of the Compilers Guide

The presented annotated outline consists of 5 main parts with a further division into a total of 25 chapters. The main parts are "general frameworks" about the conceptual, legal and institutional background, "data collection" about the various data sources, "data compilation", "data dissemination" and "cross-cutting issues". We believe that the current structure provides a logical basis for the data production work within a national statistical system. Please find the full annotated outline in the attached document.

#### **Country experience**

The CG MSITS 2010 will try to be as practical and specific as possible. It intends to use many country experiences. If you have any supporting documentations on statistics of international trade in services, the implementation process, or the statistical process, please share those with us.
