



 Done according to the International Standard Industrial Classification (ISIC) of All Economic Activities (Rev 3.1).




Tourism

The TTSNA (Trinidad and Tobago System of National Accounts) was developed locally to classify establishments from the TTSIC (Trinidad and Tobago Standard Industrial Classification), which is an adaptation of the ISIC to suit local conditions.

The Table below shows the Classification of the Accommodation Service Providers under the TTSNA along with the ISIC Rev 3 and 4 equivalents.



Industry 14 encompasses the Accommodation Industry in Trinidad and Tobago. This refers to all Hotels, Self-Contained Apartments, Condominiums, Guesthouses, Bed and Breakfast Establishments, Hotel-Bars, Hostels and Camping Facilities.

Industry 14 comprises four (4) sub-industries. Each sub-industry consists of several sub-sub-industries. They are as follows:



Sub-Industry 140100 (Hotels):

- <u>140101:</u> Hotels with more than 100 rooms
- <u>140102:</u> Hotels with 40 to 100 rooms
- 140103: Hotels with less than 40 rooms
- <u>140104:</u> Condominiums and Apartments

<u>Sub-Industry 140200 (Guesthouses, Bed and</u> <u>Breakfast):</u>

<u>140201:</u>

Large Guesthouses - more than 10 rooms

<u>140202:</u>

Small Guesthouses - with 10 rooms and under

<u>140203:</u>

Bed & Breakfast Establishments – less than 10 rooms and are usually converted residences with spare bedrooms offering additional services such as breakfast and tours.

Sub-Industry 140300 (Motels and Other Rooming Establishments):

<u>140301:</u>

Hotel bars and motels. The Hotel offers accommodation on an hourly rate basis.

<u>140302:</u>

Hostels – charitable operated facilities that offer short-term accommodation, as well as extended programs where necessary.

- Sub-Industry 140400 (Camping Facilities and Camping Space): (Included in 2003)
- <u>140400:</u>
 Camping facilities and camping space

In conclusion, even though the ISIC Rev. 4 was referred to, the System of National Accounts is still based on ISIC Rev. 3.1.
