**Methodological notes on Division 020**

Division 020 shall be completed by all reporting units (municipalities) that generated non-hazardous or hazardous wastes in the reference year and by persons entitled to treat waste.

Col. 3: **Code A** for own generated waste

**Code B** for waste taken over from another authorized person

**Code C** for waste transferred from the previous year (stock balance as at 1 January of the reference year)

**Code D** for imported waste from countries out of EU

**Code E** for imported waste from member states of EU

Col. 5: The treatment method for a given type of waste is coded according to the table below, where:

- the first letter (**A**, **B** or **C**) stands for origin of waste (**A** for own generated waste, **B** for waste taken over from another authorized person and **C** for waste taken from the store);
- the following letter and digit (**R1**, **R2**, **R3** ...) designate the treatment method.
- For instance: AR4 refers to own generated waste used for recycling, BD1 refers to waste taken over from another unit disposed of by deposition at or under the level of the terrain, CN3 is waste removed from the stock and transferred (passed) to another unit.
