Figure 45: Production of LPG by region, 1990-2014

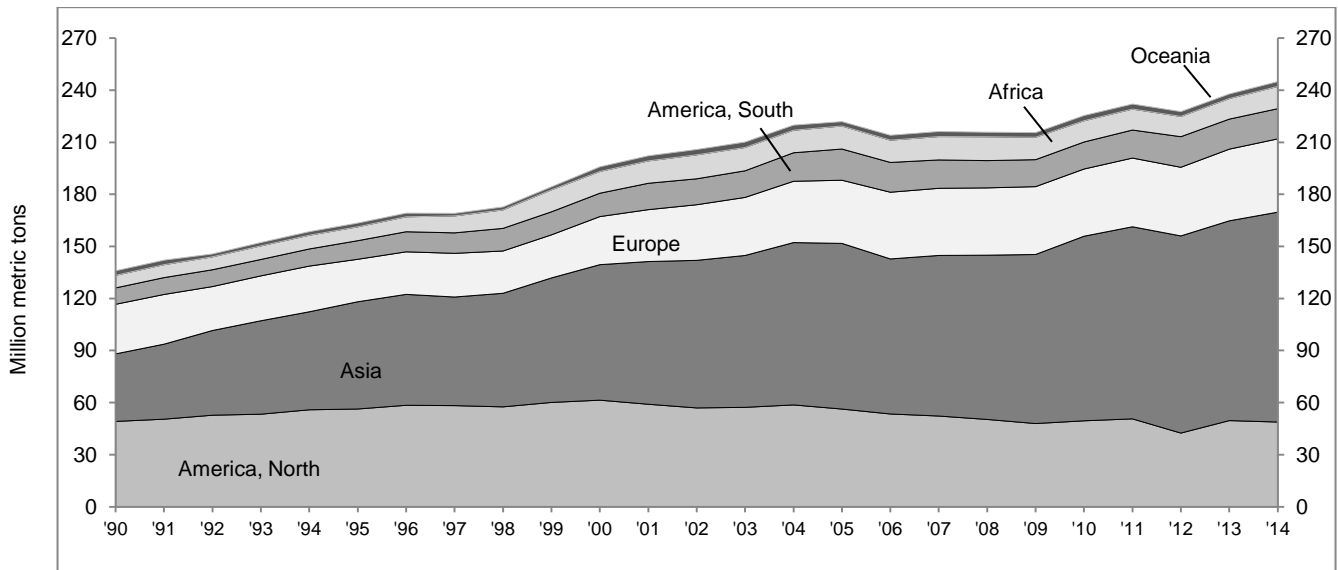


Figure 46: Major LPG producing countries, 2014

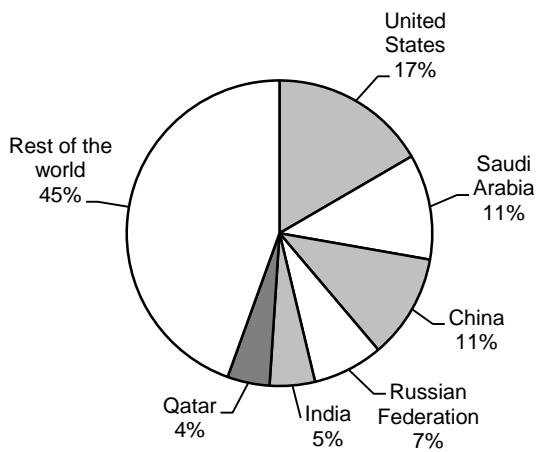


Figure 47: Major LPG consuming countries, 2014

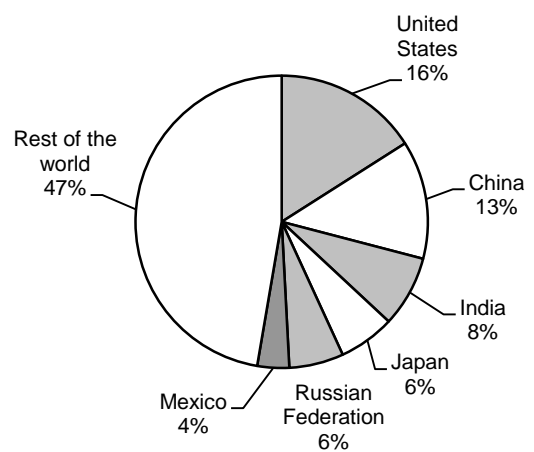
