Annotations

1. Election of officers

In accordance with rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council and past practices, the Statistical Commission, at the commencement of its first meeting of a regular session, shall elect, from among the representatives of its members, a Chair, three Vice-Chairs and a Rapporteur (the Bureau).

The Bureau is elected based on the principle of equitable geographical distribution – one member of the Bureau is elected from each of the regions represented on the Commission. The Bureau serves for two years, to the extent possible. This is achieved by electing the Bureau for a period of one year and re-electing those members of the Bureau who continue to be representatives to the Commission at the following session.

2. Adoption of the agenda and other organizational matters

The items on the provisional agenda and the corresponding documentation were proposed by the Commission at its fifty-third session, held virtually from 1 to 4 March 2022 (see E/2022/24) and were adopted by the Council in its decision 2022/324. Pursuant to that decision, the Bureau of the Commission was entrusted with streamlining and finalizing the agenda. The Bureau subsequently approved some changes. As part of the streamlining, the Bureau proposes to include three item categories: (a) for discussion and decision; (b) for decision; and (c) for information. The proposed provisional programme of work and timetable for the session is also before the Commission. The Commission is invited to adopt the agenda and provisional programme of work and timetable for its fifty-fourth session.

3. Items for discussion and decision

(a) Data and indicators for the 2030 Agenda for Sustainable Development

The Commission will have before it the report of the Inter-Agency and Expert Group on Sustainable Development Goal Indicators on the ongoing work for the implementation of the global indicator framework for the Goals and targets of the 2030 Agenda for Sustainable Development. In its report, the Group describes the activities undertaken in 2022 pursuant to Statistical Commission decision 53/101, including: (a) a review of methodologies for the indicator framework and tier classification updates; (b) work on compiling capacity-building and training programmes and materials on Goal monitoring on a common platform; (c) revision of the terms of reference of the Group; and (d) work carried out by the working groups on statistical data and metadata exchange (SDMX) and geospatial information and the task team on sustainable tourism.

The Commission is invited: (a) to approve the annual indicator refinements; (b) to approve the work programme of the Group for 2023; and (c) to adopt the revised terms of reference of the Group.

In addition, the Commission will have before it the report of the Secretary-General on the work by the Statistics Division of the Department of Economic and Social Affairs of the Secretariat, in cooperation with other entities of the United Nations system, in support of the 2030 Agenda. The report provides a description of the work carried out to prepare the annual report of the Secretary-General on progress towards the Sustainable Development Goals (E/2022/55), the work undertaken to update the Global SDG Indicators Database and related efforts.

The report also contains updates on the following topics: (a) the Data for Now initiative, jointly convened by the United Nations, the Global Partnership for Sustainable Development Data, the World Bank and the Sustainable Development Solutions Network; (b) the project of the Statistics Division funded by the Foreign, Commonwealth and Development Office of the United Kingdom of Great Britain and Northern Ireland to support countries in monitoring achievement of the Goals; (c) the collaborative on the use of administrative data for statistical purposes; (d) the Global Network of Institutions for Statistical Training; (e) the Global Network of Data Officers and Statisticians; and (f) the work on citizen-generated data.

The Commission is invited to take note of the work carried out by the Statistics Division in cooperation with the United Nations system and its proposed programme of work and to express its views on: (a) the Data for Now initiative; (b) the work of the collaborative on the use of administrative data for statistical purposes; (c) the progress of work of the Global Network of Institutions for Statistical Training; (d) the work of the Global Network of Data Officers and Statisticians; and (e) the work on citizen-generated data.

The Commission will also have before it the report of the High-level Group for Partnership, Coordination and Capacity-Building for Statistics for the 2030 Agenda for Sustainable Development, which provides a summary of the recent activities of the Group, including: (a) preparations for the fourth United Nations World Data Forum, to be held from 24 to 27 April 2023, in Hangzhou, China; (b) work to realign the Cape Town Global Action Plan for Sustainable Development Data to support statistical and data capacity development efforts; (c) the global online survey by the Statistics Division, the World Bank Development Data Group and the Partnership in Statistics for Development in the 21st Century, in coordination with the five regional

commissions, which feeds into the review of the implementation of the Cape Town Global Action Plan; and (d) updates on global initiatives related to the financing of data and statistics.

The Commission is invited: (a) to express its views on the preparations for the next United Nations World Data Forum; (b) to endorse the strategy for updating the Cape Town Global Action Plan and for preparing an outcome document on the Action Plan for the 2023 Forum; (c) to express its views on and approval of the proposed workplan of the High-level Group for 2023; and (d) to approve the revised terms of reference of the Group.

(b) Social statistics

The Commission will have before it the report of the Secretary-General on social statistics, containing a summary of work undertaken in 2022 to initiate a new Friends of the Chair group on social and demographic statistics to launch the review of the social and demographic statistics pillar, pursuant to decision 53/105. Draft terms of reference, including the proposed initial scope of work, activities, deliverables and timeline for the group, based on consultations with Members States, regional commissions and partner agencies, will be available as a background document.

The report will also contain a summary of the work undertaken by the United Nations Expert Group on Migration Statistics to identify a set of core and additional indicators for international migration and temporary mobility, in response to decisions 49/101, 50/117 and 52/109. The list of indicators and supporting information will be available as a background document.

The Commission is invited: (a) to express its views on the newly established Friends of the Chair group, in particular on its work priorities and deliverables; and (b) to review and endorse the core and additional indicators for international migration and temporary mobility as an integral part of the upcoming second revision of the Recommendations on Statistics for International Migration.

(c) Household surveys

The Commission will have before it the report of the Intersecretariat Working Group on Household Surveys, which contains a summary of recent work of the Group, including: (a) its position paper, entitled "Positioning household surveys for the next decade", which will guide the work of the Group and its support provided to countries; (b) the activities and outputs of the Group in three areas, coordination, methodological development and advocacy; and (c) the conclusions of the United Nations Expert Group Meeting on Innovative Methods to Measure the Impact of COVID-19 on Mortality through Surveys and Censuses, a joint effort by the Statistics

Division and the Population Division of the Department of Economic and Social Affairs and New York University Abu Dhabi.

The Commission is invited: (a) to endorse the paper entitled "Positioning household surveys for the next decade"; (b) to review the progress made by the Group in its work; and (c) to provide guidance on its activities and outputs, with specific attention to testing methods and promoting data innovation in household surveys and data integration, including for the measurement of adult mortality and proposed future areas of work.

(d) Economic statistics

The Commission will have before it the report of the Network of Economic Statisticians. (e) National accounts

The Commission will have before it the report of the Intersecretariat Working Group on National Accounts. In addition, the report contains the programme of work of the Group and of the regional commissions, as well as an update on the scope and timeliness of the implementation of SNA at the country level. The Commission is invited to express its views and to provide guidance on the elements of the work programme for updating the 2008 SNA and on the programme of work of the Group.

(f) Business and trade statistics

The Commission will have before it the report of the Committee of Experts on Business and Trade Statistics. In the report, the

Committee presents its new work programme, the progress made in the revision of the trade statistics manuals and the progress made in the development of a global initiative to improve the availability of unique identifiers for businesses. The Commission is invited to express its views on the progress of work and to provide guidance on the elements of the work programme.

(g) Regional statistical development

The report contains an outline of activities undertaken to respond to the impact of the coronavirus disease (COVID-19) on the African statistical system and work done to support the implementation of the Sustainable Development Goals and Agenda 2063 of the African Union. The Commission is requested to comment on the work undertaken in Africa and identify possible areas of collaboration with other regions and partners.

(h) Environmental-economic accounting

The Commission will have before it the report of the Committee of Experts on Environmental-Economic Accounting. In the report, the Committee describes progress made with regard to its five workstreams: coordination and communication; methodological development for normative standards and other research; the development of databases; implementation and statistical capacity-building; and the System of Environmental-Economic Accounting (SEEA) and business accounting.

The Commission is invited to provide its views on the progress made by the Committee, in particular in: (a) scaling up the global implementation of both the SEEA Central Framework and SEEA Ecosystem Accounting, including through partnerships between international organizations; (b) the engagement of national statistical offices in the post-2020 global biodiversity framework and the new Group of 20 Data Gaps Initiative; (c) the progress made on global data collection and databases; and (d) the engagement of the statistical community in the development of emerging business reporting and disclosure initiatives on the environment and ecosystems.

(i) Fundamental Principles of Official Statistics

of the Principles, including options for consideration by the Commission. It also contains an outline of possible options to be considered for the creation of tools to enhance the applicability of the Principles and to prevent violations thereof.

The Commission is invited: (a) to take note of the report of the Secretary-General; and (b) to review and approve the options proposed for the work to be undertaken in advance of the celebration of the twentieth anniversary of the adoption of the Principles, to be held in 2024.

(j) International statistical classifications

The Commission will have before it the report of the Committee of Experts on International Statistical Classifications. In its report, the Committee describes its work on the development and implementation of international statistical classifications in various fields and its work on the coordination of classifications and the review of the international family of classifications. The Committee also provides an update on the work of its task teams, including the task team on the revision of the International Standard Industrial Classification of All Economic Activities and the task team on the revision of the Central Product Classification. The Commission is invited: (a) to express its views on the progress of work on international statistical classifications; (b) to provide guidance on the elements of the new work programme of the Committee; and (c) to adopt the revised structure of the International Standard Industrial Classification, the revised Classification of Statistical Activities developed by the Economic Commission for Europe (ECE) and the draft international classification of violence against children.

(k) Statistical capacity development

The Commission will have before it the report of the Secretary-General on statistical capacity development. The report contains an overview of the recent activities undertaken by the Statistics Division in support of countries' efforts to strengthen their national statistical capacity and to better respond to the data challenges in the context of the 2030 Agenda. It also contains information on changes enacted in response to the COVID-19 pandemic, a description of collaborative efforts for synchronizing initiatives and leveraging partnerships and an outline of the coordination undertaken in the area of statistical capacity development, as well as emerging strategic frameworks. The Commission is invited to express its view on the work carried out and the proposals on coordination outlined in the report.

(l) Working methods of the Statistical Commission

The Commission will have before it the report of its Bureau on the working methods of the Commission. In the report, the Bureau describes ongoing work on the review of Council resolution 2022/3, by which the Council updated the terms of reference of the Commission, and its applications to existing workstreams, and highlights areas

for further work. The Bureau also highlights how the framework for groups adopted in 2020 is relevant to addressing the scope of the new terms of reference. The Bureau also provides a review of the multi-year programme of work in the light of the proposed revision to the Classification of Statistical Activities, originally developed by ECE (see agenda item 3 (j)) and presents a brief examination of the request to revisit issue of equitable geographic distribution, pursuant to paragraph (g) of decision 53/105. The report also contains updates on other initiatives undertaken by the Bureau during the intersessional period in 2022 and 2023. The report is accompanied by a background document, containing a summary table of the mapping of the terms of reference. The Commission is invited to reflect on the review and its application to the work of the Commission.

(m) National quality assurance frameworks

The Commission will have before it the report of the Expert Group on National Quality Assurance Frameworks. The Group also presents the results of a global survey of countries on the implementation of quality assurance; a proposed road map for the implementation of a national quality assurance framework for official statistics; and an update on the Group's work on the issue of quality assurance for new and administrative data sources. In addition, the report contains the proposed programme of work of the Group for the next two years to support countries in the implementation of a national quality assurance framework.

The Commission is invited: (a) to express its views on the work of the Expert Group over the past two years; (b) to endorse the proposed road map; (c) to express its views on the results of the global survey; (d) to review and approve the proposed programme of work and updated terms of reference of the Group.

(n) Big data

The Commission will have before it the report of the Committee of Experts on Big Data and Data Science for Official Statistics. Proposals are presented on systematic collaboration between the task teams and the hubs, on active collaboration between the Committee and the geospatial community, on the role of privacy-enhancing technologies in facilitating access to privately held data and on the terms of reference for the network of data science leaders. The Commission is invited to express its view on the progress made and the proposals outlined in the report.

At the meeting, the Group discussed key areas in CPI compilation, including the use of new data sources for measuring inflation, cost-of-living and housing. The report also includes a proposal for updated terms of reference for the Group. The terms of reference contain an outline of the objectives and activities of the Group, its organization of work and information on the membership of its steering committee.

The Commission is invited to take note of the work of the Ottawa Group and to endorse the proposed updated terms of reference.

(b) Integration of statistical and geospatial information

The Commission will have before it, for decision, the report of the Expert Group on the Integration of Statistical and Geospatial Information. In its report, the Group provides information on its recent activities to strengthen the integration of statistical and geospatial information, including: (a) the progress made in developing guidance for Member States to enable them to maximize the outputs of the 2020 round of population and housing censuses towards meeting the integrated data needs of the 2030 Agenda; (b) the outcomes of its seventh meeting, to be held in Santiago, including with regard to how the Group will refocus its direction towards geospatially integrated statistics onto new demands, such as statistics related to climate change, disasters and health (such as COVID-19), by expanding on the Integrated Geospatial Information Framework for the statistical domain; and (c) how the Group can support the implementation of Council resolution 2022/3, in particular with regard to how the Statistical Commission can respond to the growing demands for the integration of statistical and geospatial information.

The Commission is invited to take note of the work and agree upon the Group's future direction.

(c) Data stewardship

The Commission will have before it, for decision, the report of the Working Group on Data Stewardship, which contains a summary of the recent activities of the Working Group, including highlights from the five workstreams and the workplan for 2023, as well as a proposed way forward to better define and focus the role of national statistical offices as data stewards within their national statistical and data systems.

The Commission is invited: (a) to approve the draft consultation questionnaire to be circulated among national statistical offices to understand attitudes on the scope and

priorities of data stewardship; (b) to approve the reports on the progress made under the five workstreams defined by the Working Group; and (c) to approve the proposed workplan for 2023.

(d) Crime and criminal justice statistics

The Commission will have before it, for decision, a joint report prepared by the United Nations Office on Drugs and Crime (UNODC) and the National Institute of Statistics and Geography of Mexico (INEGI) on corruption measurement. In the report, UNODC and INEGI present the statistical framework to support Member States in their efforts to measure corruption, its impact and all relevant aspects of preventing and combating it, which has been the subject of a global consultation and will be available as a background document. The report follows the adoption of the political declaration by the General Assembly at its special session against corruption, held in 2021, in which the Assembly outlined the need to develop a comprehensive, scientifically sound and objective framework, grounded in methodological work and reliable data sources in coordination with the Statistical Commission.

The Commission is invited to welcome the statistical framework for corruption measurement and its indicators and to encourage its implementation by Member States.

(e) Refugee, internally displaced persons and statelessness statistics

The Commission will have before it, for decision, the report of the Expert Group on Refugee, Internally Displaced Persons and Statelessness Statistics. The report is focused on progress related to the development of the international recommendations on statelessness statistics, which have been the subject of a global consultation and will be shared as a background document. The draft international recommendations on statelessness statistics are the result of a collaborative effort by Expert Group members and include a newly proposed statistical framework and a comprehensive set of recommendations for improving official statistics on statelessness, in line with commitments under the 2030 Agenda.

In addition, the report will serve to inform the Commission more broadly about the Group's progress in support of the implementation of the International Recommendations on Refugee Statistics and the International Recommendations on Internally Displaced Persons Statistics.

The Commission is invited to review and endorse the draft international recommendations on statelessness statistics and to approve the future work of the Expert Group.

(a) Demographic statistics

The Commission will have before it, for information, the report of the Secretary-General on demographic statistics. In the report, the Secretary-General presents activities carried out by the Statistics Division in the area of demographic statistics. The report contains a summary of the implementation of the 2020 World Population and Housing Census Programme during the past year, with a focus on: (a) the adverse impact of the COVID-19 pandemic on the implementation of the Programme; (b) direct support for census-takers at the request of the Member States; (c) building national capacity for census-taking through regional workshops; and (d) assistance for countries in implementing the Commission's recommendations in terms of building national statistical population registers. It contains information on the implementation of the United Nations Legal Identity Agenda, including an outline of the effects of the COVID-19 pandemic on the functioning of national civil registration systems and the production of accurate and reliable vital statistics, and on maintaining the momentum of implementing the Legal Identity Agenda in the African region. It also contains information on activities related to capacity-building for the implementation of the methodology for delineating urban and rural areas for international and regional statistical purposes. Lastly, it contains information on the collection of demographic statistics through the Demographic Yearbook questionnaires. The Commission is invited to take note of the report.

(b) Finance statistics

The Commission will have before it, for information, the report of the International Monetary Fund on finance statistics. The Commission is invited to take note of the report and the 2023–2024 workplan.

In particular, it contains information on the current science, technology and innovation statistics programme strategies, directions and priorities of the Institute, covering the areas of data collection, methodological developments and capacity development activities and placing specific emphasis on current and future challenges. As the workplan includes the global collection, compilation and dissemination of environmental statistics and indicators, the report provides a summary of the results of the international collections of environment statistics carried out by the Statistics Division from 1999 to 2020, as well as conclusions with relevance for future work, especially with regard to several environment-related Sustainable Development Goals.
