Metadata Structure Definition, MSD

- **Definition** Specification of the allowed content of a Metadata Set in terms of attributes for which content is to be provided and to which type of object the metadata pertain.
- **Context** An MSD defines the reference metadata to be collected or reported by specifying the concepts required, how these relate to each other, their presentational structure and to which objects they are to be attached.

Concepts and definitions

Definition:

• Precise definition of the indicator including references to standards and classifications, preferably relying on international agreed definitions. The indicator definition should be unambiguous and be expressed in universally applicable terms. It must clearly express the unit of measurement (proportion, dollars, number of people, etc.).

Rationale:

• Description of the purpose and rationale behind the indicator, as well as examples and guidance on its correct interpretation and meaning.
