## MODALITIES FOR THE BREAKOUT SESSIONS

Sessions 1-4 are organised according to the areas identified in the concept note of the regional thematic conferences, as follows:

- For each session, 5 contributors will make a short presentation of around 20 minutes on a topic related to that thematic area. These presentations will mainly focus on national experience demonstrating major challenges, opportunities, issues, priorities and good practice.
- Presentations will be followed by 20 minutes of questions for clarification and answers by the contributors. These discussions will be moderated by the chair of the session.
- After the questions and answers for clarification, participants will be split in 4 groups. These groups remain the same for both breakout sessions (i.e. on Monday afternoon and Wednesday morning, see table below for composition of the groups).
- For each breakout session, groups will have 1 hour and 15 minutes to discuss a specific set of questions prepared in advance. Each group will nominate a rapporteur; preferably from a country that does not have a specific role otherwise. The rapporteur can be the same for both breakout sessions or different but must be from a country.
- The rapporteur of each group will have 5-10 minutes to present back in plenary the outcome and conclusions of the discussions from the breakout sessions. This will be followed by about an hour of general discussion. Presentations by the rapporteurs and the plenary discussion will be moderated by a facilitator.
- The conference is attended by the Chief Statistician or senior managers of the National Statistical Office (NSO) therefore discussion will be of a strategic nature rather technical.
- Participants from bilateral and multilateral partner organisations and other stakeholders can decide in which group they wish to participate and should appreciate that the purpose of the breakout session is to gauge experience and point of view from the national representatives.
