## MODALITIES FOR MAIN CONFERENCE SESSIONS

- The main sessions 1 to 4 are organised according to the themes identified in the thematic conference agenda
- For each session, 5 - 6 contributors will make a short presentation of around 15 minutes on a topic related to that theme. These presentations will mainly focus on national experience demonstrating major challenges, opportunities, issues, priorities and good practice.
- Presentations will be followed by 30 or 45 minutes of discussion which should consist mainly of questions for clarification and answers by the contributors. The breakout sessions will enable a fuller discussion of the topics presented.
- The chair of the session will be responsible to moderate each session including the time management of the presentations and subsequent discussion. This chair will be assisted by the conference organisers to ensure presenters keep to their allocated speaking time and the session does not overrun its indicated time.
- Presenters can also seek advice from conference organisers on what areas to focus on according to the theme of the session. The conference will be attended by Chief Statisticians, senior policy officials and other senior managers of the National Statistical System (NSS) therefore discussion should be of a strategic nature rather technical.

## MODALITIES FOR THE BREAKOUT SESSIONS

- Following the conclusion of the main sessions 1 & 2 and then 3 & 4, participants will be split in 4 groups.
- The groups for both breakout sessions are defined along the following criteria:
  - (1) if a country or area is represented by more than one participant, these participants are allocated to different groups to focus on different sessions/topics;
  - (2) the chair and presenters of a particular session are requested to participate in a breakout session related to that session.

An advanced allocation for the breakout sessions is made on pages 3 & 5.

- For each breakout session, groups will have 1 hour and 15 minutes to discuss a specific set of questions prepared in advance (see pages 3 – 6). Each group will nominate a rapporteur; preferably from a country that does not have a specific role otherwise. The rapporteur can be the same for both breakout sessions or different, but must be a country representative.
- The rapporteur of each group will have 5-10 minutes to present back in plenary the outcome and conclusions of the discussions from the breakout sessions. This

will be followed by about an hour of general discussion. Presentations by the rapporteurs and the plenary discussion will be moderated by a facilitator.

- Participants from bilateral and multilateral partner organisations and other stakeholders can decide in which group they wish to participate and should appreciate that the purpose of the breakout session is to gauge experience and point of view from the national representatives.
