OUR MANDATE

WHO ARE WE?

The Anguilla Statistics Department (ASD), with a mandate

To collect, compile, analyze, abstract and publish statistical information relative to the commercial, industrial, social, economic and general activities and conditions of the people who

To collaborate with all other departments of Government and with local authorities in the collection, computation and publication of statistical records of administration;

To take any census in Anguilla; and

Generally to organize a coordinated scheme of social and economic statistics and intelligence.



MISSION STATEMENT

OUR MISSION

To produce relevant and quality statistics for use by both the private and public sectors of Anguilla and other interested parties in their decision-making.



The Anguilla Statistics Department is tasked with the mandate, as set out in Section 2 of the Statistics Act:

To collaborate with all other departments of Government and with local authorities in the collection, computation and publication of statistical records of administration;

Generally to organize a coordinated scheme of social and economic statistics and intelligence pertaining to Anguilla.



STATISTICAL INFRASTRUCTURE

DEFINITION

Statistical infrastructure comprises activities and services that are administered to support a strong statistical system

Professional & Statistical Services include the development of sound statistical methodology

Standardized concepts and classifications (including geographical concepts)

Development and provision of statistical metadata & provision of advice with respect to Statistics Act and data-sharing agreements.



STATISTICAL INFRASTRUCTURE

CLASSIFICATIONS, OUR LANGUAGE

Statistical Classifications are a set of discrete categories which may be assigned to a specific variable in a statistical survey or in an administrative file and used for the production and presentation of statistics.

We use International Statistical Classifications

USES

Assists in arranging data into categories based on their common properties

Aid in the production of consistent and comparable data over time, space & different data sets

Usually associated with sample surveys or censuses

Thought is given to statistical classification with the collection of administrative data though vague, in conjunction with other data sources it gives a more complete picture

Help in analysis of data across the system at various levels

PROS



Most international classifications are maintained and kept up to date by the United Nations Statistics Division (UNSD)
Ability to compare across time and space with robust classifications

Reduced efforts in reconciling data.

Quality detailed data which cross reference info from Departments and Ministries, better policy, programme design & decision making

CONS



There may be occasions when there is non-adherence or inconsistencies in their application

INTERNATIONAL STANDARD
INDUSTRY CLASSIFICATION



WHAT IS IT?

The International standard industrial classification of all economic activities, abbreviated as ISIC, is a standard United Nations Statistics Division (UNSD) classification of economic activities arranged so that entities can be classified according to the activity they carry out.

HOW IS IT USED?

- Providing a continuing flow of information for the monitoring, analysis and evaluation of the performance of an economy
- Used to classify statistical units, such as establishments or enterprises
- At each level of ISIC, each statistical unit is assigned to one and only one ISIC code
- ISIC provides the internationally accepted standard for categorizing producing units within an economy, which allows for data comparison at the national and international levels



WHY IS IT SO IMPORTANT?

- ISIC allows the gathering and analysis of data quickly and efficiently.
- ISIC has a central position among existing classifications of economic activities, as well as other economic classifications, such as those for products. See: Nomenclature of Economic Activities (NACE)

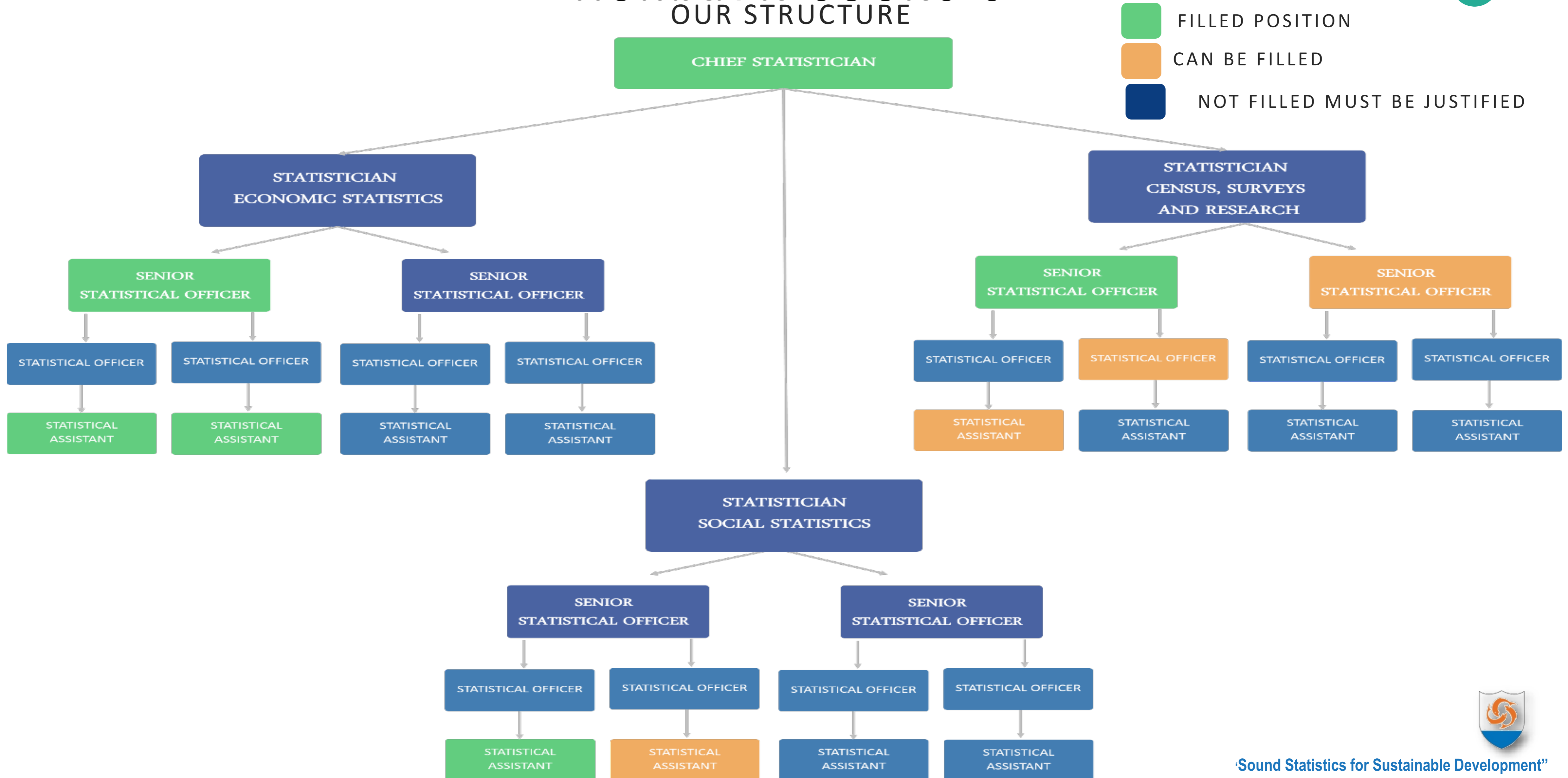
IMPORTANCE & RELATIONSHIP

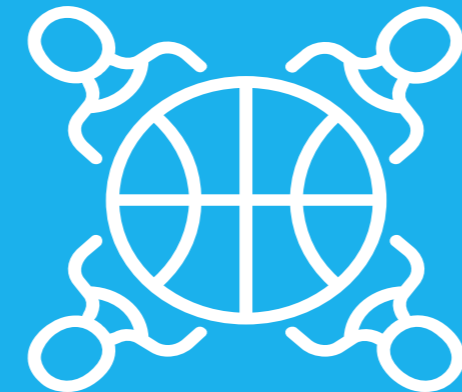

COLLECTION

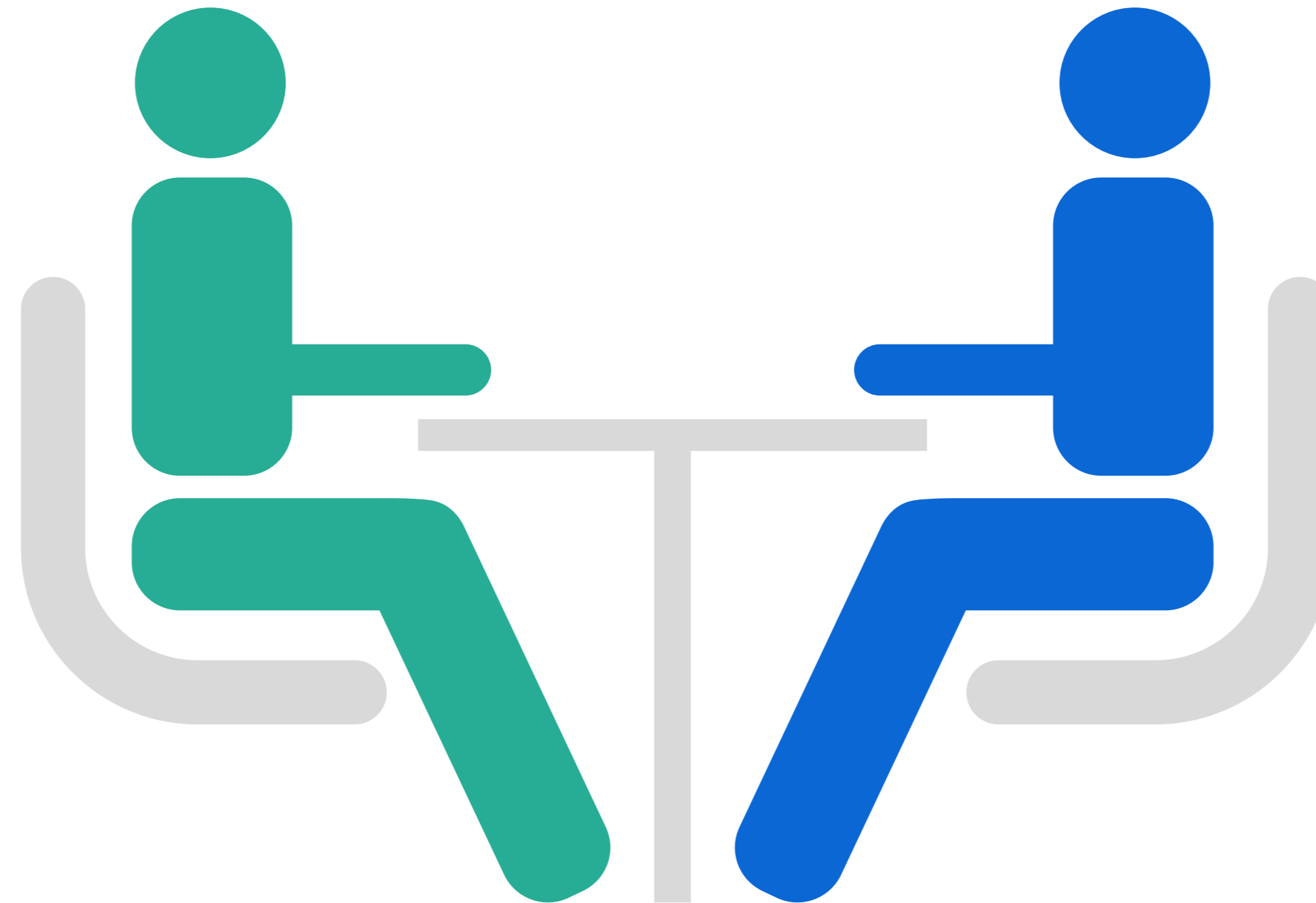
ANGUILLA STATISTICS DEPARTMENT

The Anguilla Statistics Department used its initiative to create a greater need for its services among the ministry and their department.

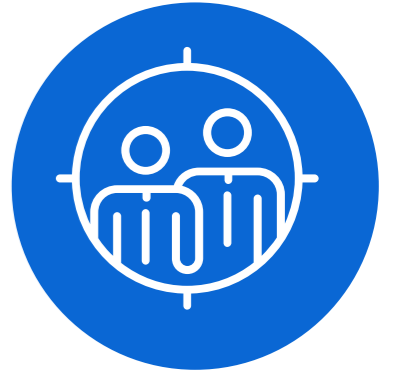
We further educated ourselves alongside international standards, progressions and classifications.

HUMAN RESOURCES

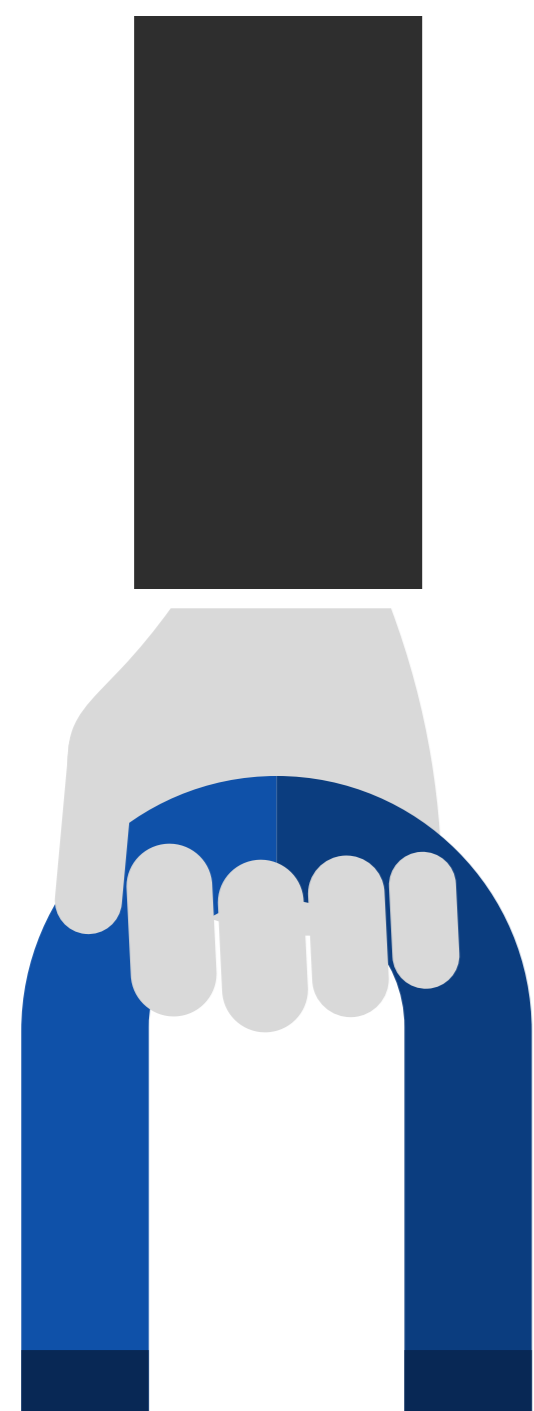


Because of our performance with minimal resources. We have initiated movements that must be sustained and can only be sustained by investing in our department with more work force.

PROVISION FOR OUR NEEDS



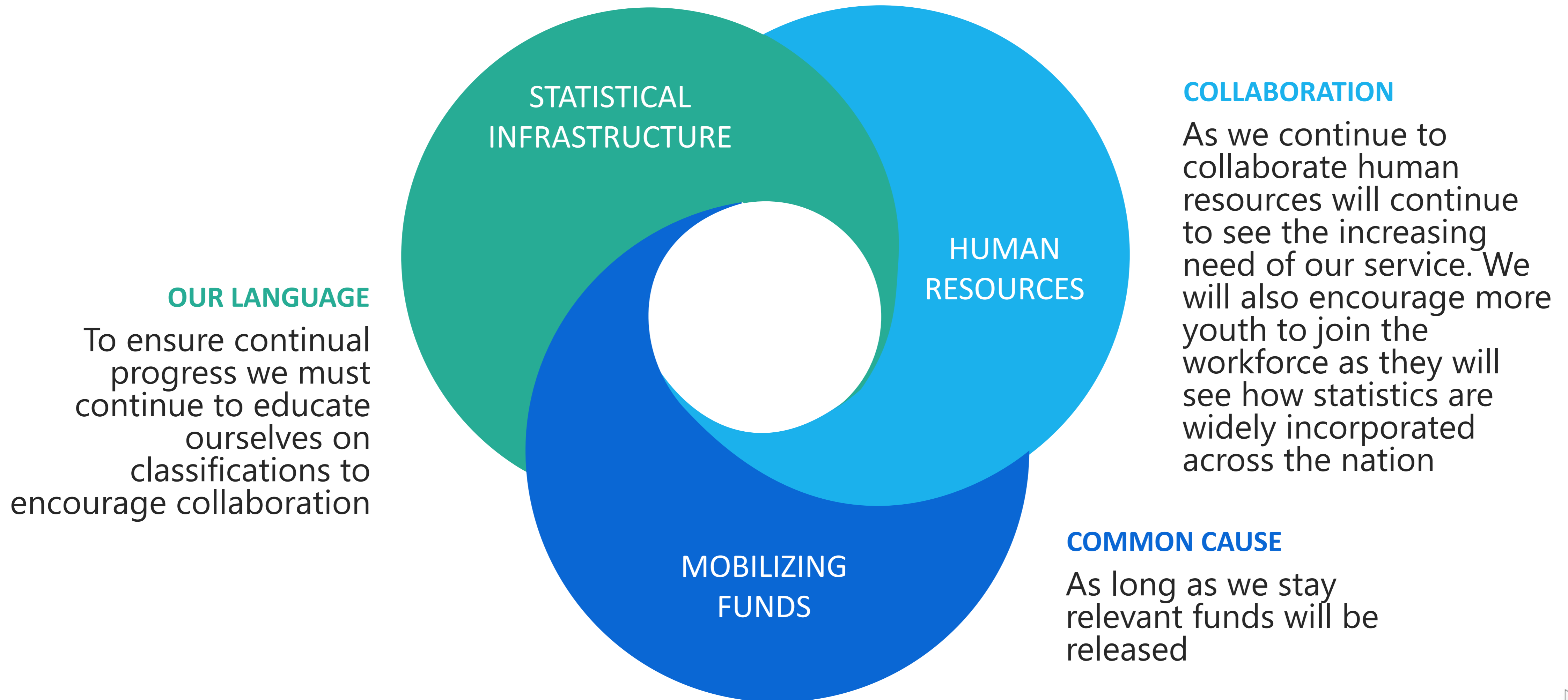
The work done at the ASD to encourage collaboration and ensure the correct classifications is being followed and has cultivated a massive workload.

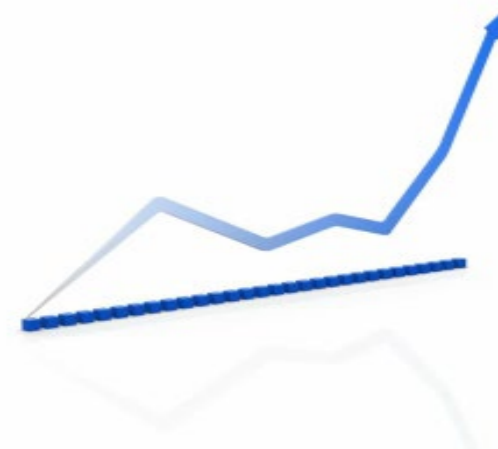
The importance of the changes we have established such as ISIC must be sustained by law. By encouraging linkages within the ministries and departments we have created a common ground, common interest and common needs.
