




#### Principal Couple Average Duration of Interview (In Minutes)

# **Observation During Interviews**

- Unavailability of some Eligible Respondents due to work or in school, market, etc.
- Simultaneous individual interview was not applicable in small houses because they hear each other answers and sometimes compare answers or argue (couple).
- Some Eligible Respondents refused or were reluctant to answer especially questions on assets.
- Some Eligible Respondents with enterprise found difficulties in estimating net income.



# **Observation During Interviews**

- Some sample households were very far from the barangay proper.
- Housing unit of some respondents were near the riverside and mountain hills.
- Other household members made interruptions during the interview.
- Bad weather made it difficult to reach the respondents (i.e., slippery and rough roads at the time of visit due to rain)
- One household and 8 individual respondent refused despite follow-up by PSA supervisors.



## **Observation During Interviews**

- Some respondents have difficulties in answering questions. They don't want to give information especially if the questions are personal according to them.
- Some husbands of eligible women were present during the interview and curious enough to listen and sometimes volunteered to answer some of the questions.
- A male spouse was suspicious as to why questions on assets were asked; according to him it is very personal. Also, the respondent suspected us that the teams are part of swindling syndicate like "Budol-Budol" (hypnotizers).
- Older respondents had a problem on language barrier and more probing was needed especially in those with low educational attainment.



# **CONCLUSIONS/RECOMMENDATIONS**

- Team approach is an effective way of collecting data. It made enumeration easier and guaranteed quality data - because of the help given by co-team members, corrections are tackled and discussed at once.
- Meeting of the Supervisors (Teams and Staff from CO and FO) after the first week is necessary to evaluate the first week of operation and measure the training absorption of the interviewers.
- The manual should contain more examples which may be encountered during the actual field operations.



# **CONCLUSIONS/RECOMMENDATIONS**

- There should be at least a gap of one week from the training to the start of the enumeration to give time for the field personnel to do coordination, review and to prepare the necessary materials for the enumeration, etc.
- Translated questionnaires should be more in layman terms to insure that respondents understand the questions and easily respond.
- A thorough review of the questionnaires should be done before printing to avoid correcting mistakes in the questionnaire that often resulted to delay for both the team supervisors and interviewers.
