Recommendations/reflections from the meeting (1)

- Will benefit from a "core" handbook that covers key aspects of household surveys, building on the foundation of the 1984 Handbook
- Will follow the GSBPM phases broadly, while incorporating lowerlevel specific points that are relevant/important for household surveys.
- A phase zero will be added on issues related to the initial planning/organization, project management, and address how a specific survey fits into the larger national data ecosystem.
- In connection to phase zero, will expand on other aspects of the enabling environment as discussed in the <u>Position Household</u> <u>Surveys for the Next Decade Paper</u>.



Recommendations/reflections from the meeting (2)

- Need to define the boundary of surveys that the handbook will speak to.
- Should strike a balance between principles and practical guidance. Principles need to be emphasized and practical solutions (example and tools, incl. those based on national experiences) can be organized around the principles.
- Should distinguish the established principles from innovations/new ideas that are still at the experimental phase.
- Efforts should be made to ensure that sufficient caution is provided on innovations/new ideas that might work depending on the national context.
- Should make references to existing materials, if available.



Recommendations/reflections from the meeting (3)

- How to take into consideration specificities in
 - Post-disaster/conflict sharing similar situation
 - Small island developing states (SIDS)

Timeline

- End Jan 2024 to UNSC: submitting meeting report and recommendations
- Feb-March 2024: comments/input from the UNSC
- 15 Feb 2024 UNSC side event on the revision of the handbook: solicit input
- End March 2024: draft annotated outline (draft + framework for examples) for comments
- March July 2024: expansion of the draft + division of labour + drafting + national experience collection
- August 2024: first set of training data for the ML/AI
- July Sept 2024: continue the drafting, initial draft
 October 2024: 2nd EGM on the revision of the handbook, Oslo, Norway
- Nov 2024 Jan 2025: Revise/continue the draft, second draft to UNSC 2025 and consultation
- Jan-Oct 2025: continue the drafting
 Oct 2025: 3rd EGM on the revision of the handbook
- Jan 2026: 3rd draft to UNSC
