## Invitation to the 7th Meeting of the Oslo Group on Energy Statistics in Helsinki, 23-26 October 2012

Mr Olav Ljones, Chair of the Oslo Group, has the pleasure of inviting your office to the 7<sup>th</sup> meeting of the Oslo Group on Energy Statistics. The meeting is to be held in Helsinki, Finland from 23-26 October 2012, and will be hosted by Statistics Finland.

The main objective of the 7<sup>th</sup> Oslo Group meeting is to review available drafts and annotated outlines for the chapters in the *Energy Statistics Compilers Manual* – ESCM. The manual is intended to assist energy statistics compilers in the implementation of the *International Recommendations of Energy Statistics* – IRES and parts of the forthcoming *System of Environmental-Economic Accounting for Energy* - SEEA-Energy.

The coordinators and volunteers of the ESCM chapters should aim to have preliminary drafts of the chapters (in particular 1, 2, 3, 4, 5, 7, 8 and 9) at the meeting, or at least a proposal for a detailed annotated outline. The more complete the text is, the easier and more fruitful the discussion at the 7<sup>th</sup> Oslo Group meeting will be. The outcome of the 7<sup>th</sup> Oslo Group meeting should provide a clear direction to guide the subsequent revision and drafting of chapters.
