KNBS DATA SOURCES

- Major data source in KNBS is sample surveys - periodic

Depending on the nature of the survey, a sample survey would give age specific of respondents then narrows down to the desired age groups

- Administrative records - continuous

Admin records are specific to the mandate of the institution generating it

- Population and Housing Censuses - after every 10 yrs
- Censuses would give single ages for all persons then put together the population as per the desired special groups

DISAGGREGATION OF DATA FOR SDGS

- Kenya has two levels of government – national and county
- There are 47 county governments
- Some services/sectors are devolved eg Health, ECDE and Agriculture
- This calls for ensuring that data is reported at the county level

DISAGGREGATION OF DATA BY AGE

- < 1 yr
- 3 - 5 ECDE - Managed at the devolved level of gvt
- 6-13 Primary – Gvt provides Free Primary Education in all public schools
- 13 – 19 teenage – transition age from child to adult
- 14 – 17 Secondary - Free Day Secondary Sch

DISAGGREGATION OF DATA BY AGE CONT...

- < 18 Children – OVCs are determined from here.
- 18 – 35 The Kenyan Youth
- 18+ Voters and/or Adults
- 15 – 49 Females of reproductive age
- 15 – 64 Active Labour Force
- 65+ - The elderly – they benefit from Social protection funds
- Street Families – Mainly supported by NGOs
- Persons with Disability – Only registered ones benefit

YOUTH ISSUES

They are affected by issues of:

- Unemployment Employment
- Poverty
- Health
- Crime and drugs
- Leisure, recreation and community service
- Youth Environment
- Poor access to financial resources

YOUTH ISSUES CONT'

- There are a number of support programs by the gvt:
 - Kazi Kwa vijana program
 - National Youth Service
 - Uwezo funds
 - Women enterprise funds
 - 30% of total public procurement sum is reserved for the youth, women & persons with disability

CHALLENGES TO “LEAVING NO ONE BEHIND”

- KNBS disaggregates age data up to 99
- Unspecified ages and sex exist in the census data (special population)
- Homeless, refugees & institutional population are not in surveys – **How do you cover them?**
- Needed sample size as you go to lower levels eg **2014 KDHS (size and questionnaires) and MICS series**
- Some youths don't report their ethnic background

EMMERGING CONCERNS

- Transgender
- Deaf-blind
- What are the other data sources, keeping in mind the quality? To what extent can we accommodate them?
- Violence against men
