General Comments:

The UNSS has updated or modified the position posted on the comments page (September 5), having reviewed the many comments and suggestions made the member states, civil society, private industry etc.

We are not clear how the Green/Yellow/Grey classification was determined or awarded. In any event, even for some of the indicators classified as "green" we are suggesting slight changes, having reviewed all the comments. Therefore we would ask that some time be allowed to review "green" indicators.

As little time is allowed for comments, we would like to note, we have at all stages taken care to use existing data, in order to minimize burden to member states. In a small number of cases we are proposing new concepts, but we made great efforts to keep this to a minimum.

In a number of cases we are proposing to use the original indicator proposed by TST 17. It is not clear why these were not presented to member states as proposed indicators, or who or why these indicators were changed.

Target 17.1 Strengthen domestic resource mobilization, including through international support to developing countries, to improve domestic capacity for tax and other revenue collection

Proposed Indicator: Composition of Tax Revenues (by source, including revenues derived

from environmental taxes), and as % of GDP

Supplementary Indicator: 17.1.1 Total Tax/GDP

Supplementary Indicator: 17.1.2 Total Tax Per Capita (\$ value)

Status: Yellow

Comment: There is quite mixed reaction to the proposed indicator. The IMF and WB proposed a broader indicator but many others have disagreed. Several of the proposed supplementary indicators would appear to be worthwhile and warrant further investigation to determine whether they can be added to suite of indicators in the future. For the moment however, the UNSS recommends the following:

Recommendation: Replace proposed indicator with 'Total Govt Revenues (by source), and as a % of GDP'. Keep supplementary Indicator 17.1.1. Drop supplementary indicator 17.1.2.

Recommendation: Keep proposed indicator and supplementary indicator 17.2.2 but drop existing supplementary indicator 17.2.1 and replace with it the original proposal from TST 17 ODA Gap i.e. Net ODA [Target 0.7% of GNI] - Net ODA [Actual] as this indicator neatly highlights the shortfall in commitments.

Drop supplementary indicators 17.4.1 and 17.4.2 and replace them with new supplementary indicators 17.4.1 'Debt service as a percentage of government revenue' and 17.4.2 'Number of countries in debt distress for two successive years, and number of countries at high and moderate risk of debt distress' or 'The number of countries using the World Bank-IMF LIC Debt Sustainability Framework (DSF) assessed to be "high risk" or "in debt distress"' - the best wording should be determined by experts in this field.

Recommendation: Keep proposed indicator and supplementary indicator 17.5.2. Agree with UNCDF, UNEP, Stockholm Environment Institute and Statistics Denmark that original 17.5.1 should be dropped.

Proposed Indicator: Access to patent information (WIPO Patent Database) and use of the

international IP System

Status: Green

Comments: Several countries do not support this indicator. Cuba and 7 African IAEG members support Cabo Verde and Africa's proposed indicator: "Fixed Internet broadband subscriptions disaggregated by speed", as well as several other countries.

Recommendation: In our view the proposed indicator is not actually an indicator and there was no metadata provided. Therefore we propose to use original proposed indicator by TST 17 and supplement it with the indicator 'Fixed broadband subscriptions, broken down by broadband speed'.

Supplementary Indicator: 17.7.1 Total STEM Investment/GDP

Supplementary Indicator: 17.7.2 Total STEM per capita (\$ value)

Status: Yellow

Comment: Concerns that 'environmental goods' are not well defined - this will need to be addressed by WTO members asap.

Recommendation: Keep the proposed indicator and drop existing supplementary indicators 17.7.1 and 17.7.2. The UNEP proposal 'Total amount of approved funding for developing countries to promote the development, transfer, dissemination and diffusion of environmentally sound technologies on favourable terms, including on concessional and preferential terms, as mutually agreed' should be adopted as a new supplementary indicator 17.7.1.

It is not clear whether proposed supplementary indicator 17.7.1 is measurable at this stage, therefore additional supplementary indicator proposed by Stockholm Environment Institute i.e. 'Total north-south and south-south funding for technology transfer initiatives' should also be included.

Status: Green

Comment: There seems to have been some confusion with this target as several comments seemed to refer to 17.18 rather than 17.8.

Recommendation: Keep proposed indicator and supplementary indicators 17.8.1 'ICT penetration' is already an established indicator used by 'Partnership on Measuring ICT for Development' and 17.8.2 as they are clear, measurable and enjoy high level of support.

Status: Grey

Comments: Several comments note the lack of clarity of proposed indicator and therefore the subsequent measurement problems. We agree.

Recommendation: Simplify wording of proposed indicator to read 'The dollar value of financial and technical assistance (including through North-South, South-South, and triangular cooperation) committed to developing countries' design and implementation of policies aimed at sustainable development'. Keep supplementary indicator 17.9.1, drop indicator 17.9.2 and include new indicator 17.9.2 'R&D expenditure as % of GDP (by sector, source of funds, field of science and socioeconomic objective)'.

Recommendation: Drop proposal to use GDP as a measure of macro-economic stability and use original proposal made by TST 17 which proposed a macro-economic dashboard. Drop 17.13.1.

Status: Grey

Comments: Comments generally in support on proposed indicator but a lot of concerns expressed regarding the word 'constraints'. However TST 17 identified this as a weak indicator and therefore proposals submitted by Asia Pacific Forum on Women Law and Development and Women's Major Group, Destatis and Statistics Denmark should be considered.

Recommendation: Replace proposed indicator with a new indicator 'Number of disputes brought against countries through dispute settlement processes (by companies or countries) in areas such as trade, investment, technology' and drop supplementary indicators 17.15.1 and 17.15.2.

Comments: This target provoked quite a bit of comment, much of it negative, expressing dissatisfaction with the proposed indicator. Several comments/queries were raised regarding both the definition of PPP's and whether this was a sensible target. However relatively few alternate proposals were submitted, just comments. This was identified by the original TST 17 as a weak spot and although the original TST 17 indicators are not presented, the indicators that are, are no better.

Recommendation: Keep proposed indicator and supplementary indicator 17.17.1. Drop existing supplementary indicator 17.17.2 and replace with 'Number of PPP projects cancelled (source: World Bank (Private Participation in Infrastructure database). Add a third supplementary indicator 17.17.3 ' Public expenditure on public-private partnerships as a percentage of total public expenditure'.

Comments: This is a challenging target comprised of two distinct and separate topics: Consequently it attracted very varied and diverse comments. In general there appears to be broad support for a 'beyond GDP' type indicator, although no consensus on which one is best. We feel it is important to retain some indicator that captures the 'beyond GDP' element of this target.

Recommendation: Keep proposed indicators 1 (slightly reworded) and 2. Drop existing supplementary indicators 17.19.1 and 17.19.2 and introduce a single, new supplementary indicator 'Number of countries that report regularly (at least once every three years) on the full suite of SDG indicators'.
