2.5.2 Proportion of local breeds classified as being at risk, not at risk or at unknown level of risk of extinction	69 out of 193	Country coverage criteria not met for Africa (20%), LAC (33%), and Asia-Pacific (21%); population coverage criteria not met for Africa (22%), and Asia-Pacific (17%). Data is available for only 69 out of 193 countries.	no response from FAO yet
16.6.1 Primary government expenditures as a proportion of original approved budget, by sector (or by budget codes or similar)	94 out of 193	Country coverage not met for Europe (26%), LAC (36%), and Asia-Pacific (49%); population coverage also not met for Europe and North America (38%)	World Bank: they are fine with the downgrade for now; by the end of this year, they expect to increase coverage to 109 countries with goals of an additional 50-60 depending on response from the countries.
