# IAEG-SDG best practices on SDG monitoring

- As part of the decisions of the last Statistical Commission, the IAEG-SDGs was tasked with focusing on the implementation of the indicator framework and the sharing of experiences and best practices on SDG monitoring.
- In line with this mandate, the group developed a questionnaire to gather short descriptions from countries and UN regional commissions to showcase best practices in areas including:
  - national platforms, dashboards, SDG portals and other progress assessment tools;
  - communication of data for the Goals; and
  - data disaggregation and data gaps of the SDG indicators
  - \* Additional question added: capacity building priorities for SDG monitoring as input to the HLG-PCCB
- The aim of the questionnaire is to obtain **short summaries showcasing best practices**, **links to any information or materials** and also to provide an opportunity for countries to contribute any additional comments, raise any particular challenges or suggestions related to the topics.
