Background

Goal 17

- “Strengthen the means of implementation and revitalize the global partnership for sustainable development”

target 17.17

- “Encourage and promote effective public, public-private and civil society partnerships, building on the experience and resourcing strategies of partnerships”

SDG proposed
Indicator

- Amount of United States dollars committed to public-private and civil society partnerships

Endorsed
Indicator

- Amount of United States dollars committed to public-private partnerships in Infrastructure

Rationale

- Methodology in place since 1990
- Indicator already calculated for 139 countries since 1990 (1990-2021) and data publicly available
- Current tier I: UNSC 51st session agreed to endorse the indicator “Amount of United States dollars committed to public-private partnerships in Infrastructure” as part of the 2020 SDG Comprehensive Review.

Methodology

- Well-established methodology. Rigorous quality control. Advisory group provided inputs to the original formulation of the methodology.
- The database goes through an extensive internal review process and it is open for public review. It is evaluated every 2-3years with MDBs and academic experts. PPP units of governments (e.g., residing in Ministries of Finance or other line ministries) can also provide feedback.
- Process:
 - ❖ Team of researchers gather data for each of the regions using public sources (from government and MDBs websites); commercial news databases as well as from commercial specialized and industry publications/subscriptions
 - ❖ Data is uploaded to an administrative website through a template to make sure data is standardized
 - ❖ Data is validated by a group of experts
 - ❖ Data is later uploaded to the public website

Data availability

- Data Availability for 139 countries for 1990 to present

- It currently covers “Emerging Markets and Developing Economies” (EMDE countries) - basically Low and Middle income countries; OECD/DAC 1 countries are not included yet
- The data is regularly updated on a semi-annual basis.
- The Private Participation in Infrastructure (PPI) Database is publicly available at www.ppi.worldbank.org and at the World Development Indicators website <http://datatopics.worldbank.org/world-development-indicators/>

Caveats

- **Methodological Feature:** Indicator measures PPP only; PPI database does not collect data on civil society partnerships. The WBG neither has the expertise nor the resources to gather the data.
- **Resource Constraints:**
 - Indicator measures partnership in infrastructure only (Infrastructure covers Energy, ICT backbone, Transport, Water and Sewerage and Municipal Solid Waste Mgm sectors) and not in sectors such as education and health. *No methodological constraint to expand sectoral coverage*
 - Indicator measures partnership in EMDE only and not in OECD/DAC 1 countries. *No methodological constraint to expand sectoral coverage*
