With respect to Elsie's question, we agree that ensuring robust data quality is an enormous challenge, and we were supposed to comply with this by 2020. Unfortunately, due to the pandemic, the Statistics Institutes faced important limitations globally, as shown by the Secretary General in his last report. We need to strengthen support to Statistic Institute (as we are currently doing from the UN SDG Task Force), and need to explore alternative and innovative methods for timely measurement, including disaggregation.

In response to question posted by Heather on VPRs, VLRs and VNRs: Partnerships between municipalities, regions, government agencies, civil society and citizens is essential to attain the SDGs. 4 cities in Sweden, Helsingborg, Malmö, Stockholm and Uppsala, carried out Voluntary Local Reviews for the first time in 2021. These are reported on in the Swedish VNR.

Also, several scrutinising reports has been published by civil society organisations that have inspired and fed into policy development.

Sweden has positive experiences of broad-based inclusion in the Swedish HLPF delegation and in the VNR process. Ensuring the participation of representatives from the whole of society has led to greater consensus, commitment, and coherence in work on the 2030 Agenda. (to be continued)

Civil society organisations are also considered an important partner in the statistical follow-up. We have engaged with actors from civil society throughout the process of developing the statistical follow-up. We have held consultations, meetings and presentations and have valued their input greatly. We realised in the beginning of the process that the knowledge held by actors in civil society was absolutely crucial for an effective, independent and trustworthy statistical follow-up. We have not used a lot of data generated by civil society (although some in the review of the principle of leaving no one behind) but they have been instrumental in the development of the national indicator list from the start.
