Statement by Cyprus

at the 29th Session of the UN Group of Experts on Geographical Names

Agenda Item 12: Activities relating to the Working Group on Country Names W.P.74/12

Response by Mr Andreas Hadjiraftis, Head of Delegation of the Republic of Cyprus to the 29th Session of the United Nations Group of Experts on Geographical Names (UNGEGN), April 27, 2016, Bangkok, Thailand.

I would like to express my regret and my strong objection for the content, as well as the nature of the statement by the distinguished delegate of Turkey who has time and again chosen to politicize the deliberations of the UN Conferences and Sessions of UNGEGN for the Standardization of Geographical Names, by pursuing to undermine the status of the internationally recognized Republic of Cyprus, a member State of the United Nations and of the European Union and to upgrade the secessionist "trnc" which it has set up in the occupied part of Cyprus since 1983, which since then is not recognized by any State other than Turkey, has been condemned by United Nations Resolutions (SC 541/83 and SC 550/84) that call upon "all States not to facilitate or in any way assist this secessionist entity", and has been described also by European Court Decisions as "Turkey's subordinate local administration".

Any reservation on the part of Turkey regarding the international personality of the Republic of Cyprus has no legal effect, does not in any way affect its status, nor does it attribute any status to the legally invalid "trnc".

It is time for Turkey to understand that such attempts are completely futile and anachronistic and merely prove its unwillingness to abide by International Law, including the UN Resolutions on the standardization of geographical names, since it has arbitrarily and illegally changed over 35,000 geographical names in the occupied territory of Cyprus, in violation also of the cultural heritage of Cyprus.

The reference given by the distinguished delegate of Turkey regarding document WP49/4 is completely irrelevant to Agenda Item 12.

We therefore expect that the UNGEGN secretariat will fully ignore the contents of the statement made by the distinguished delegate of Turkey regarding the Republic of Cyprus as: "Cyprus Greek Administration", this being completely unacceptable. The official names of the Republic of Cyprus are fully respected these being: $Ku\pi\rho\iota\alpha\kappa\dot{\eta}$ Δημοκρατία in Greek, Republic of Cyprus in English, and Kibris Cumhuriyeti in Turkish.

We kindly request that the unacceptable assertions of the delegation of Turkey will be dismissed, as befits such unlawful acts, and that you will not permit that they intrude in any of the papers or web documents of our session.
