# Feature of the National Statistical System until 2007

- the absence of institutional setting
- the technical coordination absence, that results in the use of concepts, nomenclatures and disparate methodologies
- the weakness and the irregularity of the production
- statistical that is not centered on the whole of the needs of the users, but that functioned rather under the impulse of the financial backers been urgent by the circumstances

# Feature of the National Statistical System until 2007

- crumbled
- characterized by a weak and irregular statistical production
- use concepts, nomenclatures and disparate methodologies distorting the comparability of statistics produced thus.

# New development of the setting legal and authorized of the SSN

- Law n°1/17 of September 25, 2007 carrying organization of the SSN in Burundi
- to manage, in terms of governance, the National Statistical System (SSN).
- to define the missions of the services and organisms loaded of the production and the diffusion of the statistical data in Burundi.

# New development of the setting legal and authorized of the SSN

- defines the fundamental principles and the institutional setting that govern the activities of the services and organisms, loaded of the production and the diffusion of the public statistical data on the extent of the territory.
- it also treats the general working of the SSN and the coordination of the aforesaid system.

# The National Statistical Institute (ISTEEBU)

- the National statistical institute is the central organ of technical coordination of the activities of the SSN of Burundi
- to assure the coordination of the setting in work of the activities of the SSN
- to look after the diffusion of an information of quality by the set of the Services and Organisms being a matter for the system,

# Consultant National of the Statistical information (CNIS).

- According to the article 6 of the law n°1/17 of September 25, 2007 carrying organization of the statistical system in Burundi, he/it has been created the Council National of the Statistical information
- propose general orientations of the statistical politics of the nation that he/it submits to the Government of Republic of Burundi for adoption (art 5 of the law).



# Consultant National of the Statistical information (CNIS).

- to propose the orientations of general politics concerning development of the statistical to Burundi and
- to assure the national coordination of the activities led in this domain.

# Technical committee of the Statistical information (CTIS)

- to bring a technical support to the Consultant National of the Statistical information (CNIS)

# Weakness

- ignorance of the present texts governing the other structures by the services producers and users of the statistical data
- of the absence of hierarchical tie and coordination between the producers in a same sector, what can constitute a threat for the global system,
- the decree defining the statistical mission of the services sectorial and other components being a matter for the SSN
- Coordination of statistics of the private sector and the civil society
