<u>Session 2:</u> The Environment Statistics Self-Assessment Tool (FDES Tool 2)

The work programme for the implementation of the FDES (approved by the UN Statistical Commission in 2013) includes the development of a tool for use by/in countries to assess and diagnose the state of environment statistics as a first step in the application of the FDES. An Environment Statistics Self-Assessment Tool has been developed by UNSD based on the questionnaires used in the pilot exercise on the Core Set of Environment Statistics in September 2012. The two questionnaires assessed country priorities and data availability at the statistical topic and variable level. A third questionnaire is planned to cover the institutional aspects. The Expert Group is expected to discuss the ESSAT in general and the structure, fields, contents and layout of the questionnaires in particular.
