Background of the Global Assessment

- The United Nations Statistical Commission at its fifty-third session in 2022 endorsed the launching of a regular global assessment on the status of implementation of SBRs in countries and encouraged close coordination with the Wiesbaden Group on Business Registers and other relevant groups (decision 53/119 E/2022/24-E/CN.3/2022/41).
- The global assessment on statistical business registers was developed by the TT-SBR under the UNCEBTS in close collaboration with the Wiesbaden Group.

Overview of the Global Assessment

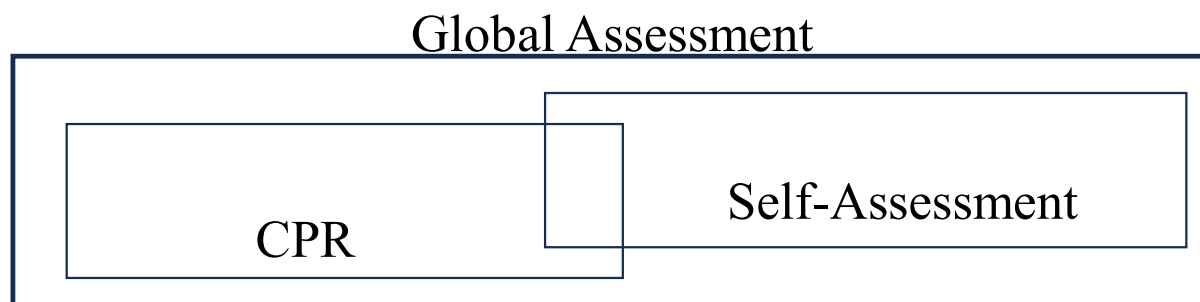
- **Objectives:**
 - To monitor the implementation of SBRs at global level
 - To identify priority areas to develop technical assistance programmes and further guidance and training materials
- **Who is the target:** National Statistics Offices, and international agencies who keep a regional/global registers
- **When is the assessment:** Starting from 11th April
- **How:** The global assessment is based on: 1) the Country Progress Report of the Wiesbaden Group, which has been in use for many years before, and 2) the self-assessment questionnaire of the Manual on the Maturity Model for SBRs.
- **What does the result mean:** Providing a complement to the CPR of the Wiesbaden Group on SBR

Overview of the Global Assessment Questionnaire

- Global Assessment Questions are made of the combination of CPR and Self-Assessment on Maturity Model questions.
- All questions in CPR and Self-Assessment are covered in Global Assessment questionnaire (Fig1).

* Two General Question (Reporter data and telephone number) in CPR is not included in Global Assessment, but it is not important.

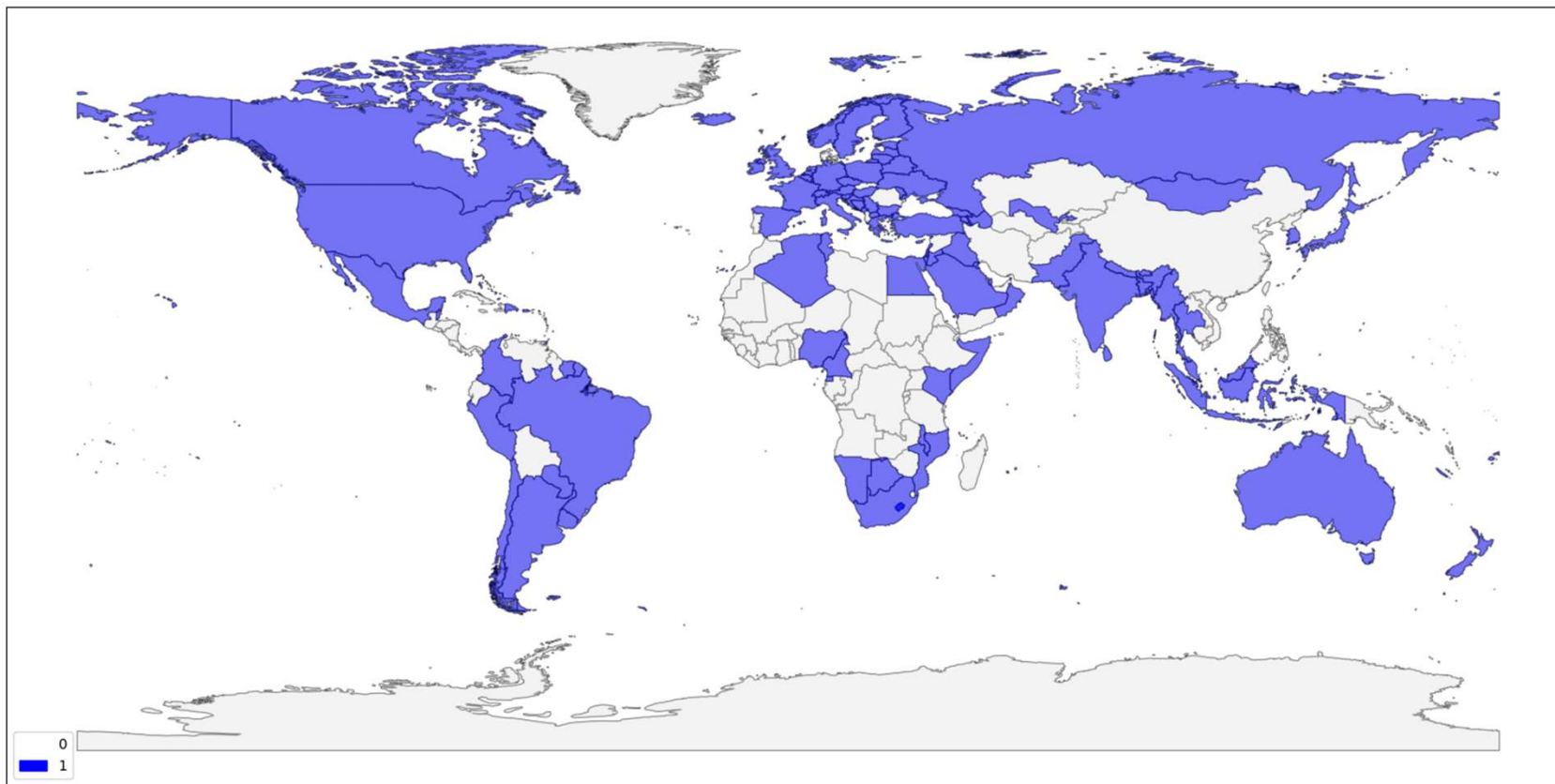
Update of Global Assessment

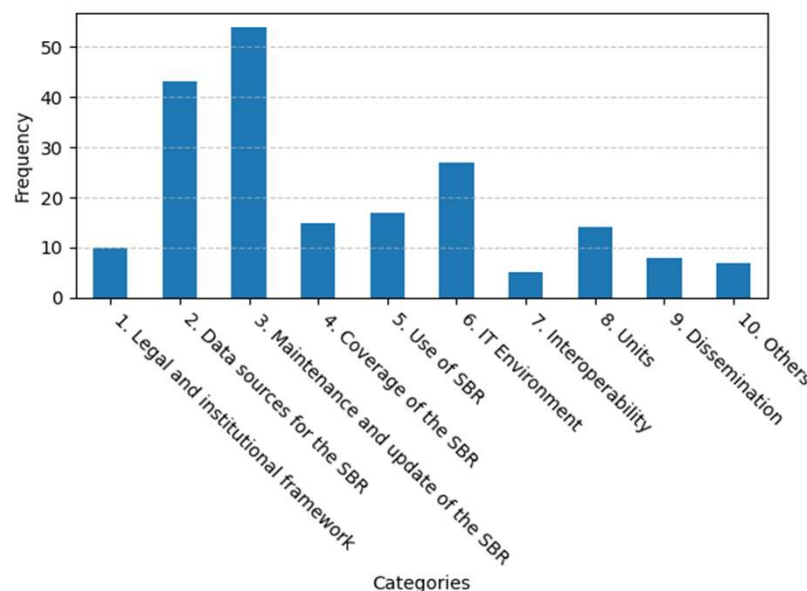


Fig3. Progress and Development in 2024

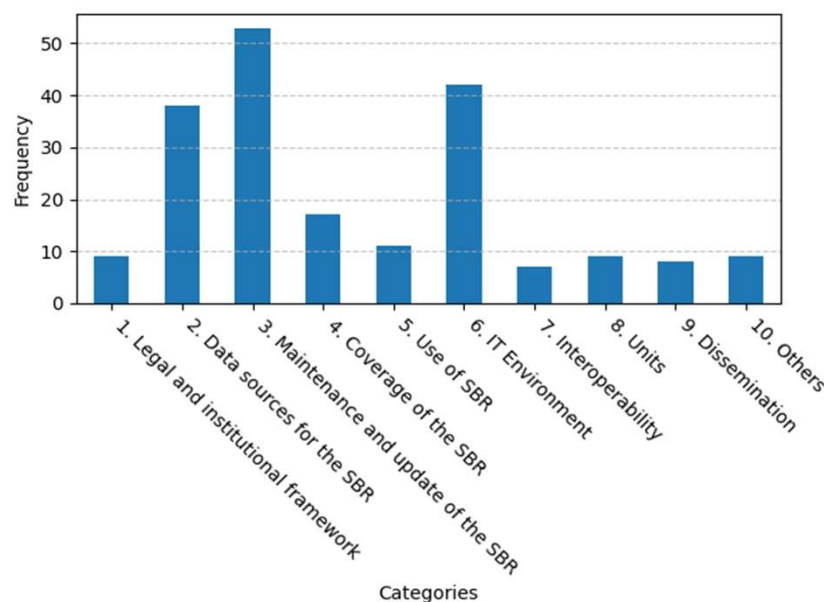


Fig4. Future Plans in 2025

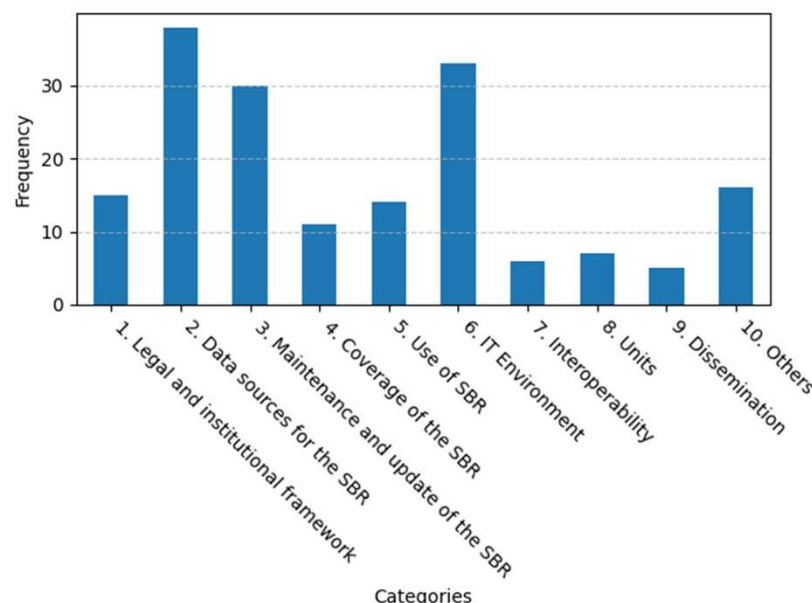


Fig5. Main Challenges
