HANDBOOK ON INTEGRATING BUSINESS AND TRADE STATISTICS

The Handbook on Integrating Business and Trade Statistics (HIBTS) was presented during the 56th session of the UN Statistical Commission (2025)

Currently, the HIBTS team is discussing the inclusion of informal cross-border trade and household trade under the Innovation section

1. Background: Objective

The main objectives of the HIBTS are:

- Provide the conceptual and methodological framework related to the integration of business and trade statistics
- Include technical guidance for building and strengthening capacities on the MDL process
- Share country experiences related to the linking business and trade
- Guide countries to produce linking business and trade (goods and services) statistics in an international comparable manner

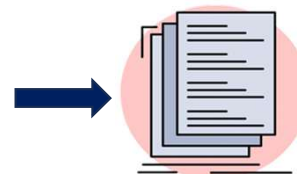

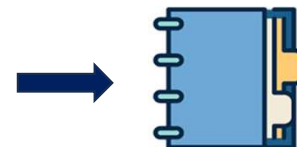

2. Collaboration to develop the HIBTS

- **Cooperation and collaboration** with various groups, countries, and organizations make possible the development of the HIBTS, taking advantage of synergies and seeking to respond to a greater number of needs:
 - Country members from the TT-ITS
 - Collaboration with IMF
 - Collaboration with the Inter-Agency and Expert Group on Gender Statistics
 - Cooperation with the other TT of the UNCEBTS (TT-SBR and TT-BDBDE)
 - Cooperation with the IMTS and MSITS Chief Editors in cross-cutting issues, for more consistency between the different manuals
- The creation of a repository of practices on integrating business and trade statistics, based on the experience of developing the Country Progress Report site for the Wiesbaden Group, taking into account the compilation (receiving a filled template) and dissemination of the country experiences



3. Lessons learned

3. Lessons learned (1 of 2)

- Early scoping and objective definition is critical: the initial discussion on the outline was very relevant and crucial for the subsequent development process
- Engaging stakeholders from the start enhances relevance: the inclusion of topics related with the HIBTS in several global consultations was decisive
- Diverse expertise is crucial, but it needs to be coordinated effectively
- Iterative drafting and feedback loops were essential in the development of the HIBTS

3. Lessons learned (2 of 2)

- Documentation of decisions ensures transparency and continuity: maintain a decision log and version-controlled drafts to track rationale and revisions was relevant in the overall process
- Balancing technical depth with accessibility takes time: striking the right tone and detail level for multiple audiences (e.g., technical experts vs. policy users) is challenging, and the global consultations were useful for the improvement of HIBTS
- Coordination with external partners can be complex, but it was relevant, to ensure the usefulness of HIBTS

4. The way forward: Implementation strategy



- As part of promoting the integration of business and trade statistics, it has been envisaged an implementation strategy along the HIBTS
- This includes the preparation of training materials, organization of regional workshops and development of a public online repository on national practices
- To achieve this goal, collaboration with other international working groups and intergovernmental bodies is essential

4. The way forward: Global online repository

- During the UNCEBTS meeting held 24–26 September 2024, the Task Teams agreed to collaborate on launching a Global Online Repository of Practices for Business and Trade Statistics
- This repository will cover several areas within business and trade statistics. It is intended to include relevant documentation for each area, as well as country-specific experiences
- The primary objective is to create a platform for knowledge sharing and to support countries in implementing the recommendations and practices advocated by the UNCEBTS Task Teams
- The Global Online Repository of Practices for Business and Trade Statistics is considered a key component of the HIBTS implementation strategy

4. The way forward: Capacity building

- UNSD also envisions the development of online materials to support the implementation of the HIBTS in countries
- Additionally, regional workshops will be organized as part of the implementation strategy
- In this regard, a regional workshop is planned in collaboration with the Economic Commission for Latin America and the Caribbean (ECLAC) in September 2025

Also, if you consider that it is necessary to complement the information, you can share any document and/or hyperlinks to get more information, as well as graphs and/ or figures. Particularly, it is required:

- Identify the **topic(s)** that better reflects the content of your practice.
- 5-6 **Keywords** that provide readers with terms to facilitate the search of practices of interest.
- An **Introduction** providing a summary of national practices and addressing the institutions/stakeholders involved. In cases of institutional cooperation, please mention if there is a law, a Memorandum of Understanding, or any cooperation agreement. Moreover, please indicate if the practice/indicator addresses any requests from policymakers.
- A **Content** section a short description of the statistical products developed emphasizing its scope, periodicity, breakdown, dissemination practices and timeliness, among other core topics such as confidentiality. Additionally, it should include a short description of the process for linking business and trade data mentioning, data sources employed, techniques used, classifications and other technical considerations (e.g., software and other IT requirements, stand-alone application). Also, mention the data sources used (Census, Survey, Administrative, Other sources), techniques used, classifications, and other technical considerations.
- Some **Closing remarks** with a brief description of the results, the main challenges faced, difficulties in achieving the objectives, improvements made, as well as future plans.
- Finally, please provide any **Hyperlinks to additional documents** to get additional information.
