Activities done in the first half of 2021

- Design of the template for the technical sheets for the UNCEBTS core indicators
- Drafting of the technical sheets of the TT on BDDE
- Support in the preparation and revision of the material for the pilot survey
- Translation into Spanish of the material for the pilot survey
- Five meetings of the TT on BDDE during 2021 (as of June 2021)

Pending activities for 2021

- Strengthening the Global Consultation based on the analysis of results of the Pilot Survey
- Coordination with the Wiesbaden Group
 - The 27th meeting will be organized by INEGI on September 20-24, 2021
 - Within its activities, some specialists agreed to support in the revision of the SBR maturity model
 - These coordination activities aim to avoid duplicities (and reduce the overburden to the NSOs) among the Global Consultation that will be launched by UNSD and the Country Progress Report undertaken by the Wiesbaden Group
- Concluding the cooperation between UNSD, ECLAC, and Latin America and Caribbean Countries for supporting the UNCEBTS activities
- Starting the discussion on the topics and activities for 2022-2023

Coordination and next activities (2022 -2023)

- Participation in the activities of the TT on Communication, Trade Task Team and other Groups
 - **Expected: Coordination with other TTs and international bodies in the field of business dynamics, demography and entrepreneurship, as well as revision of activities to avoid overlapping**
- Contribution to the Manual on the Global core set of principal Business and Trade Indicators
 - **Expected: Written contributions from the TT members**
- Collaboration for drafting the Manual on the Maturity Model for Statistical Business Registers
 - **Expected: Discussion with the TTs on Exhaustive Business Registers and Capacity Building for providing written contributions**

Coordination and next activities (2022 -2023)

- Analysis of results of the Global Consultation on the BDDE indicators for elaborating a specific diagnosis to identify opportunity areas in the countries and strengthening capacities
 - **Expected: Report on the main results and findings to support fostering, building or strengthening capacities on business dynamics, demography and entrepreneurship statistics**
- Encourage the use of unique identifiers for businesses
 - **Expected: Collaboration in the activities to foster the use of unique identifiers in legal units, likewise, participating in the discussion on the initiative of Global Group Register**

Coordination and next activities (2022 -2023)

- Analysis of the current BDDE core indicators for identifying additional breakdowns and complementing with other new indicators
 - **Expected: List of additional/modified core indicators and their technical sheets. Initial topics for discussion: gender and subnational disaggregation**
- Data, indicators and procedures related to the recovery after COVID-19: Lessons learned and way forward.
 - **Expected: Discussion on the statistical practices of countries for contributing to the recovery after COVID-19, emphasizing the usefulness of the SBR and the statistics in the field of business dynamics, demography and entrepreneurship. A brief compilation of different practices could be elaborated**

Coordination and next activities (2022 -2023)

- Identification of the main characteristics of entrepreneurship for providing more robust information to users especially in the field of policy making
 - **Expected: Profiling questionnaire to collect further information on the characteristics of entrepreneurial enterprises with the aim to define other core indicators on entrepreneurship**

Analysis of the scope of Entrepreneurship

- Review of the current thresholds for indicators such as Gazelles and High-Growth Enterprises
- Analyze administrative data and other data sources (as surveys) that can be linked at microdata level to produce new statistics, indicators and breakdowns
- Explore the need of additional indicators on entrepreneurship required by policymakers
- Elaborate a detailed profiling of enterprises by considering determinants relevant for the entrepreneurship. For instance, innovation (in products and/or processes), access to finance, digitalization, sustainability, GVCs, etc.
- The TT on BDDE kindly invite to UNCEBTS experts for contributing with proposals to elaborate the questionnaire for this profiling
