Brief description of the organisation <sup>1</sup>	<ul> <li>The World Trade Organization's (WTO) primary purpose is to open trade for the benefit of all. The WTO provides a forum for negotiating agreements aimed at reducing obstacles to international trade and ensuring a level playing field for all, thus contributing to economic growth and development. The WTO also provides a legal and institutional framework for the implementation and monitoring of these agreements, as well as for settling disputes arising from their interpretation and application. It was established in 1995 and is situated in Geneva (Switzerland).</li> <li>WTO's Statistics Group of the Economic Research and Statistics Division</li> </ul>
Mission <sup>2</sup>	<ul> <li>provides the organization's principal statistical services.</li> <li>The WTO Statistics Group provides assistance to member governments and the Secretariat in all statistical activities that are carried out by the Organisation, comprising: the provision of quantitative information related to economic and trade policy issues; the development and maintenance of databases; international cooperation in the field of trade statistics; the production of annual time series released online and as publications, e.g. the "WTO International Trade Statistics", Trade and Tariff Profiles, etc.; the maintenance, development and provision of technical assistance.</li> </ul>
Fields of Activity/ structure Statistics	<ul> <li>The WTO Statistics Group provides statistical services for Members and the Secretariat, and actively contributes to the development of a consistent, internationally-recognized set of up-to-date international trade statistics and tariff information.</li> <li>The WTO supports actively ongoing efforts to improve coordination in data collection and dissemination through the inter-agency Task Force on International Merchandise Trade Statistics (TF IMTS) and other bodies.</li> <li>Coordinates the inter-agency MDG-Trade group of Geneva (ITC/UNCTAD/WTO) that monitors market access conditions for developing and least-developed countries and produces corresponding MDG indicators. The work focuses on improving the measurement and interpretation of related MDG indicators (http://www.mdg-trade.org). Collects primary tariffs and tariff related imports from national compilers; and actively cooperates with UNCTAD and the International Trade Centre (ITC) to enhance the exchange of tariff information through a Common Analytical Market Access database</li> </ul>
