An updated template for assessing the implementation of national classifications

Background

The work of the Expert Group on International Economic and Social Classifications is focused on the development and coordination of international standard classifications. While these classifications serve as a common tool for harmonizing statistical data across countries, it is recognized that countries have additional, often specific, needs that require different classifications to satisfy user requirements.

In order to maintain a high degree of data comparability, countries are encouraged to develop or revise their national classifications to maintain or improve the links to the international standard classifications.

It is therefore of great interest to know to what degree countries are aligning their national classifications with the international standard and to get a general overview of current classification practices around the world.

The registry of national classifications, maintained by UNSD since 2001, has provided some basic information to that extent, allowing users to obtain information about national classifications used around the world in a compact form through a single access point.¹

The original version of the registry has primarily been used to solicit information about national versions of activity and product classifications (i.e. those linked to ISIC, CPC or HS). In subsequent rounds of data collection, information has also been requested about classifications of expenditure according to purpose and classifications of occupation. However, responses to the latter two categories have been limited.

In total, the registry now includes information on 422 classifications from 118 countries.

While not specifically designed to measure "compliance" with the international standard classifications, the information in the registry provides a good estimate of the implementation of the international standard in national variations.

The present document proposes an updated template for the questionnaire associated with the registry of national classifications, i.e. the set of information to be collected about national classifications.

Information to be collected

The information collected through the questionnaire and presented to users is intended to provide a concise description of each national classification used, enabling users to

understand the purpose and application of each classification, obtain basic administrative and technical information, understand its relationship to the international standard and find references for more detailed information.

To maintain comparability with the previous version of the questionnaire / registry, most questions included in the new template are similar to those in the previously used version.

For ease of use, the template has been subdivided into broader sections. As such, the template covers the following groups of information:

- 1. General information
- 2. Classification structure
- 3. Relationship to international standards
- 4. Classification uses
- 5. Implementation / revision status
- 6. Supporting documents
- 7. Capacity building
- 8. Contact information
- 9. Other comments

Some of the questions are designed for internal use by the custodian, e.g. those on capacity building and problems encountered, and the respective responses will not be made available to the public.

Since the relationship of the national classification to the reference classification is usually of high interest, the Expert Group may wish to discuss if a more targeted set of questions would be desirable. Currently, it is left to the respondent to decide how detailed the response to this question should be (see questions 3(b) and 3 (c)). While guidance on more detail may be desirable, it should also be kept in mind that the questionnaire is used to provide summary information, not detailed accounts, such as those in a detailed correspondence table.

For the latter, there is no intention to define a scale of compliance criteria, i.e. no explicit "ranking" of the compliance with the international reference classification is planned. This is in compliance with discussions at previous meetings of the Expert Group.

The complete questionnaire is shown in Annex 1 of this document.

Classifications to be covered

The original version of the registry has primarily been used to solicit information about national versions of activity and product classifications (i.e. those linked to ISIC, CPC or HS). In subsequent rounds of data collection, information has also been requested about

classifications of expenditure according to purpose and classifications of occupation. However, responses to the latter two categories have been limited.

While UNSD will continue to collect information related to classifications for which it is custodian (i.e. ISIC, CPC, classifications of expenditure according to purpose, SITC, BEC), the questionnaire template should be suitable to address classifications of other custodians as well. These other custodians could either collect similar data themselves or coordinate the data collection with others, such as UNSD.

The questionnaire template therefore has not been designed to specifically target one classification or a limited group of classifications, but solicits general information that should be available about any classification and that should also be sufficient to provide users with enough information about content, structure and uses of the classification.

Distribution and use of the questionnaire

Since this template is intended for collecting information about national classifications, the number of recipients is relatively large, covering at least all national statistical offices, but also other agencies that develop or maintain relevant classifications, such as central banks, ministries and so on.

While it may not be possible to start with a complete list of entities developing or maintaining national classifications, the list of national statistical offices would serve as a starting point. When the questionnaire is sent to an NSO, information could be solicited on other national entities that may be able provide information on other relevant national classifications.

In the past, the questionnaire also been distributed mainly in connection with classifications workshops organized by UNSD. Since there are currently no workshops planned that would provide sufficient coverage, other mechanisms should be explored.

Since more direct contact with recipients seems essential for a high response rate, a more targeted distribution of the questionnaire may be helpful. This could for instance be done through existing coordination mechanisms that exist in some regions (e.g. Eurostat's work on classifications for EU member countries) or through technical assistance activities that may exist in some regions (e.g. ECLAC's proposed Technical Expert Group on classifications).

The Expert Group may wish to explore if other options exist or if a central data collection carried out by UNSD (for the classifications listed above) would be more appropriate.

Questions

- 1. Does the Expert Group agree to the overall layout and content of the questionnaire template?
 - a. Is the current set of questions suitable to address different types of classifications?
- 2. Should any additional information be included?
 - a. Are more detailed questions necessary to describe differences from the international reference classification?
- 3. Can the Expert Group suggest suitable forms of distribution and follow up for this type of questionnaire?
 - a. Can other institutions be involved?
 - b. Should there be a fixed schedule for collecting this type of information?
