### The draft EBOPS – CPC correspondence table

# Note by UNSD

- 1. The revised Manual on Statistics of International Trade in Services (MSITS 2010) was adopted by the UN Statistical Commission at its 41<sup>st</sup> session in 2010. MSITS 2010 provides among others a more detailed classification of services delivered through conventional trade between residents and non-residents than is contained in the IMF Balance of Payments Manual. This classification is called the Extended Balance of Payments Services Classification (EBOPS). The EBOPS was revised in line with the revised statistical frameworks of BOP and SNA. The new version (EBOPS 2010) is shown in Annex 1.
- 2. As was the case for the 2002 version of MSITS, the new Manual also includes correspondence tables. These tables are not in the printed publication, but will be made available on the website as online documents. For trade in services, the most important correspondence table is the one between EBOPS 2010 and the most recent version of the Central Product Classification (CPC 2.0). Such correspondence table makes it very explicit which detailed service products of the CPC are allocated to which category of EBOPS 2010.
- 3. The current draft of the EBOPS-CPC correspondence table was recently finalized between WTO, IMF and UNSD. It is herewith presented in an attachment to the Expert Group of International Classifications. The members of the Expert Group are invited to comment on this draft correspondence table.

### Construction of the EBOPS – CPC correspondence table

4. MSITS 2010 (see http://unstats.un.org/unsd/tradeserv/TFSITS/msits2010.htm) gives a lot of detail of what the contents is of each of the service categories in EBOPS 2010 in chapter 3, Section O, which should further be read in connection with chapter 10 on Goods and Services of the Balance of Payment Manual, 6<sup>th</sup> edition (see

- http://www.imf.org/external/pubs/ft/bop/2007/bopman6.htm) to fully understand the content of the EBOPS 2010 categories.
- 5. CPC 2.0 has fairly detailed explanatory notes which describe the services contained in each of the CPC product codes (see http://unstats.un.org/unsd/cr/registry/cpc-2.asp).
- 6. Starting from the correspondence table between EBOPS 2002 and CPC 1.0, the new correspondence was established and was subsequently tested and corrected against the text of Chapter 10 of BPM6 and Chapter 3 of MSITS 2010. Since both the EBOPS and the CPC had changed, a number of decisions needed to be taken. A list of 35 of those decisions is shown in Annex 2.
- 7. As much as possible CPC product codes were assigned to one EBOPS category to enable the data compiler to make easy decisions in working from a CPC-based data collection to an EBOPS-based presentation of data. In a few cases such clear distinctions could not be made and one CPC product code had to be assigned to two EBOPS categories. The CPC codes concerned are indicated with an asterisk. A table of these split codes is provided in Annex 3.
